#### Ill **OLD & NEW BUSINESS**

A. DPW letter (re: Certificates of Compliance)

The letter was reviewed, requesting that post-bathymetric studies be required in future requests from the DPW for certificates of compliance.

The Commission will contribute comments toward drafting a new letter, to be presented at a future hearing.

#### lV **ENFORCEMENT ORDERS**

A. Roger P. Plourde Jr. –188 East Bay Road, Osterville Directive to remove pier constructed in wrong location SE3-3905

Darcy advised the Commission that the dock has been removed as requested in the enforcement order.

A motion was made to approve the enforcement order as written.

Seconded and voted unanimously.

B. Peter P. Favat - 373 Bay Lane, Centerville SE3-3497

Alteration in a resource area, flood zone, by rebuilding and extending a deck, placing old decking under said deck, construction of a new ground level deck and removal of shrubs, adding a light post, phragmites removal, unauthorized activity beyond the scope of an approved plan of record by adding 3 additional canoe/kayak racks on permitted boardwalk. Previous enforcement history, 3 enforcement orders, 7 non-criminal citations, 1 warning letter, and 7 filings with the Commission between 1997 and 2000.

Ms. Karle noted Mr. Kenny's request to continue the matter. She stated that non-criminal citations issued would stand as issued, and not be continued.

A motion was made to continue the enforcement order to November 18<sup>th</sup>.

Seconded and voted unanimously.

MN102108 2 C. John Wilson – 151 Irving Avenue, Hyannisport

**DA-07067** 

Unauthorized activity beyond the scope of a Determination of Applicability by removal of vegetation including existing beach grass and cedar trees. Failure to submit replanting plan as directed in Determination.

Attorney Pat Butler and Steve Wilson, P.E., represented John Wilson.

A motion was made to amend the enforcement order to state that a planting plan shall be submitted on or before the November 18<sup>th</sup> hearing for staff review, showing replanting of cedars which were removed, as well as shrub plantings and beach grass.

Direct abutters shall be notified of the date of the continuance.

Seconded and voted unanimously.

Ms. Karle went on to say that the non-criminal citation should be paid.

Mr. Butler indicated that his client had requested a hearing at First District Court for the sole purpose of exercising his rights. His client had wished to wait and see the results of the planting plan review.

D. Carol Onisko – 250 Hollidge Hill Lane

**DA-07004** 

Violation of a Determination of Applicability and warning issued to the landscaper, Treescape, failure to replant. Also black plastic in buffer zone.

No one attended the hearing.

Ms. Karle informed the Commission that Ms. Onisko, who resides in Florida, has said that she will remove the plastic but does not wish to replant the understory, as was recommended to her by both herself and Fred Stepanis.

A motion was made to approve the enforcement order and staff recommendations to plant 36 shrubs in the northwest end, and 15–20 shrubs in the northeast end; 3-gallon pot size within the 20-foot buffer zone. All black plastic is to be removed. Plants must be chosen in consultation with Conservation staff.

Seconded and voted unanimously.

E. Denise G. Swan – 32 Windswept Way, Osterville

SE3-3857

Violation of a Certificate of Compliance "on-going conditions" by cutting several trees on a coastal bank and 50' buffer zone.

A motion was made to continue the matter to November 18<sup>th</sup>.

Seconded and voted unanimously.

A motion was made to approve the certificate, contingent upon the submission of a revised plan (which deletes the davit). A warning letter will be sent to remove the davit or file a Notice of Intent.

Seconded and voted unanimously.

C. Dubuque SE3-4513 (ap) add patio to beach shed; install flag pole & path add pool spa and extend patio

A motion was made to deny the as-built plan, but to approve the pool spa and extension, pool patio, and flag pole.

Seconded and voted unanimously.

D. Dubuque SE3-4513 (coc) construct additions, carriage house, pool, patio, & cabana; landscaping \*

A motion was made to approve the certificate, contingent upon the submission of a revised plan showing the following:
a) removal of sprinkler heads in 50-foot buffer; b) removal of cobble stones in front of shed; and, c) removal of flag stones leading to flag.

Seconded and voted unanimously.

E. Cabral (Moustakas) SE3-4102 (coc, ok)construct single-family dwelling (not done)

A motion was made to approve the certificate, contingent upon the submission of a new Notice of Intent application. The new application is to include a narrative that addresses the excessive clearing conducted under this (SE3-4102) filing.
