I REQUEST FOR DETERMINATION

George & Debra Alliegro. Relocate lower portion of stairs down the coastal bank approx. 24 feet to the west; connect to existing upper portion of stairs with a proposed 4' walkway and 4' x 4' storage area at 205 Sea View Ave., Osterville as shown on Assessor's Map 138 Parcel 016. **DA-17008**
