New programs are in development: The Increase in fees will begin in January 2014.The dept. is grateful for a gift of \$5000.00 from the FBCOA. In the future more space will be needed as the elderly population increases.COA INPUT: There was a lively discussion from members of the COA and a consensus that the ASDC served as a vital function and was an important program for the Town. In addition the COA believes that further study is needed to determine the best way to bring this program into a self sustaining position. Do a business plan, find weaknesses and work on same.
