Jim Kupfer refers to Staff Report. The way is public and provides access, has frontage, but is reducing lot area of preexisting non conforming lot. ANR doesn't review zoning compliance. If endorsed offer a finding that states reducing the furthering non conformance.

Peter Ryll – by Deed reference is two parcels. Reference to the plan, Exhibit A this will get rid of the non conforming by adding area to the lot. The other lot is 100% unbuildable. To go to Zoning Board of Appeals (ZBA) would be a waste of time.

- It does not constitute a subdivision because each of the lots have the minimum required frontage on an existing way having suitable grades, and adequate construction to provide for the needs of vehicular traffic in relation to the proposed use and for the installation of municipal services to serve such use; and
- All materials and conditions of Chapter 801, Article IV Approval Not Required Plans, have been submitted and are in full compliance.
- While an ANR does not determine compliance with the Zoning Ordinance the Planning Board notes that by dividing Parcel A from Lot I (Map 324 Parcel 021) and convey Parcel A and combine Parcel A with Lot II (Map 324 Parcel 022), Lot I will result in lot area that is further nonconforming, seconded by Matt Teague,
