2015-006 ORDER TO PETITION THE GENERAL COURT OF THE COMMONWEALTH TO ENACT SPECIAL LEGISLATION APPROVING THE CHANGE IN CARE, CUSTODY, MANAGEMENT CONTROL AND PURPOSE OF TWO PARCELS OF LAND, NAMELY A ±16.3 ACRE PORTION OF TRACT I OF THE WEST BARNSTABLE CONSERVATION AREA SHOWN ON ASSESSORS MAP 86 AS PARCEL 1 AND A ±17 ACRE PARCEL SHOWN ON ASSESSORS MAP 314 AS PARCEL 027001

ORDERED: That the Town Manager submits a petition to the General Court of the Commonwealth for a special act approving the change in care, custody, management, control and purpose of two parcels of land in the Town as follows.

"AN ACT AUTHORIZING THE TOWN OF BARNSTABLE TO TRANSFER TWO PARCELS OF LAND.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same as follows:

SECTION 1: The conservation commission of the town of Barnstable shall transfer the care, custody, management and control to the Town Manager for general municipal purposes of a certain 16.3 acre portion, more or less, of a larger parcel of land identified on assessors' map 5 as parcel 4, which was acquired by the town and held by the conservation commission for conservation purposes pursuant to section eight "C" of chapter forty of the General Laws and has been declared by the conservation commission to no longer be appropriate to be held by the conservation commission for such purposes. Upon the transfer as provided in Section 3 the Town of Barnstable shall be authorized to use the 16.3 acres, more or less, for general municipal purposes. The 16.3 acres more or less declared surplus in order to be transferred as provided in this section 1 are also shown on a plan entitled "Plan of Land in Barnstable (West Barnstable) MA Prepared for the town of Barnstable Prepared By: the Town of Barnstable -D. P. W. Survey Division Date: July 28, 2014 Scale: 1" = 80" on file in the office of the town clerk.

SECTION 2: To ensure a no net loss of lands protected for conservation purposes under section 1, the Town Manager of the town of Barnstable shall transfer the care, custody, management and control to the conservation commission for conservation purposes pursuant to section eight "C" of chapter forty of the General Laws of a certain 17 acre, more or less, parcel of land identified on assessors' map 314 as parcel 027001, which was acquired by the town and held for general municipal purposes and has been declared by the Town Manager to no longer be appropriate to be held by the Town Manager for such purposes. The parcel contains wetland, upland and other significant natural features as well as potential for passive recreational use and is bounded on the Southeast by public water supply land. Upon the transfer as provided in Section 3 the parcel described herein shall be preserved as conservation land in accordance with said section eight "C". The 17 acres more or less declared surplus in order to be

transferred as provided in this section 2 are further described as Lot 1 on plan of land recorded in the Barnstable County Registry of Deeds in Plan Book 417, Page 18 and was acquired by the Town by deed dated May 15, 1986 and recorded in said Registry in Book 5077 Page 300.

SECTION 3: The Town Manager may execute and record any instruments necessary on behalf of the Town to effectuate the transfers under sections 1 and 2 following passage of this act.

SECTION 4: This act shall take effect upon its passage.

BACKGROUND: On December 11, 2012 the West Barnstable Shooting Range was closed following notification from the Town's insurance carrier that the Town no longer had coverage under its existing policy. The Town commenced a multifaceted process involving the Massachusetts Department of Conservation Services (DCS), Barnstable Conservation Commission, Town staff and Town Council examining all aspects of reopening the shooting range. One issue that arose following a letter from DCS to Barnstable Conservation Commission on September 23, 2013 involved removing the range from 8C jurisdiction. Subsequent meetings between DCS, Barnstable Conservation Committee, Town staff and Town staff and Town Councilors resulted in the Town proceeding with said removal.

ANALYSIS: It was recommended that the Town proceed with the process of removing the shooting range parcel (±16.3 acres) from 8C jurisdiction. The Conservation Commission voted to remove the shooting range from 8C on June 24, 2014. The Town Manager offers the 17 acre municipal parcel for placement under 8C in exchange (provided the use of the Breeds Hill parcel for the "swap" does require DCS review and approval). A two-thirds vote of the Town Council and both branches of the State Legislature are needed to remove the range parcel from 8C purposes. The Town Council would also need a 2/3 vote to change the purpose of the 17 acre parcel Breed's Hill parcel from general municipal purposes to §8C purposes.

FISCAL IMPACT: The fiscal impacts of this action are minimal and limited to associated administrative costs.

TOWN MANAGER RECOMMENDATION: The Town Manager recommends that the Town Council approve the action proposed by this order.

SUBJECT: Appropriation and Transfer Order of \$4 million for the Capital Trust Fund

BACKGROUND: The Town of Barnstable's capital needs are many. The FY 2016 capital improvement plan included a capital needs list in excess \$72 million in General Fund requests over the next five years. The Town committed to funding \$15 million of this amount in FY 2016. Additional funding sources need to be identified going forward to continue to address the projects on this list. Excess General Fund reserves have been dedicated to the Capital Trust Fund previously and this request seeks to do the same. The Capital Trust Fund is used as a financial tool to accumulate resources that are used for financing the Town's capital needs. Transferring these funds will allow the town to fund a more aggressive capital program over the next 5 years.

ANALYSIS: Positive operating results for the fiscal year ending June 30, 2015 resulted in the growth of the Town's Free Cash as certified by the MA Department of Revenue. The growth in Free Cash was the result of unexpended appropriations and actual revenues exceeding budget estimates. The main components of the unexpended appropriations were from vacancy savings in personnel budgets across all departments. The main components in the excess revenue generated were from the release of excess overlay reserves for abatements and exemptions on property taxes, motor vehicle excise taxes and building permits. The Town's Free Cash was certified at \$13,949,203 on of July 1, 2015. This request is to transfer \$4 million of the amount into the Capital Trust Fund. By adding this amount to the Trust Fund it is projected that the fund could finance a total of approximately \$40 million over the next 5 years. This includes a combination of bond financed and cash financed projects.

FISCAL IMPACT: In accordance with Town Council policy, an amount equal to 4% of the General Fund's operating budget, net of transfers, must be set aside for extraordinary and/or unforeseen expenditures from its certified Free Cash balance. The remaining balance is available for appropriation subject to Town Council approval. The allocation of the savings account balances as of July 1, 2015 in concurrence with town policies and the revenue sharing agreement between municipal and school operations is as follows:

Town Council Reserve	\$5,689,766
Municipal Savings	\$3,702,279
School Savings	\$4,557,158
Total	\$13,949,203

The proposed transfer of \$4 million will be drawn from the municipal and school savings accounts (\$2 million from each). This will leave a balance in each savings account that represents approximately 4% to 5% of their respective operating budgets. Combined with the Town Council reserve of almost \$5.7 million, the total remaining balance in the general fund free cash account (\$9.9 million) represents about 6.8% of the overall general fund operating budget (more than 1.5 times the amount of the Town Council's reserve policy).

BACKGROUND: The Town of Barnstable entered into a Community Compact Agreement on November 19, 2015 with the Commonwealth of Massachusetts in the areas of Transparency and Housing. The transparency initiative provides that there is a documented open data strategy including timelines for making municipal spending and budget information accessible from the Town website in a machine readable and graphical format. Support from the Commonwealth for this initiative includes \$5,000 in grant funding to offset the cost of developing the Town's new website. Community Compacts are designed to create clear, mutual standards, expectations, and accountability for both the state and municipalities so as to create better government for our citizens.

ANALYSIS: After reviewing several software packages the Town has partnered with a vendor named Socrata who will provide the software used for supporting the new website. Operating budget data will be exported from the Town's financial management system on a weekly basis. This process will be fully automated. Capital program data will be updated less frequently; either monthly or quarterly, depending upon the level of activity. This involves steps that cannot be automated so it will be less frequent.

FISCAL IMPACT: The grant will be used to offset the cost of creating the Open Budget website. The cost of maintaining the website going forward will be included in the annual operating budget. The current monthly cost is \$750.

BACKGROUND: The Community Preservation Committee voted on December 21, 2015 to support a funding request from the Town Clerk in the amount of \$33,126.00 for preservation and restoration of the oldest Town vital record books and to recommend through the Town Manager that the Town Council approve an appropriation from the Community Preservation Committee historic preservation funds. A professional survey of Town records indicates that twenty-two of the oldest books beginning with the years 1643 to 1966, including a handwritten copy of the Declaration of Independence within, are the records most in need of preservation. Page edges are disintegrating simply due to exposure to air and therefore content is being lost. Handling of the books in response to public record requests must be performed by staff wearing white gloves due to their condition. Methods of preservation include: scanning to compact disc, de-acidification, mending and reinforcing of paper, re-sewing, rebinding or archival grade polyester encapsulation as needed. The scanning of records to compact disc will allow the preserved original record books to be stored in a climate controlled, fireproof vault in the Town Clerk's office, while allowing Town staff and the public, access to these historic records in an efficient, searchable format through laser fiche.

FISCAL IMPACT: There is no impact to the general fund. All funds are drawn from the Community Preservation Committee, historic preservation funds.
