Contracts for the marina slips (not including Barnstable Harbor) will be going out April 1st. Barnstable Harbor contracts will be going out shortly after that. Paperwork and first payment will be due by May 1 with the second or final payment due by the first week of June.

Boat show – Cape Cod Life Boat Expo will be held Father's Day weekend June 13-15th. A letter has been sent out to the Gateway slip holders requesting use of their slips. The response from the slip holders has been positive so far.

Waitlists are final- closing date was March 17 calls are being made to fill available slips.

Joe Gibbs reported that approximately 1800 mooring permit renewals are back with 600 still outstanding. The are due in the office by March 31st. From April 1 to May 14, the permits can be renewed with an additional \$25. late fee.

Out of the 1400+ people on the Mooring waitlists, 121 did not renew, leaving the count at 1307.
