## VIII. HARBORMASTER REPORT:

Joe Gibbs reported that the budget hearings resulted in reductions in some programs with the department as well as some upgrades.

Waterway Safety received an increase of \$5k for gasoline for the boats and \$2k increase for navigation aids. Although the mooring program lost \$200 overall in expenses, an increase of \$1k for postage and \$3k for overtime were approved.

Capital Improvement Program: funding was approved for repairs to Cotuit town dock and maintenance dredging around the Cotuit dock.

Mooring permit processing is in good shape. They are getting the seasonal people ready for the positions with the Marinas, Moorings and Pumpouts. About 90% of the buoys are in. Some of the remaining Regulatory buoys will be in the 3-Bays area soon. Swim buoys will go in this week or next. A new parking plan is being worked on for Barnstable Harbor due to the parking ban. Joe Gibbs was able to secure from Port Security Grant \$90k for a new boat for the North side. The

West Bay Tower has been replaced at a cost of \$12k.
