- The Airport has had an Agreement in place for over 12 years to provide vehicle parking behind the restaurant for employees and delivery trucks.
- The prior agreement with Pain D 'Avignon reflected a rate that was significantly lower than other parking agreements in place at \$0.976/square foot versus \$1.34/square foot
- To bring this up to date the following increases were incorporated:
 - In consultation with the tenant, we agreed to a 28% increase in year one, a 10% increase in year 2 and a 3% in the final year to bring them up to more current rates.

 - Permanent or Temporary Solution is the subject matter for the Phase V reporting
 - DEP agrees with the solution presented in Phase IV to use the filtration system installed at Maher Wells
 - The Airport is in the process of developing an MOU with DPW for the finalized filtration system which captures PFOS
 - The completion of the above brings the Airport closer to closure with PFOS

Matt Elia works very hard with the supervisors and staff to make sure that the team is ready for 365 days, not just during the inspection. He is a very organized leader and she wanted to congratulate him for his hard work.
 - Assistant Manager Elia stated that once a year the FAA will come and review the Airport processes. This allows for the Airport to improve on any areas that the FAA determines.
 - The Airport did a very good job and the addition of our compliance officer has been very beneficial.
 - There were four minor discrepancies that will be corrected within a 30 day period.

UNFINISHED BUSINESS:

IN1021-2 Review and Discuss the Sign Plan Modifications to Meet Rebranding Efforts

- · Airport Management has requested quotes for the replacement of one of the two wooden signs
- If quotes come in above \$50,000, the Chief Procurement Officer would require that we bid the services via a formal bid
- The replacement sign will be the same stone sign installed at Mary Dunn Way
- The rotary sign replacement will be in FY2023, and the Tower signage and the Attucks Lane sign will be replaced in FY2024.

IN0123-2 Electric Aviation Update

- Airport Management is working through the details on lease development with BETA from Vermont for the installation of a charging facility on the East Ramp
- Management also received the draft leases of the Nantucket and Martha's Vineyard Airports regarding the charging stations
 they want to install at their airports for continuity. Management wants to make sure policies are implemented into the lease.
- BETA would like to install a charging station (lease the land) that would be available for both aviation and vehicles.
- Archer would like to have the grid connections and charging stations built by the Airport for them to be able to develop their systems at various facilities. During subsequent meetings; a regional approach is being followed with meetings to include Mass Port, Nantucket and Martha's Vineyard Airports for connecting routes.
- The Airport, in collaboration with the Cape Cod Regional Transit Authority, is the recipient of a SMART (Strengthening Mobility and Revolutionizing Transportation) Plan Grant from US Department of Transportation to plan a smart micro grid that generates and distributes clean, reliable power for both aircraft and vehicles. The project team is led by the Mass DOT Aeronautics Division. The Grant award is \$1,950,000.

NEW BUSINESS:

IN0423-1 Monthly Update Airport Business Plan for FY2023

- Manager Servis reviewed the Business Plan Update as of 3/29/2023.
- Development of a new Business Plan will be discussed at a strategic planning meeting as many of the tasks and goals have been realized.
- The future events were reviewed and the recent Scout sleep over in the terminal was a success.
- Land Leases, Projects, Media feedback, Aviation Education, and the development of an Electric Aviation Task Force were discussed.

IN0423-2 Event Updates for CY2023

IN0423-3 Airline Development Update

- Southern Airways Express is not returning this season, but they want to maintain some equipment here.
- Gull Air is working toward their Commuter certification.
- Having an Airline Consultant on board to hold conversations and navigate the airlines is paramount. The length of the
 runways is prohibitive to attract airlines as many are selling off their regional jets and moving toward larger aircraft fleets,
 including JetBlue.
- The JumpStart event is in June and will be an opportunity to sit with airlines and identify what is offered at the airport, but
 due to the progression of the Airline consultant getting on board, it might be better to focus on the Airport Round Table in the
 Fall.

Management received a call from the Nantucket Airport in regards to the limited staffing at their airport for the season. Typically they have 16 Operations and 16 Maintenance staff that are able to respond to aircraft emergencies and meet the FAR Part 139 requirements, and this year they only have 8.

- They will reduce the availability of air carrier service from 6:00 AM to10:00 PM.
- They will have a reduced ability to accommodate for general aviation and fueling, which will impact this airport.
- The current closure of Runway 6-24 for construction causes a limitation of the wingspan that can go to the East Ramp for parking. A tenant meeting will be held to plan for accommodating additional aircraft. There was concern over providing additional fueling and adequate seasonal staff.

Manager Servis gave a quick update on the project progress. She would like to schedule a ribbon cutting ceremony for the FBO in the fall.

There was a discussion of the article in the Cape Cod Times about the tenants in the W.S. Development center.

Adjournment: Having no other business to discuss, the meeting was adjourned at 11:21 p.m.

Noise Complaint Report - January 2023

Disturbance/Response	Caller reported two loud aircraft over her area near Stewarts Creek at 0646 and 0714. She stated that she is near Twinbrook.	Responded via phone that after reviewing the flight tracks the both aircraft were flying in the voluntary noise abatement flight path and over 900 feet so this would be recorded as a noise disturbance.	Email received, "Hi Noise abatement This morning in a 5 min span all we can hear is airplanes, what's up? I've attached 3 screenshots to prove our case. Prop Planes flying between 1500-2000' above our roof (blue dot) going full throttle, 150 mph is deafening and unacceptable. Please explain what steps the airport will take to remedy this."	Responded via email: I tracked the three flights you listed and yes, they are all between 1400-1925 feet. The aircraft were flying by instruments due to the meteorological conditions and flying in established flight paths. As far as the rate of speed, our flight tracking system does not track that and any private application like flightradar only provides an estimate and does not get the information from the aircraft. Typically the speed is left up to the discretion of the pilot for their safety. In your first email, you requested to know what actions the airport would take to remedy this disturbance. The only FAA (Federal Aviation Administration) permitted noise abatement steps that Cape Cod Gateway Airport is allowed are voluntary visual flight paths (paths to mitigate noise only when not flying by instrument control) and a voluntary noise curfew (6:00 a.m. to 10:00 p.m.), neither of which in this case can be addressed. These FAA restrictions on an airport's authority over flight paths and times came out of the Congressional Airport Noise and Capacity Act of 1990 (https://www.congress.gov/bill/folst-congress/senate-bill/3094)

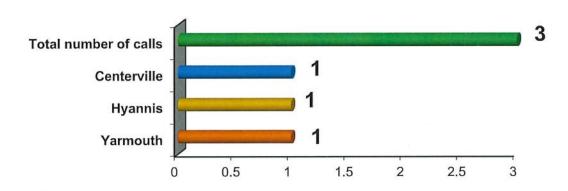

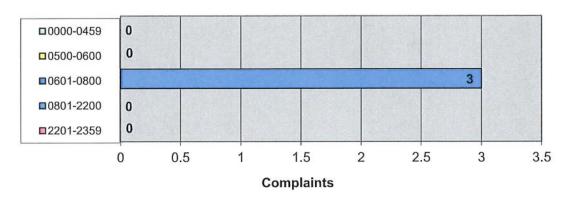


HYA 1st QUARTER NOISE STATISTICS

2023 1st Quarter by Callers



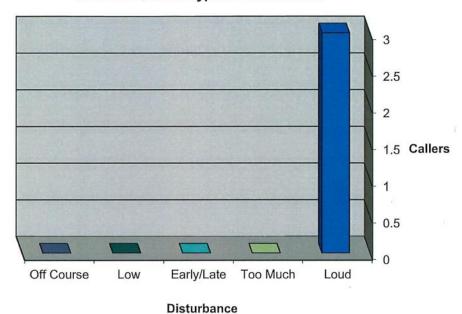
2023 1st Quarter by Hours



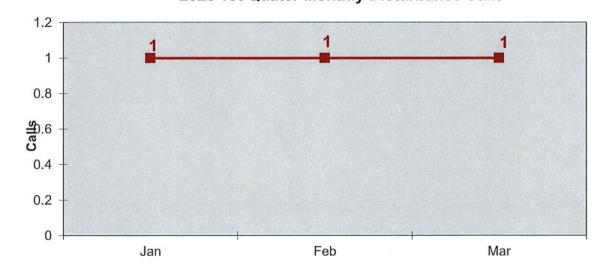




2023 1st Quarter Type of Disturbance

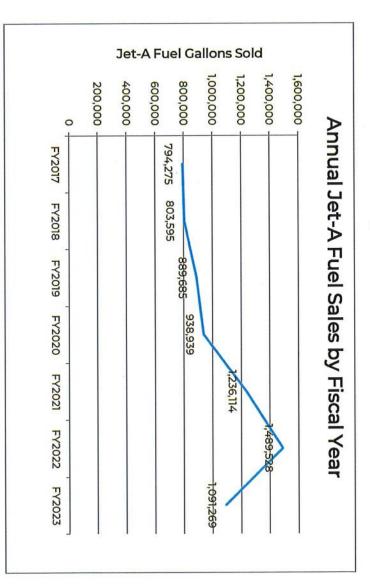

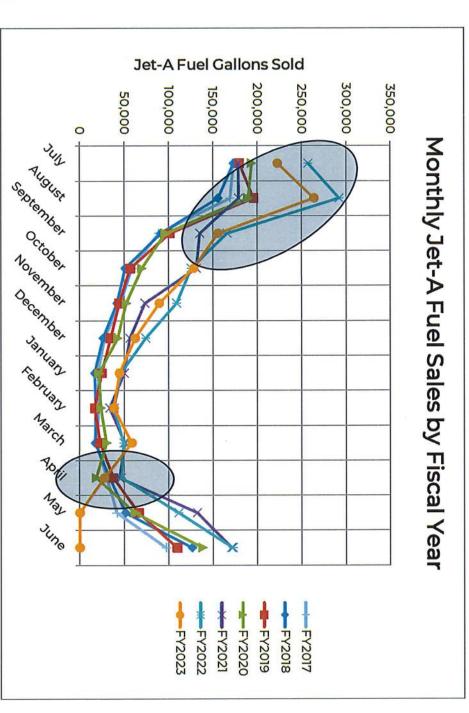

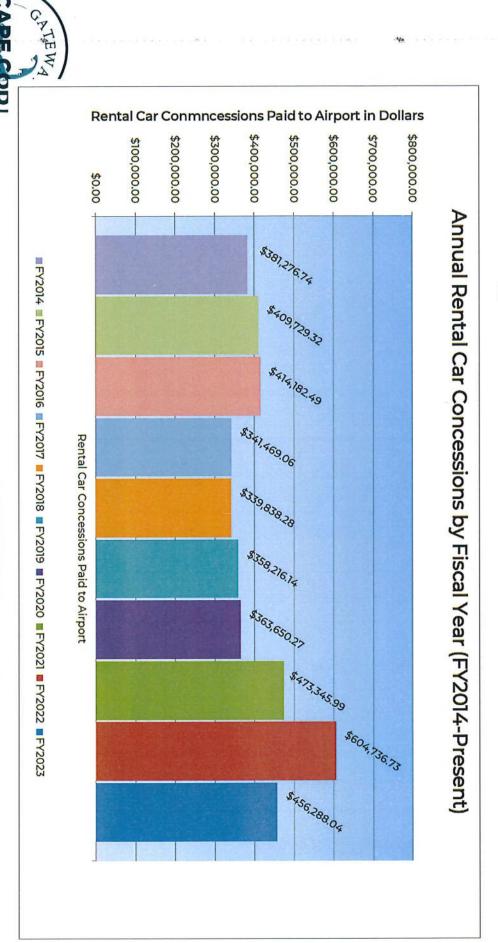

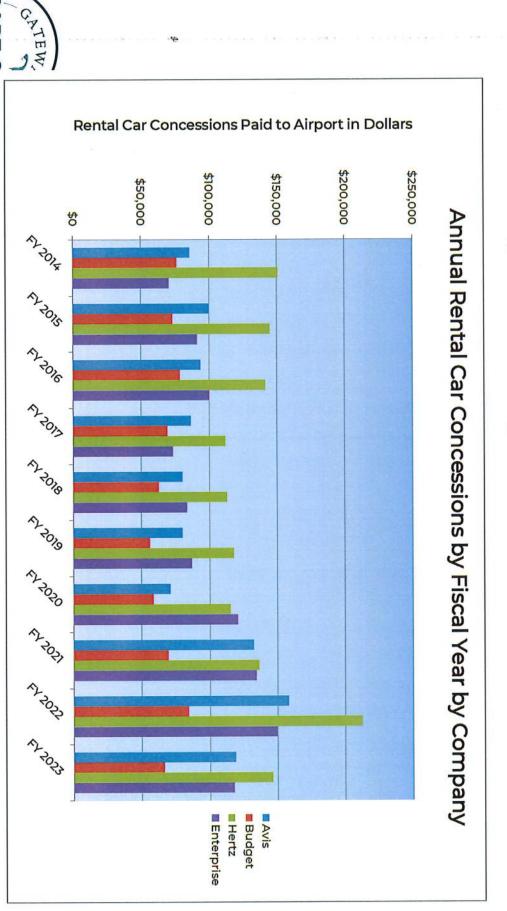

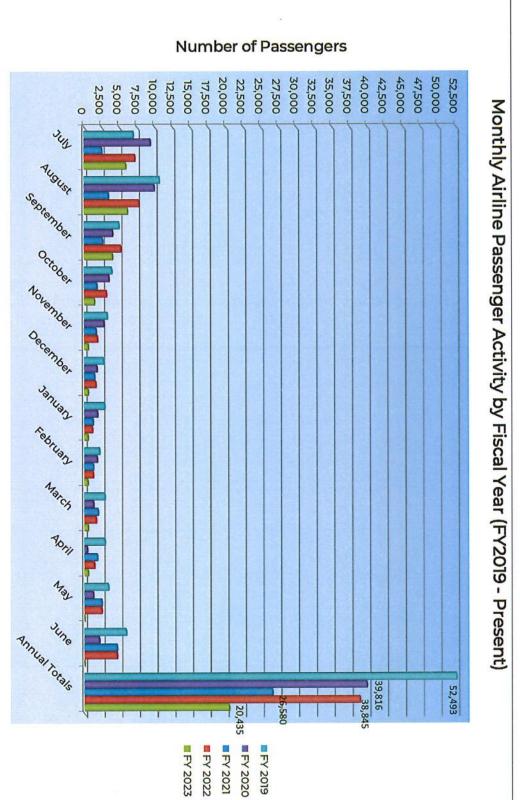


FY2023 Airport Operations/Passenger Activity
