A regularly scheduled and duly posted meeting of the Barnstable Board of Health was held on Tuesday, June 24, 2022. The meeting was called to order at 3:00 pm by John Norman, Chair. Also in attendance were Board Members Donald Guadagnoli, M.D, Thomas Lee, Daniel Luczkow, M.D, Paul Canniff, D.M.D, and Stephen Waller, M.D. Thomas McKean, Director of Public Health, and Sharon Crocker, Administrative Assistant, were also present.

I. Discussion:

Attorney Charles McLaughlin will briefly discuss risks posed to public drinking water sources by coolant fluids in transformers and the process to create and adopt regulations to mitigate this risk.

Mr. McLaughlin briefly discussed that the transformers pose a hazardous risk and the Town is considering adopting regulations to address this.

II. Variance – Septic:

Ed Gless, Existing Grade Inc, owner – 610 Skunknet Road, Centerville, Map/Parcel 169-015-016, 24,901 square feet parcel, repair of failed septic, requesting variance depth to groundwater.

Zac Gless presented the plan.

The Board discussed the concern and desire to have a four foot separation from groundwater. They also Mr. Lee proposed to change the plan to a pressure-dose system.

Upon a motion duly made and seconded, the Board of Health voted to continue this item to the next Board of Health meeting in July 2022. Roll Call: Mr. Lee-Yes, Dr. Luckow-Yes, Dr. Guadagnoli-Yes, Mr. Norman-Yes. Dr. Canniff-had technical difficulty. (Unanimously, voted in favor.)

III. Septic Installer (New):

- A. Michael Escher, MCE Dirtworks, Harwich, MA.
Installer passed exam and all paperwork was in order.

Upon a motion duly made and seconded, the Board of Health approved Michael Escher as a septic installer. Roll Call: Mr. Lee-Yes, Dr. Luckow-Yes, Mr. Norman-Yes, Dr. Guadagnoli-Yes, Dr. Canniff-technical difficulty. (Unanimously, voted in favor.)

- B. Kenneth Reposa, Tewksbury, MA.
Installer passed exam and all paperwork was in order.

- C. Ed Hart, Middleboro, MA

The Installer passed exam and all paperwork was in order.
