### BOARD OF HEALTH MEETING MINUTES Tuesday, October 25, 2022 3:00 PM

#### ZOOM MEETING 821 5438 2370

A regularly scheduled and duly posted meeting of the Barnstable Board of Health was held on Tuesday, October 25, 2022. The meeting was called to order at 3:00 pm by, John Norman, Chair. Also in attendance were Board Members Donald Guadagnoli, M.D. and Stephen Waller, M.D. Board members Thomas Lee, Daniel Luczkow, M.D., and Paul Canniff, D.M.D., were not able to attend. Thomas McKean, Director of Public Health, and Sharon Crocker, Administrative Assistant, were also present.

#### **I. SEWER CONNECTION - EXTENSION.**

Louise DiCecca, owner – 39 Greenwood Avenue, Hyannis, Map/Parcel 289-092. Initial due date approaching, 10/30/22 for sewer connection. Requesting an extension for three months as contractor's schedule is not available for 2-3 months.

Louise DiCecca was present and stated she is ready to put a deposit down on the job as soon as she knows a three month extension is possible.

Mr. McKean stated the staff has no issues with this and is aware of contractors backed up all over the Cape.
