Approval of the Draft CPC Regular Meeting Minutes from September 24, 2018.

Letters of Intent:

- Letter of Intent has been received from the Centerville Historical Museum located at 513 Main Street, Centerville, MA seeking \$30,000 in CPA Historic Preservation funds representing a portion of the entire project cost to replace the roof of the main museum building and adjoining Tin Shop. The museum contains 17,000 irreplaceable historical artifacts that define the history of Centerville and surrounding communities.
- Letter of Intent has been received from Saint Mary's Episcopal Church, Barnstable, MA seeking
 a total of \$147,725.20 CPA Historic Preservation funds which represents a portion of the entire
 renovation project amount of \$1,700,000. Funding request is to provide a portion of the cost for
 fire protection throughout the church, replace exterior wood trim, and restore the stone entrance
 on Route 6A.
- A Letter of Intent has been received from the Barnstable Historical Society seeking \$199,000 in CPA Historic Preservation funds for structural, exterior and interior renovations to the Barnstable Historical Society Building located at 3087 Main Street, Barnstable, a historically significant building. The building serves as a museum for display and preservation of the Historical Collection and other historically significant items relating to the Town as well as Cape Cod. Research assistance, educational tours and children's activities for the community are also held at the BHS Building.
- A Letter of Intent has been received from the owner of Captain Allen Crowell Homestead circa 1851, located on Pleasant Street, Hyannis "Sea Captain's Row" seeking \$25,000 in CPA Historic Preservation funds yearly to assist in the upkeep of the property advancing it as education and historical site open to the public. The property has been nominated for the Most Endangered Massachusetts resource with Mass Preservation.

A Letter of Intent has been received from Seashore Homes, Inc. seeking \$100,000 in CPA
Community Housing funds to support the creation of one deed-restricted affordable rental unit
located within a newly constructed residential development containing 8 two-bedroom
apartments located at 185 Ridgewood Avenue, Hyannis.

Meetings of a local public body, notice shall be filed with the municipal clerk, and posted in a manner conspicuously visible to the public at all-hours in or on the municipal building in which the clerk's office is located.
