I ENFORCEMENT ORDERS

A. Lori and Jay Elias – 582 Shootflying Hill Road, Centerville **SE3-2721** Violation of an enforcement order, by failing to request a Certificate of Compliance

V OLD AND NEW BUSINESS

Mrs. Denise Swan – 32 Windswept Way, Oyster Harbors annual planting report – winter moth impact

Mrs. Swan was represented by Bruce Besse of Barnstable Land Design.

Issues discussed:

- Ms. Karle gave a brief history of the original (2009) enforcement order.
- The Agent submitted the following aerial photos: September, 2001; April, 2005; April, 2008; July, 2009. The photos were noted as Exhibits A D, respectively, and reviewed by the Commissioners present. The exhibits will be placed in the 2009 Enforcement Binder (under "Swan"), along with the 2010 planting report, presented to the Commission as Exhibit E.

A motion was made to replace the nineteen trees which did not survive, due to winter moths, with a suitable canopy species (not susceptible to the moth), e.g., White Pine; to be done in consultation with staff. The three-year survive-or-replace timeframe would start again with these new trees. The Commission would recommend spraying all winter moth-susceptible trees in the future.
