#### II ENFORCEMENT ORDERS

A. Saundra and Jordan Tobins – 1110 Craigville Beach Road, Centerville Alteration of a flood zone and 100' buffer zone from a salt marsh by removing vegetation/grading, tree removed, beach grass removed planted from prior filing on abutting lot and sand pile pushed up to property line.

The Conservation Agent presented a summary of the violation.

Jordan Tobins described the work as a clean-up effort. The flooding events are much more frequent since construction of the neighboring driveway. The flooding brings jetsam and flotsam into the yard.

The Chair said the Tobins' should have consulted the Conservation Agent prior to launching the clean-up effort.

No remedial action was required by the Commission.

B. Alan Horvitz – 66 Holly Point Road, Centerville Unpermitted dock on Bearse Pond.

The Conservation Agent summarized the violation.

Mr. Horvitz recently acquired the parcel, and the need for pier permitting was not brought to his attention at the time.

A motion was made to approve the amended enforcement order. The pier will remain in place pending the filing of a notice on intent application by September 30<sup>th</sup>, 2013.
