- Question if there was any increase in hardscape proposed. The project is actually pulling hardscape away. There is an undisturbed 50' buffer.
- No change in proposed vista corridors.
- Question on drywells. They were identified on the previous plan.
- Question raised is there a jump of 2' in wall elevation?

IV. ENFORCEMENT ORDERS

A. Pamela C. Zibutis – 82 Ginger Lane, Centerville – Map 247 Parcel 147. Alteration of the buffer to a wetland resource area – wooded swamp – by piling slash and logs within the buffer and installing and maintaining an unpermitted shed.

Mr. Frank Zibutis represented Ms. Pamela Zibutis.

Issues discussed:

- 82 Ginger Lane is owned by the Town of Barnstable. There is a wetland that occurs on the back portion of the parcel which makes the entire parcel within wetlands jurisdiction.
- The shed/lean-to has been removed from the property and most of the slash and logs have also been removed. Mr. Zibutis asked for an extension to May 7, 2021 to finish removing the last of the slash, which was granted.

B. Stanley M. Hammond & Simone DeCastro – 39 North Precinct Rd., Centerville – Map 148 Parcel 130. Alteration of a wetland resource area – wooded swamp – by cutting trees and of the buffer to a wetland resource area – wooded swamp – by cutting trees. **Tabled from April 6, 2021.**

Attorney David Lawler represented Mr. Hammond and Ms. DeCastro. Mr. Stanley Hammond was also present.

Issues discussed:

- Mr. Hammond was not responsible for the cutting on the property. All cutting within 100' of the wetland resource area and in the wetland resource area was done by an agent (Michael Pacheco) working for the neighbor at 49 North Precinct Rd. (Cedalia Pacheco).
- Until the property line is marked, it is not possible to know how many trees were cut on the Hammond/DeCastro property versus what was cut on the adjacent property (Pacheco).
- Since Ms. Pacheco cut trees on both her property (49 North Precinct Rd.) and this property (39 North Precinct Rd.), she will need to coordinate restoration planting and survey work with Mr. Hammonds agent (Attorney David Lawler) who provided Ms. Pacheco with his contact phone number.

A motion was made to issue an amended Enforcement Order naming Cedalia Pacheco as a coviolator.

C. Cidalia M. Pacheco – 49 North Precinct Rd., Centerville – Map 148 Parcel 131. Alteration of a wetland resource area – wooded swamp – by cutting trees and alteration of the buffer to a wetland resource area – wooded swamp – by cutting trees and placing unauthorized fill (wood chips).

Natalia Lima represented Cidalia Pacheco.

Issues discussed:

- Ms. Pacheco and her agent Michael Pacheco (Pacheco Landscaping) cut trees on this property and on the abutting property at 39 North Precinct Rd. (Owner Stanley Hammond and Simone DeCastro).
- A concern for lack of understory vegetation on site. There was no understory cut.
- A concern was raised, given the increasing drought conditions in the area, whether it will be possible to delineate the wetland. The wetland resource should be able to be delineated on the basis of plants alone but soils may have to be considered too.

A motion was made to approve the enforcement order as written.

D. Eva Maria T. Janerus – 3009 Main St./Rte 6A, Barnstable – Map 279 Parcel 050.001. Alteration of a wetland resource area – scrub-shrub swamp – by replacing a pipe without permitting and alteration of the buffer to a wetland resource area – scrub-shrub swamp – by cutting trees and shrubs.

Eva Maria T. Janerus represented herself.

Issues discussed:

- The existing concrete pipe was broken and has not been fully functioning for several years.
- The Enforcement Order asks that an engineer determines the invert elevations of the replaced pipe and that if the existing (replaced) pipe elevations do not match the elevations specified in the plan of record for SE3-1992 that the replaced pipe be re-installed to meet the original conditions. The re-installation, if needed would be covered as part of the restoration plan.
- The Commission amended the Enforcement Order to include Drew Baldasaro of Asphalt Solutions Enterprises (who did the pipe replacement work and cut the trees) as a co-violator.
- The Commission amended the Enforcement Order to state that if an engineer determines the replaced pipe in its current location is sufficiently moving the water so as to maintain past hydrologic conditions, that the homeowner be allowed to file a Notice of Intent (after-the-fact) to seek permitting for the replacement pipe.

A motion was made to approve the Enforcement Order as amended.

E. Drew Baldasaro - 3009 Main St./Rte 6A, Barnstable – Map 279 Parcel 050.001. Alteration of a wetland resource area – isolated vegetated wetland – by placing stone fill without a permit and alteration of a wetland resource area - scrub-shrub swamp – by replacing a pipe without permitting and alteration of the buffer to a wetland resource area – scrub-shrub swamp – by cutting trees and shrubs.
