Natural Resource letter dated 11/18/2022 was read into record.

Division of Marine Fisheries letter with recommendations dated 11/21/2022 was read into record.

Issues discussed:

- The existing pier is supported on 4x4 posts and will remain.
- The area with the float will also be 4x4.
- Float stops will provide 12" of clearance.
- The pier will stay in all year. The ramp and the float will be removed for the winter.
- A revised plan noting the size of the posts will be submitted.
- A question was raised about DMF recommending $2\frac{1}{2}$ feet under the float. This is a low shellfish rating area so 12" under the float should be fine.
- A question was asked how the float and ramp will be removed. They will be towed away with a boat at high tide.

There was no public comment.

A motion was made to approve the project subject to receipt of a revised plan showing the dimensions of the piles and their locations.
