The meeting was called to order at 6:30 p.m. by Chair F. P. (Tom) Lee. Also in attendance were: Vice Chair Louise R. Foster, Commissioners Abodeely, Gillmore, Hearn, Morin, and Sampou.

Conservation Administrator, Darcy Karle was present along with Administrative Assistant, Kim Cavanaugh.

I. OLD & NEW BUSINESS

A. Open Meeting Law Violation Complaint filed with Conservation Commission by Larry Morin dated June 7, 2023, discussion and vote about response.

After discussion with the Legal Department, the Chair recommended that the Commission vote to delegate the Open Meeting Law violation complaints to the Town's legal department to respond to the two Open Meeting Law violation complaints.

Town Attorney Charles McLaughlin was available to answer questions.

Issues discussed:

- A comment was made that there does not seem to be any merit to either of the complaints.
- The technical requirements of a response is best handled by the legal department.

A motion was made to delegate to the Legal Department the investigation, reporting analysis, and official responses for consideration and potential adoption by the Conservation Commission for Commissioner Larry Morin's complaint. Seconded and voted by roll call.

II. REQUESTS FOR DETERMINATION

A. Jeffrey Becker. Proposed septic system upgrade at 1344 Main Street (Route 6A), West Barnstable as shown on Assessor's Map 177 Parcel 006. DA-23039

The applicant was represented by Daniel Ojala, P.E. of Down Cape Engineering, Inc.

Issues discussed:

- There will be a change to the plan to add a pump chamber.
- A revised plan will need to be submitted.
- Components of the system were identified on the plan.
- A pump will require more maintenance.
- There is an alarm if the pump stops running.
- In a power outage there will be two days worth of flow. If longer, a generator can be hooked up.

There was no public comment.

A motion was made to approve this project as a negative determination subject to receipt of a revised plan adding the pump chamber. Seconded and voted by roll call. Aye –Abodeely, Foster, Hearn, Lee, Morin, Sampou Nay -

A. John A. & Colleen J. Boselli. To permit and maintain expansion of existing float at 183 Bay Street, Osterville as shown on Assessor's Map 117 Parcel 152. SE3-6103

A continuance without testimony was requested to July 11, 2023.

A motion was made to approve the continuance request to July 11, 2023 without testimony. Seconded and voted by roll call.

B. Barbara Anne Kowack-Murthy. Raze and replace existing single family dwelling, wetland restoration, and mitigation plantings at 21 Lookout Lane, Hyannis as shown on Assessor's Map 325 Parcel 103. SE3-6104

The applicant was represented by Daniel Ojala of Down Cape Engineering, Inc.

Issues discussed:

- A haybale/work limit line needs to be added to the plan. It will be along the fence.
- The white fence appears to be a community fence. Taking down one piece of fence would not help anything.
- A plastic fence should not be in the resource area.
- There was discussion about the data sheets done by Brad Hall. They need to current data sheets that DEP expects. The sheets were done on 7/16/2019 before the new data sheets were in effect. They will be accepted as submitted.
- A question was asked why the the white fence could not be moved to where the picket fence is.
- It would be too close to the house.

There was no public comment.

Public comment:

David Sell – neighbor at 44 Island View Road – He shares the fence. It is for multiple properties. Would like to keep the same lines of the existing fence. A second floor will be added to the building. A question was asked about a deck on the roof. There is a small widow's walk. This is outside Conservation jurisdiction. He was advised his question could be addressed to the Building Commissioner.

• A CERP is needed to do the restoration in the wetland area.

A motion was made to approve the project subject to the contractor needs to be a Certified Ecological Restoration Profession to restore the wetland, monitoring reports for three years, a change in contractor will require written notification to writing to Conservation Administrator, submission of a revised plan showing the work limit line.

NHESP letter dated June 16, 2023 was received. DMF letter dated May 24, 2023 was received. Waterway's Committee letter dated June 14, 2023 was received. They are in support of the project. MEA letter dated June 14, 2023 was acknowledged and reviewed.

- Jimmy Foth commented on Special Condition #16. They do not need to do eel grass surveys as they are outside the 100' buffer. Special Condition #16 will be removed.
- Special Condition #3 regarding reuse of dredging materials will be modified relative to the slope. The changes have been reviewed by Darcy.
