A. Deborah A. Sosland-Edelman, Trustee – Cotuit House Trust Number 1. To remove pool and patio and construct new pool and patio at 54 Point Isabella Road, Cotuit as shown on Assessor's Map 074 Parcel 018. **SE3-6148**

The applicant was represented by John O'Dea, P.E. of Sullivan Engineering and Consulting.

Issues discussed:

- There are three large trees shown on the plan that are not being removed.
- Annual monitoring reports will be needed for three years.

Public comment:

Beverly Jackson - 40 Point Isabella Road - Beverly is curious about the three trees near the work limit line. There is a large, wooded area between the houses. Her bedroom is near the pool. Is the left front corner in the same place that it is now. Asked what her side of the fence will look like. Asked if there is a vegetation plan along the property line.

John O'Dea addressed her questions. The pool will be a couple of feet further away than it is currently. There are no plantings going along the fence.
