Barnstable Disability Commission Minutes October 19, 2022 via Zoom from 10 am to 12 pm

Meeting called to order at 10:00 a.m.

*Members present:* Paul Logan; Chair, Sheila Mulcahy, Vice Chair, Linda McKinney, Mike Hersey, and Jerilyn DiCostanzo.

*Approval of the minutes of September 21, 2022* – Linda McKinney made a motion to approve, Sheila Mulcahy seconded. Unanimous.

**Financial Report** – Current balance is \$39,442.12.

Peter Bertling provided an update on the current status of parking in Barnstable. There is discussion on increasing the fees.

Peter stated that in light of the recent notification from Mass. Office of Disability at Bismore Park there will no longer be fees assigned to the metered spots in this parking lot. The signage has been removed. In addition, there is no maximum time frame.
