- Business sign: aluminum sheet; top of words will be cut out around the letters, the part in white is solid and will be affixed to the awning; awning is red; sign will be white with red outlined letters
- Concerns raised regarding weight of sign and how it will be secured; Members request Ms. Oliver to check weight of sign and its ability to sustain the elements
- Size: awning is 12" and sign is 18"
- Open neon sign: neon sign: permitted under code, HHDC is an exception, two color with gas not led or other materials; placement will be in the front window; applicant does not imagine the neon sign will be used often due to business hours
- Nylon open sign or adjacent to window; applicant reminded that the flag or neon sign may only be used one at a time
