Business sign

- Application reviewed 1; existing sign will be repainted with new business name
- Sign material: concerns expressed regarding sign material of corrugated plastic; sign maker is Joel Kecada; Meaghann Kenney requested locations of examples of other signs created by Mr. Kecada; sign will be repainted; proposing oval sign on existing rectangle, remainder of background will be white; commission prefers a wood or Azek material or other HHDC approved material
- Color: very strong; not of a historic nature; applicant agrees to a softer pink background, same or similar to that of Bella of Cape Cod

- Sign material is metal, powder coated black; placed over the clapboard and out approximately two inches
- For the record internally illuminated signs are not permitted
- Lighting will be of a yellow/gold color

# Prova Brazilian Restaurant, 415 Main Street, Map 326, Parcel 014

Outdoor tables, chairs and egress door/stair

Represented by Warren Reed of Building Technologies for Prova Brazilian Restaurant

- Application reviewed 5
- Means of egress on South wall upgraded, reviewed and approved as required by the Fire Department; fire rated doors with same hardware as existing egress door
- Table tops: will be Kashmir white granite
- Table bases: will be black iron material; proposed manufacturer changed to EMU Sole #3403HD in antique iron, stands will be black as well
- Gazebo bar: seeking to install onyx to wrap internal bar face wall, similar to a kick bar
- Bar stools requested to match table chairs, with a bottom support bar
- Seeking to install a vestibule in the front identical to front construction to suppress air entering when the doors are opened and
  altering the interior room temperature; Mr. Reed assures that all materials proposed for the vestibule will be exactly the same as
  the rest of the building; Commission requests an architectural rendering / actual plan; proposed roof pitch will match existing;
  proposed door specs will be the same as the front door; applicant will return with updated renderings
