#### New Business

Town of Barnstable Growth Management Department, 427 Main Street, Map 308 Parcel 079 (Sturgis Public Charter School)
Two historic Kennedy photographs on 80" x 130" fiberglass panels and five sailboat banners on building façade
Represented by: Kate Kennen – OffShoots Productive Landscapes

Melissa Hersh – Arts and Culture Coordinator, Growth Management Department
Jim Albrecht – Director of Finance and Operations, Sturgis Charter Public School (SCPS)

- Application reviewed <sup>1</sup>
- Speaks to the Kennedy Legacy Trail project; goal is to increase the appeal down Pearl Street and encourage visitors to explore the next series of sites
- Seeking to install two (2) fiberglass panels (each panel is comprised of two panels each 120" long x 40" wide that are mounted together, but will appear as one); the photographs are imbedded in a ¼" graffiti resistant, 10-year guarantee fiberglass that meets the National Park Service standard; hidden mounts which will be attached to the brick masonry; placement proposed between the two series of windows as shown in the rendering; photographs were chosen and approved by the SCPS and are consistent with the photos along the Legacy Trail
- Addition of five (5) sail boat banners all in blue; same as those on Main Street light poles
- Have met with and received approval from SCPS board
- Flags: discussion of placement

### Motion duly made by Meaghann Kenney, seconded by Joe Cotellessa to approve the application as presented Discussion

- The mounting system is easily removable if necessary
- Frames and panel size discussed; may possibly reduce the size of panels

## Motion duly made by Dave Colombo, seconded by Paul Arnold to continue the application to Saturday, May 5, 2012 at 8;35am for a site visit

Discussion

- Kate Kennan: if approval was secured tonight so that all aspects could be in place for the ribbon cutting Memorial Day for
  JFK's birthday; project funding through a grant is time sensitive; flag placement has been thoroughly reviewed for maximum
  effect despite the visual rendering being incorrect
- Site visit: members request the area be taped off for visual effect
- Legal posting notice to be facilitated by Theresa Santos in accordance with Open Meeting Law requirements

Comments: Meaghann Kenney - unable to attend site visit, but expresses approval with a frame same size as existing windows; Paul Arnold – prefers approval on application as presented; Marina Atsalis – change photos, add frame, change banner placement; George Jessop – tape off area identified on façade to scale, re-space flags equally; determine scale, crop and/or re-size the picture, and vote at the site visit; Dave Colombo – site visit required for decision

- Application reviewed<sup>2</sup>
- Sign material: laminated paper, plastic and wood
- Placement: new sign in same place of previous tenants (Urban Zone)
- Graphic: reviewed and altered; re-space / re-size lettering and graphics, remove stars; photograph to be black and white; letters to be painted
- Request samples of signs produced by applicant to show quality as well as a re-scaling of the proposed business sign with incorporated changes as requested by the Commission
- No open/closed sign requested at this time

#### Cape Cod Maritime Museum, 135 South Street, Map 326, Parcel 061

Paint Museum Exterior; Climb-aboard park; landscaping, hardscape and brick walkway; picnic tables and umbrellas Represented by Janet Preston

- Application reviewed<sup>3</sup>
- Climb aboard boat: donated by Chris Kelly; top will be built as an exhibit, child safe throughout
- Mulch is all wood
- Umbrellas: no logos planned; will be canvas in either blue or green; anticipate umbrellas lasting through the season; material is white aluminum metal finish with navy blue canvas
- Seeking approval from HHDC so that project is ready by Memorial Day
- Hardscape: will be concrete aggregate, native stone
- Walkway: will be brick and adjoin Pleasant Street Park brick walkway
- Picnic tables reviewed
- Landscaping; Sea Grass and hearty Rosa Rigosa

- Minor modification reviewed<sup>4</sup>
- Applicant states purpose is for review and approval of alley vendor carts, fencing color and one small sign; Clarification by Elizabeth Jenkins that the alley vendor carts is the only applicable topic for discussion
- Vendor cart rendering submitted into record; seeking four carts, each of which colors will match respective buildings (cart
  one color / canopy the other color: yellow/green for the front building; blue/white for the middle building; red/white for the rear
  building); vendors prefer two styles; members would like to see the bicycle wheel painted to match the cart so as not to
  stand out; one cart is collapsible and transportable, minimal storage available; applicant agrees to paint the posts and
  wheels of the metal cart

Motion duly made by Paul Arnold, seconded by Bill Cronin to accept the two styles of vendor carts with the understanding that the posts and wheels be painted black
