Outside dining furniture (tables and chairs), wrought iron barrier Represented by Michael Hoagland

- Constructing a permanent outdoor patio with movable wall enclosure patio to replace the existing fabric patio
- Seeking approval on new tables and chairs
- Proposed structure will be slightly extended towards the back from the existing footprint
- Chairs will have aluminum frame with a wicker seat back which is affixed to the frame
- Tables will have aluminum frame and mahogany tops to match as closely as possible to chair backs
