A quorum being duly present, Paul S. Arnold, Chair opened the meeting at 6:30 p.m.

An announcement was made by Paul S. Arnold, stating the meeting is being recorded and broadcast on Channel 18 and in accordance with MGL Chapter 30A, §20; and requested that anyone taping this meeting to please make their presence known.

New Business

Paul N. Melville d/b/a Cape Cod Family Resource Center – 29 Bassett Lane, Hyannis – Map 308 Parcel 271 Business Signage

Chic Pollock, sign contractor in attendance.

Paul Melville and Steven Zeisis from Family Continuity/Family Resource Center in attendance.

Paul Melville states that they have not had exterior signage there for two years.

Chair Paul Arnold asks how it will be mounted and clarification of color.

Chic Pollock explains that the sign will be wrapped, bronze colored aluminum, ½ white center plaques will be digitally mounted.

Chair Paul Arnold asks what is "Cape Cod Family Resource"?

Paul Melville replies that it is a state funded non-profit organization open to all families. They help people with resources in the community. Everything is free and need based for families.

Chair Paul Arnold refers to the picture of the sign, Exhibit A, confirms just one sign and the demensions.

Chic Pollock explains the color from a color chart, medium bronze color from a color chart.

Paul Melville replies, yes, one sign, they are flexible with the medium bronze color.

Taryn Thoman asks where the address is.

Paul Melville answers that it's where Prime Lending used to be.

Chair Paul Arnold entertains a motion, moved by Marina Atsalis to accept as presented, seconded by Taryn Thoman, so voted unanimously.

Mary Ann Agresti in attendance. Elizabeth Wurfbain in attendance.

Mary Ann explains where the utility box is located. Passes around picture(s) of where it will be and design of, Exhibit B. Some historic pictures (black and white) are passed around with an explanation of the history of this particular area and how it will be incorporated into the design on this particular utility box.

Marina Atsalis comments that she doesn't like the colors that are presented. She thinks that the utility boxes that have already been painted could have been able to be cohesive, maybe whales or to make some kind of continuity with them in total, possibly from a start to end of Main Street. Suggests rich colors/older colors with a more historic look.

Timothy Ferreira comments that maybe an application should have been presented.

Chair Paul Arnold states that they could bring in an application. Taryn Thoman also asks about an application.

Discussion regarding submission of a complete application.

Elizabeth Wurfbain clariles that they were here before with an application (for the former utility boxes).

Taryn Thoman comments that maybe we do need these types of colors. She is in favor of the colors.

John Alden approves as well. He likes that it enhances the beauty of Downtown Hyannis.

Chair Paul Arnold comments that he thinks Mary Ann Agresti did try to look at some history, he likes the colors.

Chair Paul Arnold entertains a motion, moved by Taryn Thoman to approve this particular drawing/art at this particular location, for this particular utility box (with formal application to be filled out) seconded by John Alden, Timothy Ferreira is in favor. Marina Atsalis abstains. The vote passes, 4 to 1.

Elizabeth Wurfbain comments that they had a committee and they had many discussions about the colors, It adds an excitement and people put a lot of effort into them. Trying to make pleasing to all.

Mary Ann Agresti explains that it was an opportunity for the artists to show their interests.

Chair Paul Arnold comments that when other

Marina Atsalis comments that the Barnstable Historic Commission gets listened to. People need to respect us/our opinions and suggestions. Town government, especially Growth Management do what they want.
