Dave Dumont recuses himself from this application - He will not be participating in this application.

Andrew Wade, of My Generation Energy in attendance. He gives an explanation of the proposed solar project. Roof mounted panels, all black.

Jack Kay asks how are the conduits and ancillary equipment being run from the panel location? Will it be grey or white conduit?

Andrew Wade replies being done with micro inverters, up through the attic with the conduit. They want to keep everything inside the bldg. wires through the bldg. Grey conduit. Any conduit for outside he would be glad to review with the Commission if it has to go outside.

Betsy Young asks for clarification of what side of the building, left side.

Andrew Wade answers, from South Street, it's the west side of the bldg., southwest, opposite the intersection.

### Chair Cheryl Powell asks for any public comment.

Jake Dewey in attendance, 17 High School Rd., Hyannis, abutter. He is in support. The building does have some historic significance, this is a change to what the roof will look like.

#### Chair Cheryl Powell closes public comment.

Paul Wackrow explains that not to many solar applications come to HHDC. The ordinace and guidelines don't have much for this. Refers to Staff Report, Exhibit A. Guidance from Secretary of Interior and Mass Historical Commission's guidebook, example of how they view some of these installations.

Paul Wackrow directs to Andrew Wade, asks where conduit would go.

Andrew Wade refers to the picture of the roof, dormer, between long skinny addition, Exhibit B, picture stating proposed location aerial view. This would keep it as hidden as possible.

Jack Kay asks where electric meter is on the house? Will you have to install another panel?

Andrew Wade replies that they can tie into the existing panel in the basement. They will have to install a separate meter. He believes that it is on the front southwest side of the bldg. disconnect switch and another meter.

Chair Cheryl Powell entertains a motion for the Findings, moved by Betsy Young to find this application located at 336 South Street, Hyannis to be compatible with the preservation and protection of the district, seconded by Cecelia Carey, Roll Call Vote:
