LICENSING HEARING MINUTES

Town Hall Building, 367 Main Street, 2nd Floor Hearing Room, Hyannis, MA – 9:30 a.m.
December 9, 2013

A regular meeting of the Barnstable Licensing Authority was held on Monday, December 9, 2013, Chairman Martin Hoxie called the meeting to order at 9:30 A.M. He introduced Gene Burman, Vice Chairman; Paul Sullivan, Clerk; Ron Semprini, Associate Commissioner; David Nunheimer, Associate Commissioner, Richard V. Scali, Interim Director of Regulatory Services, Lt. John Murphy and Patrolman Steve Maher, Liaison Officers from the Barnstable Police Department, and Christine Ade, Recording Secretary. Dick Boy was absent.

Vote to accept Minutes: Vote to accept minutes of the 11/18/13 Meeting.

A motion was duly made by Mr. Burman, seconded by Mr. Sullivan and a unanimous vote taken to accept the minutes of the 11/18/13 Meeting.

Hearings:

One Day Wine & Malt License & 1 Day Entertainment License: Application of Joseph Jamiel, Ardeo, 23V White's Path, S. Yarmouth, for a One Day Beer & Wine License to serve at the Barnstable Municipal Airport concourse area for a Winter Solstice celebration for Airport employees on December 19, 2013..

Mr. Jamiel appeared for the application. He is the owner/operator of Ardeo. They are requesting a one day license for 1 day 4-6 pm; 1 bar set up only. It is December 19, 2013.

Mr. Hoxie asked who will serve the alcohol; Mr. Jamiel stated a TIPS certified employee.

A motion was duly made by Mr. Burman, seconded by Mr. Sullivan and a unanimous vote taken to approve the application of Joseph Jamiel, Ardeo, 23V White's Path, S. Yarmouth, for a One Day Beer & Wine License to serve at the Barnstable Municipal Airport concourse area for a Winter Solstice celebration for Airport employees on December 19, 2013 from 4 pm to 6 pm.

Amend Class II Auto Dealer License: Application of AMR Holdings – MH, LLC., d/b/a Prime Pre-Owned Center, 95 Falmouth Road, Hyannis, Matthew McGovern, Manager, to amend its Class II Auto Dealer license to change its parking plan to that approved by the Building Commissioner on 11/1/13 to encompass 19 customer/service vehicles, 79 display/unregistered vehicles and 2 handicap vehicles, for a total of 100 vehicles on the site.

Matt McGovern, co-owner and Tim Fallows, location manager appeared to request to amend the existing license to include # of ehicles on the site.

Mr. Hoxie asked if this was in order; Officer Maher stated it is.

A motion was duly made by Mr. Burman, seconded by Mr. Sullivan and a unanimous vote taken to approve the application of AMR Holdings – MH, LLC., d/b/a Prime Pre-Owned Center, 95 Falmouth Road, Hyannis, Matthew McGovern, Manager, to amend its Class II Auto Dealer license to change its parking plan to that approved by the Building Commissioner on 11/1/13 to encompass 19 customer/service vehicles, 79 display/unregistered vehicles and 2 handicap vehicles, for a total of 100 vehicles on the site.

Amend Class I Auto Dealer License: Application of Xiphias Enterprises, Inc., d/b/a Hyannis Honda Annex, 405 West Main Street & 57 Shady Lane, Hyannis, James B. Goodwin, Manager, to amend its Class I Auto Dealer license to include a total of 79 spaces as shown on updated plan signed by the Building Commissioner 10/15/13. Continued from 11/18/13.

Jay Goodwin appeared for this application. The purpose of this application is to comply with the request of Mr. Scali for the use of the property for new vehicle storage.

Mr. Scali stated this is one of the ones on the BPD list needing updating. They have now come into compliance.

A motion was duly made by Mr. Burman, seconded by Mr. Sullivan and a unanimous vote taken to approve the application of Xiphias Enterprises, Inc., d/b/a Hyannis Honda Annex, 405 West Main Street & 57 Shady Lane, Hyannis, James B. Goodwin, Manager, to amend its Class I Auto Dealer license to include a total of 79 spaces as shown on updated plan signed by the Building Commissioner 10/15/13.

Show Cause Hearing: At the request of the Town of Barnstable Building Division and Barnstable Police Department, a Show Cause Hearing is requested on Ferreira's, 85 Old Yarmouth Road, Timothy J. Ferreira, Manager for the purpose of determining if its Annual Junk Dealer License should be modified, suspended, revoked or otherwise conditioned due to the following violation pursuant to a Police Report dated October 25,: Violation of the restriction on its current Junk Dealer's License, to wit: "Recycling bins and related equipment to be utilized and stored within the existing building." Attorney

request to continue to January 13, 2014 hearing. Mr. Hoxie stated this would be continued to January 13, 2014.

Addition of Regulations for Class I & Class II Auto Dealers as proposed by the Barnstable Police Department as follows:

Clarification to categories of vehicles to change wording from total vehicles allowed to wording that reflects numbers for display/unregistered vehicles, customer vehicles and/or employee vehicles.

1. Require a sign on the property, legible from the street, listing the name of the business and the hours of operation.
2. In the case of a new or modified application, require that the associated repair facility sign off on the application of the auto dealer indicating their affiliation with the applicant. In the case of existing licenses, a letter be kept on file and updated yearly of the affiliation with a repair facility.
3. Require all licensees to have available on site and readily available for inspection a copy of the approved parking plan submitted with the application and approved by the Board.
4. Require that all spaces delineated on the approved parking plan be marked out on the surface of the property with lines utilizing a permanent substance, contrasting with the surface.
5. In the instance of Class II dealers who do not display vehicles on the licensed property, or who only conduct business via the internet, that they be required to submit to the Licensing Authority at a minimum a quarterly report of all vehicle transactions, as delineated in the Used Vehicle Inventory Book.
6. Allow licensees to utilize a computer-generated version of the Used Vehicle Inventory Book, so long as it is approved by Mass DOR.

In the area of inspections and enforcement, it is recommended that a physical vehicle count be conducted of all Class I and Class II dealerships at least quarterly. It is further recommended that an inspection of the Used Vehicle Inventory Book of each dealership be conducted at least once per year.

Officer Steven Maher from the Barnstable Police Department went through these proposed regulations. He stated he has read the letters submitted by several dealerships with regard to these regulations. What we are seeking is for those applicants without plans, this would not come into play unless they were in for changes. Any new dealership or owners would need to comply with the plans denoting numbers. On this parking plan, it is asked that it be on site for inspection by BPD. If there is a parking plan, he stated that the marking of spaces is needed. A storage facility only would not need to be delineated. The signs are necessary for the police department to figure out where they are. How can you conduct a business without letting the public know who and what you are – as well as hours of operation for public. One of the letters mentioned internet sales; however, if business is conducted from home, it is a lot easier for them to send quarterly reports – the BPD is looking for number of vehicles they are selling. A letter from a repair facility is only for those without repair allowed on site. Some sites took 10-15 cars and had them out at repair facilities on top of their

regular count of cars. It is hard for the police to look at the used vehicle inventory book and compare if vehicles are out for repair. Officer Maher stated it IS a function of BPD to do this as the State Police have not been doing this regularly, contrary to what someone said in a letter. They have found that just having a total number of vehicles on site has not worked. There has been confusion about including customer vehicles – the cars are held for scrap, etc. The numbers are not working unless specified as to what they are.

Mr. Hoxie stated that all Class I and II dealers will have to indicate hours of operation. Officer Maher stated this is for the consumer and the BPD. Mr. Hoxie asked if a Licensee could utilize more than one repair facility. Officer Maher said that would be fine but they need to list where they have their cars out so the numbers can be checked. It need not be submitted to Licensing but needs to be available on site.

Mr. Scali asked about the hours. He said it particularly pertains to those not on site. The repair facility is supposed to be listed on the Form 53 – it is protection for the consumer as well to know that they are affiliated with a repair facility if the customer has a problem. There are some who still need to come forward with lots or areas not on their current plans to make them current.

Mr. Burman asked if all of the dealers were notified of these proposed changes. Has there been a meeting to discuss this? Mr. Scali stated that all have been invited to this meeting to comment and were also asked to comment in writing if they wished to do so..

Michael Bradley, partner in Huhtanen's, appeared as a 27 year licensee with no complaints. He finds some of the items (3) to be onerous – such as need for a repair facility signing off...Mr. Scali stated this would let the customer know where to go for warranty issues. He stated that this is not true – he stated that he is responsible for the repair; he has to select the repair shop or fix it himself. He stated he uses 1-2 garages. He does not think it is fair to ask a garage to affiliate itself with them. He stated his sign is visible from the road. They have their hours posted in the window already and do not want to take down their sign and re-do it with hours. He understands now after hearing Officer Maher that the other items do not apply to him. He said that his other concerns are addressed in the letter he sent to the Board.

Officer Maher stated if the hours are posted someplace visible to the outside area it would be more than adequate – this licensee does not need to make these changes. Hours posted on the door, etc. will be adequate.

Brad Tracy appeared also – commenting on the amount of vehicles a dealer has, there are a lot of places to put them on the larger lots. He does not understand what this has to do with having more inventory than appears on their lot. He also stated that the record book being available at all times has nothing to do with the Town, it is State law. Right now he does not see a need to mark the spaces either.

Officer Maher stated the Board is now issuing all licenses with a number of vehicles on the property. If storing vehicles outside their licensed premises the Board does have authority over the storage off site if in Town. Once a licensee holds a bill of sale or title, it is their responsibility to include that vehicle in their book and in their vehicle count. Once they take possession of the vehicle it should be on the count.

William Baron appeared for Ziggy's. He said he has spoken to Officer Maher about the lines on the parking lot. He moves the cars around for display. He says he would never have the cars in the lines. He fans them out. Lining in the rear is which is not paved would be very difficult. Officer Maher stated that in regard to the parking plan – it is signed off delineating the parking spaces. If we are accepting these plans – and if the licensee is not sticking to it as signed off, what is the point of having one? BPD is in a dilemma about this. He does not know how to address the issue of when they have less vehicles and want them to look like more.

Mr. Hoxie asked if the plans are all marked out...Officer Maher replied that yes they are. The lot areas not used for display do not need to be marked out. Lots of the dealers have these.

James Goodwin came up to speak about the vehicle display lines being too controlling for merchandising. Inventory is a very fluid thing – at times they are pushing their limits and other times slim on number of vehicles they have. It is the merchandising that is important to make it look full if not full. Every week the look of the lot changes and this is effective. It is a very big deal to the dealers to have to stick to one plan with lines.

Mr. Hoxie asked Officer Maher if there is flexibility in use of the lots for merchandising. Officer Maher stated some of the dealers put the vehicles OUTSIDE the parking plan – but they need to be on their lots. Not on the roadways, not on the grass, etc. When they have less cars it is not a problem to spread them out but when full it is a problem.

Mr. Scali agreed with this assessment. There are also zoning and fire code issues – this must take precedence. However, spreading out if they have less vehicles and not in the lines should be o.k.

Mr. Burman said he sat on the Zoning Board for years. They used to debate parking lots – the natural lots are better – less runoff, etc. He does not think we should have hardtop surface and enforce plans with numbers. Mr. Burman said certainly we can count.

Officer Maher said we are not requiring blacktop. He said #5 could exempt those surfaces from marked lines as long as they adhere to the parking plan.

Mr. Semprini asked about storage at repair shops where repairs are not actually being done? Officer Maher stated they are.

He then asked Mr. Bradley about clarification as to getting a consumer problem resolved – if a stalemate – he would like to have an opportunity to go to the repair shop to see the person actually working on his car. Mr. Bradley said the customer can always go through the Lemon Law process if an issue with a vehicle cannot be resolved. In terms of a repair shop, even if he had one in his garage you would not talk to his mechanic. If you went to a repair shop HE is their customer, not you. If there is a conflict the lemon law process makes demands on the dealers to act in good faith.

Mr. Hoxie asked Officer Maher why it is important for us to know where vehicles are repaired. He stated it is more about where and how many vehicles are being parked off a licensed premise. During inspections this came up. It would help to determine the max count of vehicles. Mr. Scali stated the repair facility is required to be listed on the Form 53 each year. There is flexibility on whether it has to sign off. Mr. Burman asked if it could be out of the Town of Barnstable. Mr. Scali stated it can.

Officer Maher stated there are also licenses which do not ALLOW repair – it is important to know where they have repairs done.

Mr. Tracy also wanted to comment that there are a lot of dealers with potential for more cars – if you take the small dealers

Mr. Nunheimer asked if we are not now requiring hardtop or marking on lines on those, hours of operation visible on premises, not necessarily on the name sign. Also that vehicles not on site not be counted against the total on the license. Officer Maher stated it is.

Mr. Hoxie stated perhaps we should clarify the regulations after this hearing and bring it for vote at the next meeting. Mr. Nunheimer stated that the only safe way to do this is to have another public hearing. Mr. Scali stated it would just have to be continued, not re-advertised.

Renewals:

The following renewals have been submitted without any changes from the previous year for Licensing Authority approval:

Mr. Scali stated The Steakhouse Sports Bar is not open and has tax issues. The Regatta also is not open; they have advised they will be applying for a seasonal license. The Board voted unanimously not to renew the licenses of these two establishments.
