A meeting of the Barnstable Licensing Authority was held on Monday, April 08, 2019. Chairman Martin Hoxie called the meeting to order at 9:30 A.M. He introduced; Ron Semprini, Vice-Chairman, David Nunheimer, Clerk; Larry Decker, Associate Commissioner, Nancy Karlson-Lidman, Associate Commissioner, Richard Scali, Licensing Director; CAO Officer Therese Gallant, Lt. John Murphy and Maggie Flynn, Recording Secretary. David A Hirsch was absent.

Vote to accept Minutes

1. Vote to accept minutes of the 03/18/19 meeting.

A motion was duly made by Mr. Semprini, seconded by Mr. Nunheimer and a unanimous vote taken to accept the minutes of the 03/18/19 meeting.

New Business:

1. Application for a One Day All Alcohol and Entertainment Licenses:

Application of Mary Lyons on behalf of the casual Gourmet for a One day all Alcohol and Entertainment licenses for the Duffy Center Annual Gala. The event is to take place on May 3, 2019 from 5:00 PM to 9:00 PM at the Barnstable Municipal Airport, 480 Barnstable Rd., Hyannis. Entertainment is for a jazz trio.

Sara Grambach appeared on behalf of the application. This is an annual event; tickets are \$195.00. There will be approximately 300 guests. There will be two bars and there is an approved floor plan signed by the Building Commissioner. Thursday morning will have a final walkthrough with Building and Fire. The hours are corrected to 6:00 PM to 9:00 PM.

A motion was duly made by Mr. Semprini, seconded by Mr. Nunheimer and a unanimous vote taken to accept the application as presented.

2. Consent Agenda:

A motion was duly made by Mr. Semprini, seconded by Mr. Nunheimer and a unanimous vote taken to accept the Consent Agenda as printed with the exception of AJ Marks. This license will need to be amended due to a change in location.

Public Hearings:

 Application for a New Annual All Alcohol Common Victualler License and New Non-Live Entertainment License: Application of Blue Moon at 430 Main Street, Inc., d/b/a Blue Moon, 430 Main Street, Hyannis, MA, Aubrey Foster, Manager, for a new All Alcohol Common Victualler License and a new Non-Live Entertainment License.

Premise Description: Building is at street level, consisting of front and rear entrance and exit, interior seating (38 seats), bar seating (6 seats) and patio seating (24 seats) for a total seating capacity of 68 seats. 4 bathrooms (2 staff, 2 customer), basement storage, kitchen area, wash area and total square feet of 1800.

Hours of operation are 10:00 AM to 1:00 AM daily.

Non-Live entertainment includes: recorded music below conversation level and 2 T.V.'s. Non-Live hours are 10:00 AM to 12:45 AM. ******Continued from** 3/18/19****

Aubrey Foster and Attorney Jeffrey Johnson appeared on behalf of this application. The landlords also appeared. This restaurant was not operational last year.

Officer Gallant asked about his plans. Is this going to be a restaurant, yes, not nightlife? She asked if David Adams will be there, not sure yet. In the past there were problems with the numbers, there was smoking both inside and outside. This cannot take place. Mr. Semprini asked about his experience. Have you been in the liquor business before? Not in America. Is three employees enough? There is concern about the back hallway, would you consider cameras? Yes, already on that. Mr. Semprini suggested reading the guidebook. Mr. Scali asked about the plan, under the occupancy there is not standing around the bar. There are no investors, correct as they were going to be investing previously. They asked to open for food only.

A motion was duly made by Mr. Semprini, seconded by Mr. Nunheimer and a unanimous vote taken to accept the application as presented.

2. <u>Application for a New Annual Wine and Malt Common Victualler License:</u> Application of Ronny's Pizza Inc. d/b/a Ronny's Pizza, 11 Ridgewood Ave., Hyannis, Ronaldo Fraga manager for a new Annual Wine and Malt Common Victualler License.

Premise Description: Mortar concrete building with one entrance on the corner of Ridgewood Avenue and two exits; one to the rear and off the kitchen. Premises contain seating for 70 plus 12 at the bar totaling 82 seats and total occupancy of 97. Two bathrooms located in the rear of the dining room. Basement storage area approx. 540 sq. ft., kitchen approx. 600 sq. ft, dining area and bar approx 1200 sq. ft.

All approved by the Building Commissioner on 1/22/19.

Ronald Fraga appeared on behalf of this application.

Mr. Fraga apologized for *Mr.* Christos outburst last time. I am trying to make a living. There are cameras everywhere. We need to try and survive; we need wine and beer. I am there every day. We are closed on Mondays, because no one can do my job in the front. You need to be able to speak both Portuguese and English. I work the front and my wife works in the back.

Mr. Hoxie asked who is in charge if he must leave; my wife. Sunday we open at 3pm. Mr. Hoxie asked that a beer and wine license would easily double his business. I am behind at this time. I am 3 months in arrears in rent, Are your customers asking for beer and wine, yes. Personally, I do not drink. I am there every day, have never had a problem with the police.

Lt. Murphy stated you do not need to apologize for Mr. Christo. This is not personal. For the Board, you were involved with Scotties from Dec16. Can you give the board how much alcohol Scotties was able to sell? \$400-600/ day.

Mr. Hoxie asked is there a public need at this location? Ronny replied that people want a beer and glass of wine with their food. *Mr.* Hoxie asked how his relationship with BPD is. Good as far as I know. I have 2 very close friends in the department.

Lt. Murphy stated it is true that there have been few if any calls to his establishment. Did you say I sit outside your building? No, the cops do in the Chevy Dealership. There is no directed patrol of Ronny's pizza.

Mr. Semprini asked about his painting business as a very successful. Why would you leave the business? I invested money in Scotties and it was losing money. I was in Nantucket, not near my family. All of 2017 he was at Scotties, I was there every day. As being an investor and at the establishment how could you not know what was going on? Nothing happened inside the establishment. I was a single father raising my sons by myself. There is a huge concern at that location. I am there to make a change.

Lt. Murphy has respectfully requested that we go into executive session.

Mr. Hoxie has to declare that this is detrimental to the Town. Attorney Charlie McLaughlin stated there is an exemption to open meeting law. It must relate to charges that have been filed. Lt. Murphy clarified that it has no bearing on a criminal nature to Mr. Fraga.

A recess was requested for 5 minutes at 10:20 AM. We are not going into executive session. 10:38 returned to open session; does not qualify for an executive session.

Nancy Karlson-Lidman asked about 4 employees on the application; who will be handling the beer/wine? Just me responded Mr. Fraga.

Lt. Murphy stated that he does not want to taint Mr. Fraga's reputation but the Board asked him to look into the background of Scottie's Pizza. Mr. Fraga stated that Scottie's is in the past, not in the present. I am open to discuss, anyone can come into the restaurant. The investment I the business is the nexus. Ronlad Fraga was an investor in this business. In December 2016 he worked 40 hours/week as adjunct manager to help support his business/son. In December 2016, the DEA initiated narcotics investigation. The central figure was Alex Fraga.

Mr. Nunheimer asked if there is anything other than his presence in the building that leads him to believe that he was involved. Lt. Murphy commented that there is nothing that indicates that Ronald Fraga sold at his residence or business. However, surveillance of the business in 2017 there were transactions taking place. You were managing the restaurant at that time.

Per Lt. Murphy, during 2017, the investigation centered on several residences and Scottie's; Alex Fraga was involved in drug transactions while he was at Scottie's Pizza. He did receive phone calls. At 45 Murphy Road, Ronald Fraga's residence, 4 kilograms of heroin/fentanyl that was located in a trailer was sold. The US Attorney elected not to charge Ronald Fraga. The cooperation of Ronald Fraga post-arrest, he had no knowledge of drugs in the trailer. He cooperated to the extent that he no knowledge of the drug activity; nor did he participate in any drug activity.

Mr. Semprini commented that he empathizes with him; He stated that he was appointed to this Board to try and make the best decisions for the Town. I have tremendous concern for what is happening in our community. This is based upon public need we do not have to grant them.

Mr. Fraga said that he thinks he will do better but may not. He needs the opportunity to make it work. He is 3 months behind on his rent.

A motion was duly made by Mr. Nunheimer, seconded by Mr. Hoxie and a 2-1 vote taken to accept the application as presented.

3. <u>Application to Amend a Live Entertainment License and Change of Hours</u> on an Annual All Alcohol Common Victualler License: Application of 959 Bearse's Inc. d/b/a Gannon's Tavern, 959 Bearses Way, Hyannis, Michael S. Gannon manager, to amend a live Entertainment License and change of hours. Live Entertainment is to include the previously approved 28 seat outdoor deck. Request is to have 3 performers with 3 pieces.

Entertainment hours are: noon - 12:45 AM; Daily

Change of hours is for an earlier Sunday opening and service time to 10:00AM from 11:30 AM.

Mike Gannon appeared on behalf of this application. This is to formally update the change of hours that have been temporarily approved. The deck is a dining area, not a smoking area. The music is not late night it will be more like 4-7pm and -8 pm. Mr. Scali asked about outdoor entertainment hours, better to narrow down the hours. This will be more of a background type of music. Office r Gallant suggested reaching out to the hotel about noise levels. There is a picket fence as a buffer. The deck is covered with a metal structure. Mr. Scali clarified that it is 3 pieces amplified.

A motion was duly made by Mr. Semprini, seconded by Mr. Nunheimer and a unanimous vote taken to accept the application as presented.

4. <u>Application for a Change of Manager on an Annual All Alcohol Common</u> <u>Victualler License:</u> Application of GMRI Inc. d/b/a The Olive Garden Italian Restaurant #1523, 1095 Iyannough Rd., Hyannis on their Annual All Alcohol Common Victualler Malt License, for a Change of Manager from David M McCaffrey to Jaye M Peura.

Jaye Peura appeared on behalf of the application. Mr. Scali asked about staffing levels, empty tables with lines. Mr. Nunheimer recused himself form this application.

A motion was duly made by Mr. Semprini, seconded by Mr. Decker and a unanimous vote taken to accept the application as presented.
