A motion was duly made by Mr. Semprini seconded by Mr. Nunheimer and a unanimous vote taken to accept the minutes of the 06/10/19 meeting.

New Business:

 Application for a One Day Entertainment and One Day Beer and Wine Licenses: Application of Bob Bourque on behalf of the Hyannis Rotary Club for a One Day Entertainment and One Day Beer and Wine Licenses for the Quahog Fest 2019. The event is to take place on the Hyannis Village Green, 367 Main Street, Hyannis on August 25, 2019 from 10:00 AM to 5:00 PM. Entertainment is for 3 performers with 3 pieces.

Bob Bourque appeared on behalf of the application. They will be fencing the entire grass area. We also added wine this year; First Crush Wine. Mr. Semprini asked about the local restaurants being invited; Elizabeth Wurfbain and Bob Bourque reached out to many Main St. restaurants. They can also be sponsors.
