A meeting of the Barnstable Licensing Authority was held on Monday, December 9, 2019. Chairman Martin Hoxie called the meeting to order at 9:30 A.M. He introduced; Ron Semprini, Vice-Chairman, David Nunheimer, Clerk, Larry Decker, Associate Commissioner, Nancy Karlson-Lidman, Associate Commissioner, Richard Scali, Licensing Director; Officer Therese Gallant; Lt. John Murphy and Maggie Flynn. David Hirsch was absent.

Vote to accept Minutes:

1. Vote to accept minutes of the 11/04/19 meeting.

A motion was duly made by Mr. Nunheimer, seconded by Mr. Semprini and a unanimous vote taken to accept the minutes of the 11/04/19 meeting.

New Business:

1. Application for (3) One Day Wine Only Alcohol Licenses: Application of Linda Mawhinney and John McGinn on behalf of Cape Arts and Entertainment for (3) One Day Wine only licenses for the Cape Cod Symphony events. These events, New Year's Day Concert, The Tony's Concert and Sinatra Concert will all be held at the Barnstable Performing Arts Center, 744 West Main St., Hyannis on 1/1/2020 from 2:00-5:00 PM. The Tony's Concert is on 2/22 from 2:00 - 9:00 PM and 2/23/2020 from 2:00-5:00 PM. The Sinatra Concert is scheduled for 6/13/2020 from 2:00 PM - 9:00 PM and 6/14/2020 from 2:00 - 5:00 PM. Entertainment licenses have previously been applied for and granted.

Linda Mawhinney appeared on behalf of the application. We are only discussing the January 1st event and tabling the other two.

Mr. Scali stated that this is a pilot program only. There have been a number of discussions regarding this pilot program, Conditions have been set and a walkthrough has been conducted. The issue is where the alcohol is being served and capacity numbers. Alcohol only allowed in cafeteria, police details, checking of ID's will be done through the Caterer. This is a Vienna café with pastries and coffee. There will be a champagne toast. There is no intermission. This is only a short amount of time. The remaining two events will be reviewed at a later date. Officer Gallant commented that we are comfortable with the process. There will also be a second walkthrough.

Mr. Semprini asked about the conditions and liability. Also how far is the café from the event hall? It is a decent walk down the corridor. Only signage states Vienna Café, no marketing has been done.

The legal department and school board have approved.

A motion was duly made by Mr. Nunheimer, seconded by Mr. Semprini and a unanimous vote taken to accept the application with the following condition; one day only New Year's Day Concert.

2. Consent Agenda:

A motion was duly made by Mr. Nunheimer, seconded by Mr. Semprini and a unanimous vote taken to accept the Consent agenda as presented except for two Licensees: Balise Hyundai and Missako Bakery.

Balise Hyundai requires a new application for a new location. Missako Bakery requires a completed lease agreement and new sign.

Public Hearings:

*** Ashley Manor Lodging House Application: Attorney Kate Mitchell represented Ashley Manor for a new Annual Lodging House Application. All paperwork was submitted properly and abutters were notified. The application was inadvertently left off the posted Agenda. The Licensing authority agreed to hear the application and not vote formally until proper posting on the 12/23/19 Licensing Authority Agenda. Alison Mackey is the new owner. They will be attending the Zoning Board of Appeals on 12/11/19 to obtain a special permit for a 6 bedroom/12 lodger Lodging House. Nothing else has changed. Mr. Scali asked about past experience. They are previous employees of Lodging Houses and also significant hospitality experience.

1. <u>Application for a New Live Entertainment License:</u> Application of William Sturgis Friends of Education Foundation Inc. d/b/a Sturgis Charter Public School, 529 Main St, Hyannis for a new Live Entertainment license. Entertainment is to include, Dancing, Live Music, Stage Shows and Live Theater. Entertainment Hours are 10:00 AM to 11:00 PM; Daily.

Mary Lincoln is the events coordinator and appeared on behalf of the application. This is the former Wings building. This is now owned by Sturgis. There are 2 floorplans on file. The capacity is up to 500. This will be good for Main Street but conditions will be needed. Admission is not charged. Mr. Decker brought up issue about noise; this will be inside 529 Main Street. Ms. Karlson-Lidman asked about the parking issues, planning Board approved use and parking exemptions. This is to build community relations; we are a non-profit. It will be a case by case situation.

A motion was duly made by Mr. Nunheimer, seconded by Mr. Semprini and a unanimous vote taken to accept the application as presented.

2. <u>Application for New Officers/Directors and Transfer of Stock on An Annual All Alcohol Common Victualler License:</u> Application of 99 Restaurants of Boston LLC, d/b/a 99 Restaurant and Pub1600 Falmouth Rd., Centerville, MA, Thomas Hamm, Manager, for a change in corporate Officers/Directors and stock interest.

Mr. Scali updated the Board that the ABCC has already approved the necessary paperwork as this change is statewide. No appearance required.

A motion was duly made by Mr. Nunheimer, seconded by Mr. Semprini and a unanimous vote taken to accept the application as presented.

3. <u>Application for a Change of LLC Managers on an All Alcohol Common Victualler License:</u> Application of Chipotle Mexican Grill of Colorado, LLC, d/b/a Chipotle Mexican Grill, 793 Iyannough Rd., Hyannis, MA, Jelani Allen, Manager, for a change in LLC Managers.

No appearance required; just ABCC paperwork.

A motion was duly made by Mr. Nunheimer, seconded by Mr. Semprini and a unanimous vote taken to accept the application as presented.

Show Cause Hearings:

The Barnstable Licensing Authority will hold Show Cause Hearings for the following establishments violating the following: Section 502-I sections R & T (Violation of MGL c138 s34) of the Town of Barnstable, Massachusetts Code: Alcoholic Beverages Sales and Laws - sale or delivery of an alcoholic beverage to a person under 21 years of age

Officer Gallant reviewed the underage compliance checks procedure. Both Male and female decoys were utilized.

Officer Gallant DRAFT Proposal: Based upon last year's annual voluntary meetings we proposed seeking out different types of penalties on these types of violations (First time offenders). Suggesting a workshop with the Board for options: chatable donation to local charity event, hosting of TIP service trainingas opposed to a one day suspension. This is for first time offenders, basic policy, very simple.

 Aztec City LLC d/b/a Ristorante Milanese, Maria N Calle, Manager, 302 Main St., Hyannis Annual All Alcohol Common Victualler License; October 12, 2019 Female decoy was served, never asked for ID. The person working at the bar was not TIP certified. There is a previous violation on record from November, 2019.

Jorge Siguencia appeared on behalf of the restaurant. The restaurant was under contract, employees were scarce. He commented that he does attend all the meetings. Tumi was very busy. The individual at the bar was from Tumi. Mr. Scali asked if employees have been retrained; yes. Very difficult to hire new employees with a pending sale.

After testimony from Consumer Affairs Officer Therese Gallant, the following motions were voted by the Licensing Authority:
