## FY25 Grant Awad Process (discussion)

The MCCC received two reconsideration requests. One was approved by Mass Cultural, the other is TBD. Mass Cultural Also asked us to review several other grants to be sure they aligned with our goal of not funding the **same project** for more than 3 **consecutive** years.

Margeaux reviewed the State process we need to follow during reconsideration. A lengthy discussion ensued.

Projects reviewed -

93307 – Cape Cod Verdean Museum (the group requesting reconsideration)

91868 – Mary Wilson

85573 - Cordial Eye

10374 - Arts & Justice Collective

92137 – Recovery Program (Mass Cultural has yet to determine if the group has grounds for reconsideration)

A reminder – All projects that scored higher than 4.05 were approved or funding in full (or up to \$1,500)

Project 93307 – All agreed it is a worthy project but funding outside our jurisdiction of Barnstable/Yarmouth is not possible with so many local applications for funding. Their ranking was not changed.

Project 91868 – Each year has been a different project so is following our funding guidelines.

Project 85573 – This is the third year of funding for this project. They will be advised that funding for this project will not be available in FY26. May still apply for funding of different project.

Project 10374 – This is only the second year the A&J Collective has applied for funding so is following our guidelines,

Project 92137 - TBD

Further discussion of the need for outreach to more local artists of all types, help with grant writing, and looking for new members to diversify our ranks.
