Park Square Professional Building LLC 94 Main Street & 26 Camp Street, Hyannis, MA

A letter dated February 23, 2015 from Evangelos G. Geraniotis, as a Manager of Park Square Professional Building LLC, has requested the release of \$6,200.00 escrow surety being held by the Town of Barnstable as a condition of Special Permit No. 2008-002.
