## Approval Not Required Plans:

A plan entitled "Draft Plan of Land in Barnstable (Osterville) Massachusetts", dated September 14, 2016, prepared for: 1340 Main Street Osterville LLC. The petitioner has submitted for endorsement an Approval Not Required Plan (ANR). The plan proposes to divide map 119 parcel 079 into three new lots (Lot 1, 2, and 3) - Staff Report, plan, application and associated documents enclosed

Attorney Albert Schultz (for Attorney Michael Schultz) in attendance for the Applicant. He gives a brief explanation of the proposed ANR application, agrees with and makes reference to the Staff Report, Exhibit A.

Motion made by Paul Curley to endorse/approve this ANR, seconded by Mark Ferro, so voted unanimously.

Greystar GP II, LLC has submitted a plan entitled "Approval Not Required Plan of Land at Communication Way", dated September 14, 2016 for endorsement an Approval Not Required Plan (ANR). The plan proposes to divide Map 314, Parcels 036-038 and 044-049 and Map 315, Parcel 042 (10 parcels) into three new parcels (parcel 1 of 406,312 square feet, parcel 2 of 133,932 square feet, and parcel 3 of 535,242 square feet). The subject properties are addressed 0, 125, 145, 160, 175, 180, 191, 200, 225, 265 Communication Way, Barnstable, MA.

Edward Pesce of Pesce Engineering in attendance, representing the Applicant/owner, Lyndon Paul Lorusso Charitable Foundation of 2002. He agrees and makes reference to the Staff Report, Exhibit B. This will be for the Senior Active Adult Complex project.

David Munsell comments that he approves.

Ed Pesce states that they have approval from Site Plan Review and they are now pending approval from the Cape Cod Commission sub committee and Town Council.

Ray Lang confirms the phases of the project.

Motion made by Paul Curley to endorse/approve this ANR plan as presented, seconded by Mark Ferro, so voted unanimously.

Special Permit Application No. 2016-02 - David Colombo, 159 Ocean Street, Hyannis, Black Cat Harbor Shack Map/Par 326/039 - Proposal for: New roof deck, stairs and vertical lift located within front yard setback and reduction of required parking for an additional 23 seats. *Continued from May 23, 2016*.

Motion entertained by Chair Ray Lang, moved by Mark Ferro, seconded by Paul Curley to continue this hearing to December 12, 2016.
