#### Scenic Roads:

<u>2019-01 – Scenic Roads Application</u> – Route 149, adjacent to rear of 2150 and 2160 Main Street, Marstons Mills MA. Application by the Town of Barnstable Department of Public Works c/o Andrew Bernier, Town of Barnstable Tree Warden, to remove trees along Route 149 in Marstons Mills Village Center in association with the streetscape and place making project managed by the Department of Public Works. This project proposes to remove up to 15 trees within the road right-of-way.
