## Sandy Neck Board Meeting December 12, 2011

A regularly scheduled meeting of the Sandy Neck Board was held on December 12, 2011 at the Barnstable Town Hall, Selectmen's Conference Room, 367 Main Street, Hyannis, MA. The meeting was called to order at 7:36 pm by Chairman Rich French.

## **Staff Report:**

## Nina Coleman addressed the Board:

- The gatehouse is open by appointment only.
- The 2011 Sandy Neck Deer for archery was held from November 21 26 and three deer were taken, (two bucks and one doe). The primitive firearms deer hunt started today and as of 2 pm, one doe was taken. A total of twelve (12) is allowed. All 60 hunters that came to the primitive firearms meeting will be allowed to hunt. There will be 20 each day. New this year, pairing will be allowed. Teams can go out together. Many people liked the idea and she has heard positive feedback.
- Cottage colony removed fencing with the help of AmeriCorp.
- Budget two main requests for additional staff. The first request is for "senior" employee positions. These positions will be for those people that come back year after year and are already trained. ORV use has risen 40% for the last 8 years but staff has not increased to match the usage. Plus, the pay rate has remained the same since 2004. These positions are seasonally only. The second request is for a maintenance/groundskeeper position. This person would be responsible for the grounds around the bathhouse, trash removal, restrooms, portable toilet, among other duties.


## Sandy Neck Parking Numbers Report

Re: Proposed FY 2012 Sandy Neck Fee Changes

I wanted to provide you with formal comments from the Town of Sandwich on the proposed FY2012 Sandy Neck Fee Changes to be discussed at your upcoming fee hearing on December 6, 2011. Specifically, I wanted to express the Town's strong opposition to the proposed new \$50.00 annual "Sandwich Parking Permit."

As you know, the Town of Sandwich makes annual payments to the Town of Barnstable to allow Sandwich residents to enter Sandy Neck Beach Park. In the current fiscal year, this totals \$40,590.00, an amount which increases by 2.5% annually.

It is our understanding that the Town of Barnstable is considering a new \$50.00 "Sandwich Parking Permit" to replace the current annual payment from the Town of Sandwich to generate an *additional* \$22,756.00 to cover Sandwich's "share" of the recent capital improvements at Sandy Neck Park, i.e., the new bathhouse and paved walkways. It is also our understanding that the Sandy Neck Board would like the Town of Sandwich to purchase a total of \$64,360.00 of "Sandwich Parking Permits" from the Town of Barnstable up-front and assume the risk of later re-selling and recouping the associated costs from Sandwich residents.

The Town of Sandwich strongly opposes this proposal for the following reasons:

- 1. The Town of Sandwich does not formally own any portion of the new bathhouse or paved walkways, yet we are being asked to pay for "our share" of these structures.
- 2. We believe the revenue derived from the Town of Barnstable's food and beverage vendor management agreement(s) at the Sandy Neck bathhouse should be reflected in the fee proposal. Specifically, we believe that some portion of the revenue should offset some portion of "our share" of the cost of the building, which houses the food and beverage operation.
- 3. The Town of Sandwich was not asked to participate in the building committee for the new bathhouse. Accordingly, we do not know if a differently designed, lower cost building could, or should, have been constructed.
- In FY06, both towns agreed to a new payment structure which more than doubled Sandwich's payments to Barnstable. Capital improvements were not part of this agreement or discussion.
- 5. In addition to paying the Town of Barnstable over \$40,000 annually, at an amount automatically increasing by 2.5% per year, the Town of Sandwich also maintains at 100% Town of Sandwich expense Sandy Neck Road leading into Sandy Neck Park. Our Department of Public Works estimates this costs the Town of Sandwich over \$24,000 per year, on average. This includes snow and ice removal, street sweeping, catch basin cleaning, paving, striping, mowing & brushing, and litter pickup. At a minimum, we believe any request by the Town of Barnstable for additional fees from the Town of Sandwich should be offset by some or all of these substantial costs the Town of Sandwich incurs on an annual basis, as they are directly related to the traffic entering Sandy Neck Park.
- 6. The Town of Sandwich is concerned that this proposal is being proposed and considered at the last minute, and that we do not have sufficient time to fully consider all of its aspects. For example:

- The Town of Sandwich would like to see substantially more detailed data about actual Sandwich resident usage at Sandy Neck Park.
- We are unclear if the proposed \$64,360.00 annual cost to the Town of Sandwich will go up by 2.5% per year. What will happen to the debt amount allocated to the Town of Sandwich when the debt is fully paid off?
   Will our cost allocation decrease accordingly?

 Compared to the status quo, will Sandwich residents receive any additional benefits or services in return for the substantial additional funding being requested? For example, will any physical parking spaces be reserved for the "Sandwich Parking Permits" sold?

If the Town of Sandwich does ultimately agree to an additional amount – net of a reasonable share of food and beverage bathhouse revenues and our DPW expense for maintaining Sandy Neck Road – we would like to discuss payment mechanisms other than the Town of Sandwich purchasing stickers up-front from the Town of Barnstable and assuming all the risk for recovering our costs after the fact. For example, we believe other viable options should also be discussed, such as the Town of Sandwich increasing our own beach sticker, through the Sandwich Board of Selectmen fee hearing process, with a higher annual amount paid to the Town of Barnstable quarterly, to more closely match the cash flow of our beach sticker sales.
