## **Sandy Neck Board Meeting**

### February 14, 2011

A regularly scheduled meeting of the Sandy Neck Board was held on February 14, 2011 at the Barnstable Town Hall, Selectmen's Conference Room, 367 Main Street, Hyannis, MA. The meeting was called to order at 7:32 pm by Chairman Rich French.

### **Act on Minutes:**

## **Staff Report:**


## Nina Coleman addressed the Board:

- A few storms since last meeting but no major problems.
- The gatehouse is presently closed. Staff is available for the sales of ORV permits by appointment only. Current permits [2010] are valid until April 15, 2011. New [2011] applications will be mailed the first week of March. The gatehouse will re-open for the season on April 1<sup>st</sup>.
- Regarding the Sandy Neck Rules and Regulations (that were discussed and approved by the Board) – there will be a public hearing on February 25<sup>th</sup> at 10:30am. The color for resident stickers is black this year with red writing. And therefore, black t-shirt.
- This winter there was one expired dolphin and two expired porpoises on the beach, which is very common this time of year. Too early to predict plover activity for this summer.

# Bathhouse Update
