# Sandy Neck Board Meeting November 17, 2014

A regularly scheduled meeting of the Sandy Neck Board was held on November 17, 2014 at the Selectmen's Conference Room, 367 Main Street, Hyannis, MA. The meeting was called to order at 7:30 pm by Chairman Rich French.

#### **Staff Report:**

### Nina Coleman addressed the Board:

- The Gatehouse hours are Friday, Saturday and Sunday from 9:00 am to 4:00pm or call for an appointment.
- This is still pheasant season until the Saturday after Thanksgiving. There is no hunting allowed on the front beach and there is no hunting allowed on Sundays.
- No incidents to report since the last meeting.
- There have been two snowy owls sited at Sandy Neck. Too early to tell if it will be another "banner year".
- No Ridley Sea Turtle strandings on Sandy Neck this year but staff is on high alert. If you see a turtle on any town beach you can call MEA/Natural Resources (508-790-6272) or Animal Control (508-790-6274) or the gatehouse (508-362-6300). Leave a message staff is on duty during the weekends. The turtles are usually found after a high wind storm in the rack line/seaweed. Mark the area so they can find the animal. But do not move it. They must be handled carefully and rehabilitated by the professionals.
- Staff rescued a loon that was tangled in fishing gear.
- Staff is looking into being able to accept credit cards especially for the sale of merchandise. Check out the website merchandise is on sale!

#### **Old Business:**

### Update on dune nourishment project:

Nina Coleman reviewed the dune nourishment project. There have been two storms (so far this year). Both with high winds out of the north.



This picture is from October 22<sup>nd</sup>. On the left of the picture is the high dune with a conduit of water to the right. Water is coming in the swale and sending water to the tow of the dune. (We did not lose handicapped ramp).



This picture is from November  $2^{nd}$  looking east You can see at the tow of the dune shows the conduit. The material in front – up to the grass – is the "sacrificial sand." There is about 1/3 of the sand left from what was placed there last year.

This picture is from the parking lot looking down at the beach. The left shows the natural grass line with a cracking on the top. For integrity reasons, this area is "coned off" so no vehicles can park there.



The percentage of sand that was lost in the past year is shown in detail on attachment #1 at the end of these minutes entitled **Sandy Neck Parking Lot Dune Monitoring.** The upper lot has lost the highest amount of sand which is where the septic system in located.

Money was taken from the Sandy Neck operating budget to work on this project immediately. If the project funds are approved by Town Council on November 20<sup>th</sup>, 2014, the money will be replaced with money from the Sandy Neck surplus funds. The bid was awarded to *Robert B. Our*, *Co.* who will place 4,000 cubic yards of sand back on the beach at a cost of \$86,000.

Phase II of this project will be a more permanent "softscape" solutions such as sand bags that could last 5 to 7 years. The design and permitting for this project was awarded to CLE Engineering, Inc., for approximately \$30,000. Construction of Phase II could cost as much as \$400,000 and will be awarded to a company via an RFP process. At some point, CLE could come to a Sandy Neck Board meeting to discuss the project and present different "softscape" erosion control applications. Sampou asked if it would be possible to "fill in" the low swale area with stone in order to reduce the wave action to the dune.

Last month Rich French wrote a letter to CPC asking to be placed on the next agenda so he could formally request \$200,000 from CPC for Sandy Neck. However the request must go through the Town Manager first. That was done and now he is waiting from more information.

Also, Nina Coleman has also applied for CZM grant money. She has also looked into Biomimicry.

Please note: sand can only be replaced in the fall. Money could be secured earlier as a line item [\$100,000] but nothing can be done until the fall because of plover nesting issues. But next year, we will be into the big Phase II project.

#### **Old Business:**

**ConComm annual report** – The entire report is attachment #2 at the end of these minutes. Some highlights:

- ➤ In 2014 plovers did better.
- Diamondback Terrapin Turtles numbers increased again this year.
- Because of the beautiful weather, revenue is up this year. Dune fees are up again this year. More ORV permits were sold, too. Number of day trippers increased a lot of vehicles on the beach.
- > The use of the beach has doubled over the past few years and one more seasonal is needed for next year.

**Parking lot information** – The entire report is attachment #3 at the end of these minutes. Some highlights:

- Number of Barnstable and Sandwich parking totals has increased. The number of daily trip to the Bodfish Public beach for Barnstable v. Sandwich sticker holders is about the same all season.
- Last year, Sandy Neck got \$58,965 from Barnstable Sticker Sales and \$42,654 from the Town of Sandwich.
- ➤ Daily hang tags sold (\$15/\$20) increased in number to over \$7,000.

The Bodfish Beach (public beach) closes at 3:30 pm which is in line with all the other Town Beaches. There was a question as to whether or not Sandy Neck Beach Park could collect money/stay open longer since Sandy Neck is unique and has more to offer than other Town Beaches.

#### NOTE:

A new subcommittee was formed to look into new revenue options. Tom O'Neill and Lynne Heslinga will look into this and report back to the Board in March or April. They will work with Nina Coleman and she will ask Mark Milne for more information if needed.

### **New Business:**

#### 2015 meeting dates

These dates will be voted on next month.

#### **Public Comment:**

• Wendy Paquette asked why this ConComm information was not provided sooner – prior to the fee discussion. She noted that day tripper use increased and again questioned why their rates increase this year.


#### Adjournment:
