Shellfish Committee Minutes of the Meeting

Stuart Rapp chaired the August 16, 2017 meeting of the Shellfish Committee. Stuart Rapp took a roll call of members present at the meeting. Stuart Rapp read a notice at the beginning of the meeting: NOTICE OF RECORDING "Please note that tonight's meeting is recorded and broadcast on Channel 18 and, in accordance with MGL Chapter 30A, s. 20, I must inquire whether anyone is taping this meeting and to please make their presence known."

1.) Meeting Minutes:

The Shellfish Committee voted unanimously to approve a motion made by Linda Romano seconded by William Shumway to approve the minutes from the April 19, 2017 and July 19, 2017 meetings.

2.) Chairman's Comments:

Area around Cotuit Town Dock, Coordwood Landing and Little River Road beach. There is a lot of beach erosion in these area.

3.) NR Propagation Report:

Tom Marcotti reported that there is a new update on the Shellfish Ratings in the Three Bay Areas that will be submitted to Conservation Commission.

Liz Lewis reported on the upcoming Classes. Three are scheduled in July and August open to all. July 26, 2017; August 13, 2017, and August 16, 2017 all at Bridge Street.

Amy Croteau reported on Shellfish Licenses Sold to Date: 1985 Resident, 175 Non-Resident and 39 Seasonal licenses which is in line with what was sold last year.

5.) New Business

A. Jan T. Barr, Trustee, Jan T. Barr 2010 Revocable Trust. Construct and maintain path, boardwalk, ramp and float for the use of non-motorized craft in the Centerville River at 0 Long Beach Rd., Osterville as shown on Assessor's Map 185 Parcel 047.

Hearing has been heard, no vote taken.

B. Sarah Turano-Flores, Esq., Nutter McClennen & Fish LLP Elevated boardwalk, dock, ramp and float is proposed to be installed over saltmarsh located between coastal bank 30 Gardiner Lane and water's edge of East Bay. Proposed structure would extend over two separate properties and would be shared by both owners. Existing boardwalk, dock, ramp and float at 110 East Bay Rd., would be removed. Project also includes 43,100 sf of restoration planting and invasive removal at 30 Gardiner Ln. and 110 East Bay Rd. Restoration entails saltmarsh enhancement mitigation using core marsh pillows, wetland mitigation, coastal bank mitigation and native woodland understory mitigation. Planting to include 250 native shrubs, 14 trees and seeding. Project locations are: 110 East Bay Rd., Osterville as shown on Assessor's Map 141 Parcel 123-001, and 30 Gardiner Ln., Osterville as shown on Assessor's Map 141 Parcel 123-002.

After much discussion. The Shellfish Committee voted unanimously to approve a motion made by Linda Romano seconded by William Shumway to have Stuart Rapp submit a letter to the Conservation Commission to address the Shellfish Committee concerns about the use herbicide on this project and put a restriction on the use and the removal of vegetation due to the effect it will have on the habitat of the shellfish.

C. Jennifer R. & Edmund F. Murphy. To replace existing 3 ft. wide pier with 4 ft. wide pier, rotate ell 4 ft., reconfigure tie off piles and add ramp and float at 656 Sea View Avenue, Osterville, MA as shown on Assessor's Map 114 Parcel 15 002.

The Shellfish Committee decided to not act on this application.
