Stuart Rapp chaired the August 15, 2018 meeting of the Shellfish Committee which was called to order at 7:32 pm as a quorum was achieved. Stuart Rapp took a roll call of members present at the meeting. Stuart Rapp read a notice at the beginning of the meeting:

- 1. Meeting Minutes: Motion was made by Caruso to approve both the May 16, 2018 and the June 20, 2018 meeting minutes; seconded by Shumway and all present voted in favor. Since the July 18, 2018 was informational only, they were not included.
- 2. Chairman's Comments: None
- 3. NR Propagation Report: Tom Marcotti stated that the shellfish team deserves accolades for all their hard work. Liz Lewis, the Shellfish Technician, and the seasonal staff work very hard to grow the product for permit holders to enjoy. Seasonal staff includes Lisa, Kendal and Emily. These women work very hard and do a wonderful job for the Town. The next Shellfish Class will be held on Sunday, August 19, 2018 at Bridge Street in Osterville. The classes have been very successful with large numbers in attendance. In coordination with BARS (The Barnstable Association for Recreational Shellfishing), there will be more rakes available for the upcoming clamming class. Through a coordination of volunteers, the home grown shellfish which is of size, has been raked and moved to the recreational shellfish areas. Surprenant asked if the shellfish was from out of town relays? Marcotti replied thanks to Lewis' efforts, the shellfish is all homegrown. Out of town relays, when you don't have a lot of labor, are a good option. Lewis started to say she didn't like the out of Town relay and pushed for the homegrown shellfish, that is what we are reaping the bounty from now.

Next month Natural Resource Officer Amy Croteau will review Town of Barnstable Shellfishing rules and regulations for potential changes and for review of changes which have already been approved. Marcotti will send to the committee for review prior to the meeting. Final approval will be in October to have the final changes ready for a Town Manager's public hearing before the end of the year. Caruso asked a question about what time is used for sunrise in the regulations? Is it local or Boston time? There is a six minute difference.

Project: Proposed float reconfiguration, existing rock revetment, concrete ramp & shellfish floating nursery system (FLUPSY). This is an after the fact notice of intent. The only thing

Property: 345 Baxters Neck Road, Marstons Mills

Project: Proposed repair /replacement of approximately 172 LF of bulkhead
