Map 117, Parcel 084
Zoning: BA, AP/GP Overlay

Proposal: Demolish existing building per plan and reconstruct at rear of property. Since the proposed new building covers 55% of the lot in the GP Overlay District, the applicant is proposing to install pervious pavement to reduce the overall lot coverage from 74% to 72% (a reduction of 256 s.f.)
Relief from the Zoning Board of Appeals will be required.

SPR 086-18 Centerville Convenience Center
1617 Falmouth Road, Centerville
Map 209, Parcel 085
Zoning: HO, AP & SEP Overlay

Proposal: Construction of a proposed 5,000 s.f. +/- retail building and new gas pumps. The retail building will consist of a convenience store and donut/coffee area with 10 seats. Site improvements will include new parking for 30 vehicles, improvement of vehicular circulation through the site and entrance reconfiguration onto Route 28. There will be improvements to landscaping, drainage and storm water management, modification to existing utilities, and lighting. This is a revised layout of SPR 066-17 previously approved.
Relief from the Zoning Board of Appeals will be required.

For your information the section of the M.G.L. that pertains to postings of meetings is as follows: Except in an emergency, in addition to any notice otherwise required by law, a public body shall post notice of every meeting at least 48 hours prior to such meeting, excluding Saturdays, Sundays and legal holidays. In an emergency, a public body shall post notice as soon as reasonably possible prior to such meeting. Notice shall be printed in a legible, easily understandable format and shall contain: the date, time and place of such meeting and a listing of topics that the chair reasonably anticipates will be discussed at the meeting. Meetings of a local public body, notice shall be filed with the municipal clerk, and posted in a manner conspicuously visible to the public at all hours in or on the municipal building in which the clerk's office is located.
