

### Town Council Meeting February 27, 2020



quorum being duly present, President Paul Hebert called the February 27, 2020, Town Council meeting to order at 7:00 p.m. in the James H. Crocker, Jr. Hearing Room of Town Hall, 367 Main St., Hyannis, MA.

An announcement was made by President Hebert regarding the meeting being televised live and questioning if anyone was actively taping the session to please make their presence known. This session is recorded and broadcast on Channel 18.

The Pledge of Allegiance was led by President Hebert; and it was followed with a moment of silence.

#### PUBLIC COMMENT:

Karla Cabral from Sustainable Practices urged Council to join the plastic bottle ban. She noted there were eleven municipalities which had already joined the plastic bottle ban.

Suzanna Nickerson, who is the Chatham Sustainable Practices liaison, hoped Council would join the plastic bottle ban. She felt the ban would help protect Cape Cod against the ill effects from plastic bottles.

Mary Cote, filer for the municipal plastic bottle ban in Yarmouth wanted a united Cape Cod against the plastic bottles.

Anne Rowland spoke about the inequality of younger generations to afford homes in Barnstable. She felt that with the lack of affordable housing is affected by lack of new businesses and the high price of a new sewer system.

Juliet Farrell felt there was a big difference between commercial ownership and private ownership in relationship to short-term rentals. She felt some of the draft regulations were vague and could lead to confusion.

Bob Warren questioned if the draft short-term regulations held the Town as well as the owner responsible for issues at the short-term rentals.

Deborah Krau felt there was not enough data regarding the short-term rentals. She inquired if there would be a database of the rentals and urged Council to take one year to understand review data then decide on the appropriate regulations.

James Fralee spoke about the need to keep short-term rentals. He suggested possibly limiting the numbers of home owners that can rent. He explained short-term rentals allowed for residents to live in Barnstable as it was a second income.

Chuck Sabatt suggested the penalties were good but there needed to be significant fees for infractions with the short-term rentals. He added there needed to be specific noise ordinances in the draft resolution.

Jeremy Hegarty believes everyone wants what is best for the community regarding the short-term rentals. He felt the short-term rentals allowed residents to live in town as it is a second income to help fray the costs. He noted the short-term rentals created jobs which helped the Town.

Matthew Teague urged Council to find the statistics regarding short-term rentals. He felt there was a good history with the rentals and it helped build the community. He hoped the Town would take their time review all the data and make the right decisions.

John Crow read out loud the letter from David Sorenson regarding the sewer expansion project. He hoped the Town would review all the options on short-term rentals and urged them to listen to the village civic associations.

Matthew MacNeely felt any housing regulations should apply to all properties. Please do not place the burden on the short-term rentals.

Brian Covell asked Council to review the impact of properties which have short-term rentals near them.

Peter Hanson questioned the lack of data and wondered how draft regulations could be proposed without the data.

Kelly Summers supported the draft regulations regarding short-term rentals. She suggested a possible 7 day minimum stay.

Tyler Murphy urged Council to find a better solution than the draft regulations for short-term rentals.

Kathy Holcombe felt this was a short-term rentals were a zoning issue. She said she supported the Cape tradition of private ownership of short-term rentals.

Alan Lagoruim explained his family had ownership of the short-term rentals and never had any issue. They utilized local realtors and screening of potential rentals.

Bonnie Bridges echoed the earlier sediment regarding the plastic bottle ban.

### COUNCIL RESPONSE TO PUBLIC COMMENT:

Thank you for expressing your opinions here tonight as the future workshop regarding the short-term rentals will not have public comment. The regulations from the civic associations were very restrictive. It is great that short-term rentals can afford younger generations to stay here in Barnstable. Thank you for the information regarding the plastic

bottle ban. Barnstable County has 20-year low interest loans to help the owner with the cost of connecting to the septic system. The housing issue is a problem please look into the accessory units by right.

### TOWN MANAGER COMMUNICATIONS:

Coronavirus is a very serious issue. We are communicating with the Public Health Department. Public health and safety are very important to keep the residents safe.

Mark Ells gave an overview of the PowerPoint Presentation. He discussed the future water supply and the 4 water departments. He noted the Town would look at the option to partner with other water systems as this water supply issue was a multi-stage process.

Dan Santos, Public Works Director, updated the Council on the Comprehensive Waste Water Management Plan. He mentioned the draft plan had been sent to Massachusetts Environmental Protection Agency (MEPA). He added they were continuing to have outreach within the community.

Zenas Crocker discussed the need for alternatives to the septic systems. He noted there would be a workshop at a later date. He spoke about the need for a study.

### Councilor questions and comments:

Interested in the Joint Base Cape Cod is there an update? [A planning group is looking at this in Washington DC] Please make sure to reach out to the community with the conceptual design.

## Council Workshop on Short Term Rental DRAFT Regulations (Discussion Only)

The committee consists of Brian Florence, Building Commissioner, Elizabeth Jenkins, Planning and Development Director, Karen Nober, Town Attorney and Andrew Clyburn, Assistant Town Manager. Councilor Schnepp noted there would be no votes or motions

tonight regarding the short-term rental draft regulations. Andy Clyburn discussed the history of short-term rentals in Barnstable. He spoke about the terminology of short-term rentals. He clarified that anything less than 2 months was considered short-term. He said the committee had reached out to every civic association. He said the main take away from the associations were the need to deliberate measured data and the need to not rush the process. He added the Town needs to regulate the short-term rentals. Elizabeth Jenkins spoke about the general ordinance which would license and regulate all short-term rentals. She noted there needed to be zoning clarification. Brian Florence said there need to be regulations regarding inspections and smoke detectors. He inquired about the process for complaints.

### **Councilor questions and comments:**

Liked the idea of a policy consideration with a cap on licenses per owner. Please utilize Global Information Systems (GIS) database for all short-term rentals. We need to make sure all rentals laws are the same across the board. Please spell out noise laws, ordinances and sign ordinances.

Zoning is important as it outlines what a municipality should look like. Main theme from all discussions is the need to not rush the process and get it right.
