

## Town Council Meeting September 17, 2020



The September 17, 2020 meeting of the Barnstable Town Council was physically closed to the public to avoid group congregation.

A quorum being duly present, President Paul Hebert called the September 17, 2020 Town Council meeting to order at 7:06 p.m. from a remote location.

An announcement was made by President Hebert regarding the meeting being televised live and questioning if anyone was actively taping the session to please make their presence known. This session is recorded and broadcast on Channel 18.

The Pledge of Allegiance was led by Councilor Clark followed by a moment of silence for the family of artist, Elizabeth Mumford.

### **PUBLIC COMMENT:**

Frederick Wrightson brought up news stories regarding shootings at short term rentals in Massachusetts, the public deserves to know.

Rob Wilson urged support of becoming a green community

Michelle Sgarlat talked about a need for a climate emergency policy in the Town of Barnstable: action is needed now to reduce fossil fuels.

Gene Quaglia owner of rental properties has some ideas to help solve the problems of short term rentals.

Jennifer Lynch objects to the three night minimum for short term rentals. Close Public Comment

### **Councilor Response to Public Comment:**

Thank you for your comments this evening and taking the time to speak with us; we need to listen to those residents that speak; looking forward to a unified message and more information on climate emergency policy; we can look at the verbiage on the number of rentals per week, perhaps it should be no more than two rentals per week; a letter was read supporting the Town of Barnstable becoming a green community; communicate with us in the next couple of weeks, have people email the Councilors regarding the climate

action network and why we should support it.

#### **TOWN MANAGER COMMUNICATIONS:** (Exhibit A)

For the record, the incident in the rental happened January 31<sup>st</sup> and was reported on the first of February through a press release, by the Police Department and it went out on social media. Our intent is to communicate with our residents and to keep everyone safe.

Town Clerk Ann Quirk gave an update regarding the upcoming November 3<sup>rd</sup> General Election and the 2020 Census.

Meg Mayo-Brown, Superintendent of Schools gave an update on the schools reopening, with a phased in approach. Enrollment has gone down, as some parents have opted for home schooling.

### **Councilor questions and comments:**

Appreciate the remote instruction, thank you for your efforts. How or if extracurricular activities will occur [not after school, but during school time] transportation update [far better than we thought; our entire student body can get transportation] how are you assigning physical education, music, etc. [as much as we can in school, with social distancing] thank you for your countless hours, there are a lot of unknowns still, do you have a plan for families calling about the schedule. [the high school schedule is very challenging, trying to get our software program to run in this new environment with Cohorts A, B, C and D] do you anticipate difficulty filling the positions [Principals are doing a great job, we will make that transition well] looking for volunteers, how do we do that [family and community engagement at the HYCC]

### **Town Mangers Update continues:**

Continue to monitor FY 2021 revenues and expenses. Mark Milne, Finance Director will provide an update.

Town Council Strategic Planning

Phase 3, Step 1 of the Governor's four phase recovery plan

Cape and Islands Water Protection Fund Board continues to discuss distribution of funds

David Anthony, Director of Property and Risk Management provided an update relative to certification as a Green Community. Lisa Sullivan is our contact for Southeast Green Community. Anthony used a PowerPoint presentation to give the benefits of the Green Community designation.

### **Councilor questions and comments:**

What is the timeline for the stretch by-law [December 30<sup>th</sup>, would have to demonstrate compliance] Alternate plan of compliance, when would that be resolved [Brian Florence, December 30<sup>th</sup>, trying to amend the 2021 code to make it more strict by October] Why bring the proposed resolution before the Council now instead of waiting [Ells, we were asked to bring this forward, by the Council, the current effort is worthwhile] What is the basis of your appeal to the State [Florence to meet the Green Community act] what is the unique situation [we are in a 140 mile and hour wind zone, is one example] Could you make that available to us [it is not written as yet, we think we can be successful, and cost effective for the citizens of Barnstable] the stretch code is not the way to go? [that is not what I said] there is a uniform building code for Massachusetts, are you saying you want another one [No sir] we have a tight window to get anything done, five targets, if we were

to have the audits completed in three months, it seems that all these pieces can come together; the Town of Barnstable has come along way to become a green community; feeling some reluctance to go forward; is there anything we could do to help [Florence, absolutely in favor of being a green community, I will do everything I can to get us there before the December timeline] Amend the existing building code, even if we could meet those, what is the feasibility of having that happen by the end of December; Criteria is to have a plan in place, all 14 towns on Cape Cod have passed the Stretch Code; predictable and consistent make us easier to work with; this has been thoroughly vetted, the fifth component is the poison pill in the green community, we need a million dollars in new growth every year to keep us going. Adds time to get the inspections; increase the cost of residential construction; we can be a leader; Criteria 3 and 4, speak to those Mr. Anthony Ithese are both proposed plans, energy reduction plan sitting waiting to be funded through CIP, we would be able to address three and four by the end of the year] Commercial buildings.[Sullivan does not affect local control of permitting, makes sure it meets the criteria] Point of order, we should hold anymore questions until we take up this item up; we could use a workshop on this to bring in all sides on this item.

Mark Ells Town Manager, deferred to Dan Santos, Director of the Department of Public Works who gave an update on the construction of the Maher Drinking Water Filtration Plant and the Comprehensive Wastewater Management Plan(CWWMP).

### **Councilor questions and comments:**

Waiting for sign of on the plan, when does the rubber hit the road [the rubber has hit the road, first construction project will be in the spring, process is the submission of environmental impact, then our plan will have it's final blessing] do we have any innovative systems [we are working with the Barnstable Clean Water Coalition, the installation of alternative septic systems in the area of Shubael's Pond] Willing to offer a ride out to see the alternative septic systems; financing on the CWWMP [assuming we go forward, anticipate betterments or sewer assessment, next year] valuation on the drilling on potential water [field work is completed the report is forthcoming, we will then present and distribute to all] What is parts per million that we normally discharge [around four to five]

**Director of Finance, Mark Milne** utilized a PowerPoint presentation to discuss the Financial Policy Review, starting with the Tax Levy Policy.

### **Councilor questions and comments:**

Automatic 2 ½ every year, a half percent what is that [would be around 600,000 dollars, and we would need to find that plus a million dollars in new growth]. [Mark Ells, important to bring this back to the Council, especially as we go forward to the Waste Water Management Program] Current fiscal process increases our reserves, what is that on an annual basis [Milne, have that information on additional supplies, we are not in the business of making money]

Next slide: New Property Tax Growth, resurgence of new growth over the last six years;

#### Councilor questions and comments:

What does that mean, [we could fund  $3\frac{1}{2}$  million dollars in new loans] We have to come up with a dollar amount, [that would be on the next slide]

Next slide: Capital Program Policy, several types of projects.

### **Councilor questions and comments:**

Assumptions are still valid with the revenue sharing [yes] capped at one million dollars [yes]

Last Slide: Fund Balance Policy (Free Cash)

### **Councilor questions and comments:**

Are we comfortable about how we are doing business at this time; is it possible to have a workshop with the Town Council [Mark Ells, yes, this time sensitive item] Special meeting or within our Town Council meeting: warrants its own special meeting; last Thursday in October, for a special meeting, with just this item to be discussed. The Town Council will plan on October 29<sup>th</sup> for a special meeting of the Town Council.

notes of the Town therefor; and that in accordance with M.G.L. c. 44, §20, any premium received by the Town upon the sale of any bonds or notes authorized by this order, less any such premium applied to the payment of the costs of issuance of such bonds and notes, may be applied to pay such project costs, thereby reducing the amount authorized to be borrowed by this order by a like amount; and that the Town Manager is authorized to contract for and expend the appropriation made available for these purposes.

**RESOLVED:** That the Town Council hereby votes to approve the Town of Barnstable's amended request for \$320,000 in Community Preservation Open Space/Recreation Funds for the acquisition of the open space resource consisting of 15.96 acres located at 28 Falcon Road, West Barnstable, Map 195, Parcel 038 and the Community Preservation Committee's vote to recommend said acquisition. Specifically, the Town Council hereby authorizes, pursuant to the provisions of the Community preservation Act, G.L.c. 44B and the Conservation Restriction statute, G.L. c. 184, Sections 31-33, the amended application for the larger amount of \$320,000 which represents a portion of the total purchase price of \$347,500, said Restriction to be held by the Barnstable Land Trust which is contributing \$27,000 in both funding and in kind contributions. The Town of Barnstable will be applying for a Massachusetts drinking water grant that would potentially pay for up to half of the cost of the project and reserve rights for the Town to install a drinking water well at this site. If awarded, the amount granted would be returned to the Community Preservation Fund. The CPC has requested that the Conservation Restriction reflecting Barnstable Land Trust as the holder, be approved by the Legal Department. The Town Council further votes to authorize the Town Manager to execute, deliver and record documents and restrictions as provided in the relevant, above-cited statutes for the stated purpose and oversight of the Community Preservation Committee.

Specifically, the Town Council hereby authorizes, pursuant to the provisions of the Community preservation Act, G.L.c. 44B and the Conservation Restriction statute, G.L. c. 184, Sections 31-33, the amended application for the larger amount of \$500,000 which represents a portion of the total purchase price of \$525,680, said Restriction to be held by the Barnstable Land Trust which is contributing \$25,680 in both funding and in kind contributions. The Town has a pending application for a reimbursement grant from the State for matching funds in the amount of \$250,000, which

upon award, would be returned to the Community Preservation Fund. The CPC has requested that the Conservation Restriction reflecting Barnstable Land Trust as the holder and other usual conditions, be reviewed and approved by the Barnstable Legal Department. The Town Council further votes to authorize the Town Manager to execute, deliver and record documents and restrictions as provided in the relevant, above-cited statutes for the stated purpose and oversight of the Community Preservation Committee.
