

Town Council Meeting June 1, 2023



A quorum being duly present, Vice President Jen Cullum called the June 1, 2023, Town Council meeting to order at 6:00 PM.

An announcement was made by President Levesque regarding the meeting being televised live and questioning if anyone was actively taping the session to please make their presence known. This session is recorded and broadcast on Channel 18.

The Pledge of Allegiance was led by Councilor Cusack followed by a moment of silence.

PUBLIC COMMENT:

(In-person)

MaryAnn Barboza working on a petition, however she will not be turning them in right away. She stated that Barnstable has given this man a monopoly on menthol cigarettes and this man will not sell to all the residents. We want to treat the tourists exactly the way the residents are treated, very important to take care of your residents.

Laurel Schaider from the Silver Springs health study on perfluoroalkyl and polyfluoroalkyl substances (PFAS) found in the Hyannis water announced the extension of the study. PFAS is considered a forever chemical, the goal of the study is the effects on the health of people who lived in Hyannis from 2006 to 2017? Participants will receive gift cards.

Ann and Bob Schulte spoke about the off shore wind projects. (Exhibit A). This article is concerning the State of Connecticut and their dealings with the off shore wind developer. Numerous problems with this project, what we oppose are the lack of transparency from Avangrid. Avangrid is now trying to back out of the project in Connecticut.

Susanne Conley of Save Greater Dowses Beach, updated the Councilors regarding concerns about Avangrid for off shore wind projects, (Exhibit B). We support the Commonwealth's energy and environmental objectives with offshore wind developers; however, they should protect and preserve the public interest.

Hector Gunther of Save Greater Dowses Beach, Avangrid off shore wind is a startup project; they have never done this before. Set up as an LLC, ultimate parent companies have limited liability and we will have to live with the high voltage infrastructure for decades.

(Ells) many of the questions would need to be answered by Avangrid; Park City Wind told our Legal Department that they have not defaulted. Their permitting is proceeding, to be determined; we are a third party that is impacted by the outcomes. Commonwealth Wind is different, they have defaulted, we paused the host committee agreement, and it will remain so until the Town Council gives us the go ahead. We heard from the State of Connecticut yesterday. Lot of questions for the Council to ask them directly

COUNCIL RESPONSE TO PUBLIC COMMENT:

(Neary) Councilor Atsalis gave him a response to some of the questions he received (Exhibit D)

- 1. Support has come from two host agreements, the Town Manager has consistently stated the project is on hold, until such time as the Council goes forward.
- 2. Allowing Avangrid to continue to use our libraries for monthly meetings is confusing the public. The monthly presentations should stop immediately until we know we are going forward with these projects.

(Clark) Avangrid spoke to the West Barnstable Civic Association, we are concerned about the amount of acreage and the loss of forested acreage, there will likely be an effect on the West Barnstable Fire District. (Ludtke) Would like to see an insert added to the tax bills regarding the PFAS study; will Attorney Nober have any information on that (Nober) We are looking at the language of the insert, we would be presenting it as town, so it needs to come before the Council. (Ludtke) Appreciate the comments of all the speakers, have read some of the comments, we need to do the research, listen to everyone, this is going to be our future. (Schnepp) A lot of information to make us want to learn more encourages the dialogue. (Cullum) Great to be face to face with Avangrid.
