

Town Council Meeting September 7, 2023



A quorum being duly present, President Matthew Levesque called the September 7, 2023, Town Council meeting to order at 7:00PM.

An announcement was made by Vice President Cullum regarding the meeting being televised live and questioning if anyone was actively taping the session to please make their presence known. This session is recorded and broadcast on Channel 8 or High Definition Channel 1072.

PRESENT: Nikolas Atsalis, Kristine Clark, Jennifer Cullum, Paul Cusack, Jessica Rapp Grassetti, Matthew Levesque, Betty Ludtke, Jeffrey Mendes, Paul Neary, Paula Schnepp, Tracy Shaughnessy, Gordon Starr Eric Steinhilber.

The Pledge of Allegiance was led by President Levesque followed by a moment of silence.

PUBLIC COMMENT: (In-person)

Susanne Conley spoke about the Cuda Classic Golf Event at the Olde Barnstable Fairgrounds, which would raise money to support Cape Cod Women's Health Care. The money would be utilized to help with their cost and quality of care. The event will take place on October 3rd, 2023.

Asia Graves discussed affordable housing ideas and policies. She spoke about the high cost of brokerage fees, which include first month, last month and a security deposit. She noted there was also an additional application fee. People are being priced out due to the expensive rents and associated fees. Asia mentioned the need for better medical dispensaries closer to Town. She mentioned the idea of co-living, as the rents for this type of living was affordable.

(Mendes) Thank you Asia for what you are saying it is real. My family has some issues as well.

(Clark) Good work at the golf course; great event for the Cuda Center; Thank you to Chris Gonnella for the good and challenging work you have done; I am sensitive to the housing issue.

(Ludtke) Thank you for the excellent care at the Cuda Center; thanked Asia for her innoviative ideas regarding housing; please continue with your ideas.

(Rapp Grassetti) Thanked Asia for coming to the Council meeting; and asked her to attend the Affordable Housing Trust Fund; she suggested money could be put toward affordability of rents.

(Levesque) Please attend the meeting with the Town Manger, which is a zoom meeting at 9 AM.

(Schnepp) Asia thank you for stepping forward; Accessory Dwelling Units (ADU) allows for flexibility in housing.

(Levesque) Thanked Susanne and appreciate your passion for all of Barnstable.

TOWN MANAGER'S COMMUNICATIONS: (Pre-Recorded) (Cullum) The Town Manager's report has been prerecorded and the written form will be available to all on the Town Manager's page on the website. (Exhibit A) Update on:

- 1. Budget calendar for Fiscal Year 2023 update
- 2. September 21, 2023 Town Council meeting we antipate two workshops regarding the Taking of Private Roads and Flow-Neutral by-laws.
- 3. September 4th Recreation completed the last official day of beach operations for the season.
- 4. September 1st Town of Barnstable files its application for a Watershed Permit.
- 5. Town of Barnstable is now a Complete Streets community with the Massachusetts Department of Transporation.
- 6. Department of Public Works (DPW) has completed a New Source Evaluation Report
- 7. Per-and Polyfluoroalkyl substances (PFAS) new guidelines will be proposed by Massachusetts Department of Environmental Protection (DEP).

Councilor questions and comments:

(Ludtke) How will we prioritize these projects? (Ells) Yes as a Complete Streets community we are certified as accessible and a safe community. We will work with the project costs, adjust when needed and brain storm other projects with the list of complete streets. Elizabeth Jenkins, Director of Planning and Development (Jenkins) There is a prioritization plan, Massachusetts Department of Transporation (MDOT) has accepted the list. (Ludtke) All very good projects. (Starr) Rolling applications? (Jenkins) Yes we will probably leverage other project mid-October. (Jenkins) Award announcement will be in October. Opportunity will be leveraged if we are awarded. (Starr) Housing project plan? (Jenkins) Utilizing the 2023 census data recommend Housing Committee will hit all reccomendations with affordability housing. Joint meeting with Planning Board and Housing Committee. (Starr) How about small scale developers housing? (Jenkins) Meeting with consultant; updating 2023 census and adding in costs which are appropriate threshold to our ordinance. Need to go to Housing and Affordable Trust. (Rapp Grassetti) Application for Watershed Dan Santos, Director of Public Works met with Mashpee and Sandwich was not present. The water Intermunicipal/watershed plan agreement was worked on with Dan Santos, Mark Ells and Jessica Rapp Grassetti. (Santos) The Comprehensive Wastewater Management Plan (CWMP) has many pieces; requirements going forward on the properties with CWMP. (Schnepp) What was the dialogue with the Town of Sandwich? (Ells) Lots of discussion with Mark Forest and George H. "Bud" Dunham. Will continue with dialogue – each community needs to come together although should file

differently. (Schnepp) Thank you for the Second Annual Celebration it was great. (Ells) Everyone came together to do this event look for it next year. (Cullum) CWMP thank you for approach you took. Message needs to be understood and explained. (Levesque) Commend the Town Manager for working with the DEP thank you

Presentation from Dr. Caitlin Coyle from the Gerontology Institute at UMass Boston Age & Dementia Friendly Barnstable - An Action Plan

Chris Gonnella, Director of Community Services, introduced Kelly Howley, Director Council on Aging, Caitlin Coyle, from the Gerontology Institute at UMass Boston Age & Dementia Friendly Barnstable, Patty Sullivan, Program Director Dementia Friendly Massachusetts, Massachusetts Council on Aging and gave the background from 2019 to the future plans. He discussed the process to complete the plan. He mentioned there was 18,100 people in Barnstable who 60 years and older. Dr. Coyle gave an overview of the PowerPoint presentation. She spoke about the framework, and the Age Friendly Action Plan, which was completed May 2023. She talked about the six goals of housing: which included: transportation, walkability, community support, health services, respect and social inclusion and civic engagement. Kelly Howley spoke about the transportation with the pilot project. Patty Sullivan thanked Madeline Noonan, former Director of Community Services Barnstable, reassured council that she would be working with the Town during implementation. She noted Dementia is not a disease it is a condition.(Clark) Suggested matching nursing students, certified nursing assistants and others who have had

special skills training with aging residents. Also include low income and others with the special skills training to be housing with a resident that need special help. (Sullivan) great idea. (Mendes) This is a hugh health crisis and 2/3 of those affected will be women. (Cusack) Would like to be involved; will be meeting with Kelly next week. (Ludtke) Thank you for the great presentation. (Schnepp) What about adult foster care? (Coyle) Yes this is needed. (Sullivan) Supportive Day Programs, non-medical services all programs on Cape Cod there is a waiting list; we are trying to expand those programs. (Cullum) Have you reached out to others in the community utilizing diversity and inclusion initatives. (Coyle) Yes, we have reached out into those communities.

2024- 037 ORDER TO PETITION THE GENERAL COURT OF THE COMMONWEALTH TO ENACT SPECIAL LEGISLATION APPROVING THE CHANGE THE USE OF APPROXIMATELY 3,400 SQUARE FEET OF LAND WITHIN THE CRAIGVILLE BEACH PARKING LOT INTRO: 09/07/2023

Dan Santos, Director of Public Works gave the rationale. He utilized a PowerPoint presentation. Karen Nober, Town Attorney introduced the new Barnstable attorney Tom LaRosa, She discussed Article 97 Amendment to the Constitution which is to dispose or change use of recreation land. She added there needs to be notice to the Secretary of Environment Affairs and public comment. It is for the replacement land equal to or greater to the land utilized. She mentioned the comments received were generally supportive of the Town sewering and do not want pump stations on public town land.

Open public hearing seeing no one and no one on zoom, close the public hearing

Council questions and comments:

(Shaughnessy) We are losing any parking? (Santos) Will lose 3 parking spaces. (Atsalis) Great start you will need community input. Will the dumpster move? (Santos) It will be part of the design. (Clark) How will the replacement land be chosen? (Nober) Not determined a process

yet; we will have annual updates and the Town has 3 years to get the replacement land.

Upon a motion duly made and seconded it was

ORDERED: SECTION 1:

That, having received notice that the Town Manager has determined that approximately 3,400 square feet within the Craigville Beach parking lot, as shown on a plan of land titled "Area of Land for Which A Change of Use is Contemplated, 997 Craigville Beach Road, Barnstable, Massachusetts" drawn by Town of Barnstable Department of Public Works dated 8/24/2023 ("the Property") are no longer needed exclusively for recreation purposes, and that the Town Conservation Commission, by unanimous vote, concurred with and endorsed the Town Manager's declaration that the Property which is under his custody and control, is surplus to the municipal, conservation and open space needs of the Town of Barnstable and should instead be dedicated to general municipal purposes to support construction of a sewer project which is part of the Town's Comprehensive Wastewater Management Plan, the Town Council hereby approves a change in use of such Property from recreation land to general municipal purposes; provided that such change in use shall be subject to the enactment of legislation by the General Court as set forth in Section 2 of this Order.

SECTION 2:

That the Town Council hereby directs the Town Manager to submit a petition to the General Court of the Commonwealth for a special act approving the change in use of approximately 3,400 square feet within the Craigville Beach parking lot, Centerville, as follows:

"AN ACT AUTHORIZING THE CITY KNOWN AS THE TOWN OF BARNSTABLE TO CHANGE THE USE OF A PORTION OF LAND WITHIN THE CRAIGVILLE BEACH PARKING LOT

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

SECTION 1. Notwithstanding any general or special law to the contrary, and in accordance with section 5A of chapter 3 of the General Laws, the town council of the city known as the town of Barnstable may change the use of approximately 3,400 square feet of land located within the Craigville Beach parking lot, as shown on a plan of land titled "Area of Land for Which A Change of Use is Contemplated 997 Craigville Beach Road, (Centerville) Barnstable, Massachusetts" drawn by Town of Barnstable Department of Public Works dated 8/24/2023, for the purpose of constructing, operating and maintaining sewer infrastructure, including a below-ground sewer pump station and related infrastructure as well as an above-ground structure to enclose electrical equipment, all in support of the town of Barnstable's approved Comprehensive Wastewater Management Plan.

The town of Barnstable may make minor modifications to the plan to carry out this act. SECTION 2. As compensation for the change of use of the land described in section 1, the town of Barnstable shall deposit \$71,500 to the town of Barnstable Community Preservation Fund, which represents 110 percent of the required appraised value, to be used by the town to acquire replacement land or interests in land pursuant to section 5A (2) of chapter 3 of the General Laws.

SECTION 3. The Town Manager of the town of Barnstable may execute and record on behalf of the town any instruments necessary to carry out this act.

SECTION 4. This act shall take effect upon its passage."
