 - 251 Green Dunes Drive, Hyannis, MA 02601. Proposed project: Dock and float (this matter was previously discussed on 04/22/2025). It was brought to the applicant's attention that the intention of using a motorized Vessel was not clear

and that the applicant needs to go back to the committee to make the clarification. The applicant provided a revised plan in response to comments from the Conservation Agent.

Despite the applicant's assurance that all dimensions and environmental regulations remain compliant, committee members expressed concern over the significant change in vessel size, navigational constraints, and potential impact on the surrounding waterway, which is commonly used for kayaking and paddleboarding. Members requested detailed schematics for further review before deciding on the matter.

1. Deborah Peterson.

Request for this mooring was denied back on August 20, 2024. Ms. Peterson's deeded beach rights are not the same as the waterfront property ownership, which is the guide the Harbormaster has used for determination of applicants outside of the Town's designated mooring fields.

2. John Healy Jr.
