## Waterways Committee Meeting November 27, 2018 Minutes

A meeting of the Town of Barnstable Waterways Committee was held on November 27, 2018 - Selectman's Conference Room, Hyannis MA. The meeting was called to order at 7:04 pm by Chairman Jack Meade.

### Meeting Minutes:

Approval of October 23, 2018. meeting minutes. All meetings are recorded and available on line at Towns web site. Motion was made by Mr. Peter Cross to accept the minutes as written. It was seconded by Ted Komenda.

### Notice of Intent (NOI):

1. Corsiglia, Christina & Alger, Sarah, Trustees: 65 Waterman Farm Road, Centerville, MA 02632, Map 206, Parcel 072. The applicant proposes to construct and maintain a boardwalk, ramp and float.

**WWC have no objections. Harbormaster staff had no objections but wanted it on record that there would be no motorized vessel berthed at the dock and no maintenance dredging moving forward. The NOI states the following:**

**“The creek does not have water depths to support any motorized boat traffic, and is not a traveled channel”.**

2. Blair, Henry: 275 Millway, Barnstable, MA 02630, Map 301, Parcel 063. The applicant proposes to revise the maintenance dredge plan to allow the use of hydraulic dredge in addition to the mechanical dredge, permit a second dewatering basin for the hydraulic dredge and repair the wooden bulkhead.

**WWC & Harbormaster Staff had no objections.**

**New Business:**

1. Eel River Waiting List proposed change in status (open to closed)

**WWC had no objections however, asked detailed questions pertaining to Harbormaster reasoning for closing the waiting list. Harbormaster staff feels**

**by leaving this certain mooring field open it creates false hope due to its location.**

2. Proposed changes to Mooring Regulations related to wording on “fees” - discussion and possible vote.

**WWC & Harbormaster Staff had no objections but did point out a few grammatical errors. WWC also suggested adding a fee sheet and reference where fees should be found and maintained. There will be a new addition to the regulation, reference: waiting list offerings (406-16 Waiting List Procedure, Section L).**

3. New Regulations: Waiting List Procedure – discussion and possible vote

**WWC & Harbormaster Staff had no objections.**

4. Hyannisport Mooring Field, Chuck Roland, Sullivan Engineering

**Chuck Rowland and Evans Arnold made a presentation regarding accretion in Hyannisport Harbor. They proposed that the Hyannisport mooring field and mooring locations be reconfigured due to the accretion. Harbormasters staff will meet with mooring servicers and discuss the presentation. A follow-up will be made at a Waterways Committee Meeting in the future.**
