On the cover: Milk Room and Barn Foundation, *The Lucy Stone Home Site*, West Brookfield, listed in the National Register of Historic Places on February 8, 2021. The site includes the foundation remains of the family house and farmstead where Lucy Stone (1818-1893), the women's rights pioneer and anti-slavery activist, was born and spent her formative years. She maintained a strong association with her family's Coy Hill farm throughout her life. Fiercely determined from an early age to oppose and overcome the inequalities and obstacles she encountered, she was the first woman in Massachusetts to earn a baccalaureate degree, the first known married woman to retain her maiden name, and may well have been the first woman to retain her economic rights through a pre-nuptial agreement. A gifted orator, she was a powerful women's rights activist and abolitionist. Soon after graduating from Oberlin College in 1847, she was appointed as a lecturer for the American Anti-Slavery Society, launching a lifetime of inspirational public speaking for social reform. In 1850 she helped organize the first National Women's Rights Convention in Worcester, which led to a national lecture circuit as both an abolitionist and women's rights activist. After the Civil War she helped form the American Equal Rights Association, which promoted the right of all American citizens to vote, regardless of race or gender, and in 1869 she was one of the organizers of the American Woman Suffrage Association. Her weekly newspaper, *The Women's Journal*, focused solely on women's suffrage and became a prominent newspaper of the women's rights movement. Lucy Stone saw the inequalities between races and genders and made it her life's mission to educate others on the rights of women and the wrongs of slavery, and to institute social changes that altered the nation.

The West Brookfield farm remained in the Stone family until 1936, and continued in agricultural use until the farmhouse and associated outbuildings were destroyed by fire in 1950. In 2003, the property was acquired by the Massachusetts Land Conservation Trust, a subsidiary of the Trustees of Reservations (now The Trustees), which has worked to preserve the farmstead's clearly visible foundations and related historic architectural and archaeological features as a commemorative site accessible to visitors seeking to learn more about Lucy Stone and the family farm on which she was born and raised.

MEMORANDUM

TO: Local Historical Commission and Local Historic District Commission Members
FROM: Michael Steinitz, Deputy State Historic Preservation Officer, MHC
DATE: January 15, 2022
RE: Preservation Restrictions listed in the *State Register of Historic Places*

I would like to call to your attention the **Preservation Restriction** designation (abbreviated “PR”) that is noted on certain properties listed in the *State Register of Historic Places*. Please take special note of any existing or newly listed properties with Preservation Restrictions that are located in your community.

Owners of properties protected by a Preservation Restriction granted to a governmental body or qualified charitable corporation have a special responsibility to safeguard the historic integrity of their buildings or sites and their settings. As defined by M.G.L Chapter 184, ss. 31-33, a Preservation Restriction may restrict or limit any or all alterations to exterior or interior features, changes in site appearance, inappropriate uses, archaeological field investigations, or other uses or actions inappropriate to the preservation of an historic structure or site.

While the MHC itself holds Preservation Restrictions on many properties as a result of grant assistance, many other Preservation Restrictions are held either by local governments or by qualified charitable corporations. Alterations or changes to a property with a “PR” generally require prior written notification to and approval by the holder of the Preservation Restriction.

The MHC asks that you communicate to the Commission knowledge of or concerns regarding any potential activity that might threaten a property in your community protected by a Preservation Restriction. MHC and the holder of the Restriction should also be made aware of any present or future plans for rehabilitation, construction, sale or transfer. The MHC will cooperate with local historical commissions and historic district commissions concerning any action that should be taken. The MHC would also appreciate any corrections regarding the Preservation Restrictions noted or any omissions on the State Register of which you are aware.

PREFACE

The Massachusetts Historical Commission (MHC) was established in 1963 to encourage the preservation of the historic buildings, structures, objects, landscapes and archaeological sites that contribute to the cultural heritage of the Commonwealth's cities and towns. These unique and non-renewable historic resources help to maintain a sense of place and time in our downtowns, neighborhoods, town centers and rural landscapes. They inform our understanding of the past, and through their maintenance, rehabilitation and reuse, they will continue to play a role in shaping vital and dynamic communities into the future. Historic preservation is integral to protecting the qualities of community character that make Massachusetts an attractive place for visitors and residents alike.

The conservation of historic and archaeological properties is a legitimate concern of public policy and has been recognized as such by a full body of state and federal legislation. MHC's programs seek to integrate a systematic consideration of historic properties into current management and planning decisions. The **State Register of Historic Places** was created in 1982 to enhance MHC's ability to identify, evaluate and protect the Commonwealth's historic and archaeological resources. The State Register creates a single, easy-to-use master list of properties designated under several specific local, state, and federal statutes. It supports a comprehensive and timely system of review for state governmental bodies whose actions may affect designated properties, providing a clear framework to ensure that the Commonwealth's cultural heritage is not inadvertently damaged by public action. The regulations that protect properties listed in the State Register are cited as 950 CMR 71.00.

ORGANIZATION

The State Register is a compilation of listings of properties and sites with several different types of official local, state, or federal designations. See the Abbreviations section for a complete list of designations. Please note that the filing of an Inventory Form with the MHC does not constitute listing in the State Register of Historic Places.

State Register listings are arranged by municipality. Within each city or town, properties are arranged alphabetically by their historic name. Properties named after people are listed with the surname first (*i.e.*, Smith, John House). Properties known only by their address are arranged alphabetically by the street name with the street number following. Specific location information is not provided for archaeological sites to protect them from possible harm. Following the name and location information are the designation type and date, and the number of properties or resources included in the designation.

Many listings include multiple designations. For properties and districts with multiple designations, the boundaries of each designation sometimes differ. The "Center Village Historic District" may be the official name of both a National Register district and a local historic district that overlap but have different boundaries. In such a case, the "Center Village Historic District" is listed twice, with each listing including a different designation, date, boundary description and property count. Properties that have individual designations and also fall within historic districts appear with both their individual and district designations. For districts, a listing appears only for the district as a whole. PLEASE NOTE THAT THE STATE REGISTER DOES NOT INCLUDE ADDRESS LISTINGS OF INDIVIDUAL PROPERTIES LOCATED WITHIN DESIGNATED HISTORIC DISTRICTS. For this and other information, researchers should always consult the Commission's records related to State Register designated properties and districts on file at MHC offices at the State Archives Building, 220 Morrissey Boulevard, Boston.

ABBREVIATIONS FOR STATE REGISTER DESIGNATIONS

NHL: National Historic Landmark (36 CFR 65)

Includes properties of outstanding national significance designated directly by the Department of the Interior.

NR: National Register of Historic Places (36 CFR 60)

Includes properties of local, state, or national significance designated by the Department of the Interior through the State Historic Preservation Office. Codes that indicate National Register designations include:

NRDIS: National Register District

NRIND: National Register Individual property

NRMRA: National Register Multiple Resource Area

Refers to a community-wide or area-wide designation that can include nominations of individual and district properties. If a property has been designated as part of a Multiple Resource Area, "NRMRA" is listed directly below the NRDIS or NRIND designation.

NRTRA: National Register Thematic Resource Area

Consists of properties related by theme; these resources may be located over a much wider geographical area than those of an NRMRA.

NRMPS: National Register Multiple Property Submission

For properties or districts designated as part of a Multiple Property Submission, "NRMPS" is listed, with a date, directly below the NRIND or NRDIS designation. If listing dates for the NRMPS and the NRIND/NRDIS differ, then the official date for inclusion of the property or district in the State Register is the one noted for the individually listed property or district.

NRDOE: Determinations of Eligibility (36 CFR 60.3 (c) & 60.6(s))

Includes only properties of local, state, or national significance that have been determined eligible for listing in the National Register of Historic Places by the Keeper of the National Register, Department of Interior. The Keeper's Determinations of Eligibility may occur during the course of a federal undertaking, or if a property owner objects to listing, or if a majority of owners in district object to listing. Any opinions or determinations relative to properties made by the MHC staff or the MHC in its role as the State Review Board, are not NRDOE's, and those properties are not listed in the State Register.

MA/HL: Massachusetts Archaeological/Historic Landmarks (M.G.L., Ch. 9 s. 27)

MAL: Massachusetts Archaeological Landmark

MHL: Massachusetts Historic Landmark

Includes sites (MAL) and structures (MHL) of state significance designated by the Massachusetts Historical Commission; all are subject to the Standards for the Care and Management of Certified Historic Landmarks which are recorded with the property's deed.

LL: Local Landmark (various local ordinances)

Includes properties of local, state and/or national significance designated by local governments.

LHD: Local Historic District (M.G.L., Ch. 40C and special legislative acts)

Includes properties of local, state, and/or national significance designated by local governments. Designation date and number of properties reflect the last amendment made to the district, and do not always represent the initial date of establishment or original property count.

RHD: Regional Historic District (special legislative acts)

Includes properties of local, state, and/or national significance designated by special act of the legislature. At this time, the only designated regional historic district is Old King's Highway Historic District, Barnstable County (M.G.L., Ch. 470 of the Acts of 1973).

PR: Preservation Restriction (M.G.L., Ch. 184, ss. 31-33)

Includes properties of local, state, and/or national significance. Restrictions run with the deed in perpetuity or for a specified term of years. If the Restriction does not run in perpetuity, the expiration date is indicated below the PR date. The Massachusetts Historical Commission must approve Preservation Restrictions, but any qualified governmental body or charitable corporation may hold Restrictions.

Props: Number of Properties

Indicates the number of properties or resources included in the listing. Properties and districts that cross town lines are listed under each town, with the property count divided accordingly. A single property located directly on a town line is counted once in each corresponding town.

The regulations that protect properties listed in the State Register are cited as 950 CMR 71.00.
