

Background

The Barnstable Department of Public Works (DPW) is located at 382 Falmouth Road. It consists of one single-story building with an accessible entrance located on the east side of the building. Offices located at the DPW building include the Administration and Technical Support Division Offices, the Highway Division Offices and the Emergency Response Center. Only the Highway Division is open to the public. The parking lot is located on the east side of the building. There are two (2) accessible parking spaces located near the main entrance. In additon to the accessible parking spaces there are two (2) reserved parking spaces also near the main entrance.

The DPW Fleet Maintenance is also located on site – across from the DPW offices. The Fleet Maintenance is not open to the public.

Key Accessibility Issues

- Signs at accessible parking spaces installed lower than the minimum height allowed.
- Tactile sign not provided at emergency exit door.
- Illuminated ISA symbol not provided at the accessible egress door.
- Maneuvering clearance not provided on the push side of the door at the main entrance.

Order of Magnitude Cost Estimates

• Miscellaneous corrective actions (signage, automatic door opener, etc.): \$3,524

Total: \$3,524*

*Note: Cost to provide an auxiliary counter near the service window is not included.

Best Practice and Inclusive Design

Best practice and inclusive design recommendations include elements that are not required in the standards but may create enhanced experiences for all users.

• Recommend relocating the information signs located at the main entry door to avoid glare.
