### **Town Council Meeting – Thursday, March 5, 2020**

Last night's Town Council Meeting began with Town Council President Paul Hebert presiding over the meeting which began with the Pledge of Allegiance and a Moment of Silence. President Hebert took **Agenda Item 2020-137** Resolve to Proclaim March 12, 2020 as Girl Scout Day in the Town of Barnstable out of order. Town Councilor Eric Steinhilber read the item and provided the rationale for the item which was unanimously approved. Public Comment and Council Response to Public Comment followed.

Town Manager Mark Ells presented the following items during [Town Manager Communications](#) for the period February 28-March 5, 2020:

1. The President of the Town Council has requested that the Town Manager prepare a presentation for Town Council to consider whether Barnstable wants to pursue a Green Communities designation ([Green Communities Website](#) at the State). Mr. Ells has created an internal working group on the subject that consists of the Building Commissioner, School Facilities Director, DPW staff, and Director of Property and Risk Management. David Anthony, Director of Property and Risk Management, provided an overview relative to this effort. We will keep you advised as we progress on this matter.
2. Mr. Ells provided the Town Council with our most recent communication to Local Boards of Health from the U.S. Centers for Disease Control and Prevention (CDC) dated March 4, 2020 issuing revised guidance regarding travelers to Level 2 and 3 countries returning to the U.S. and recommended procedures for reducing the risk of transmission of virus associated with COVID 19. Our Emergency Response Officials in coordination with all staff, county, state and federal officials are in constant communication and will remain so until this event concludes. We will keep you advised as more information becomes available.
3. We are proceeding with the tasks in the budget action calendar for FY 2021 as scheduled. The FY 2021 Capital Budget and [FY 2021 – FY 2025 Capital Improvement Plan](#) has been submitted to Town Council and posted on the Town website. Town Council will conduct their first reading of FY2021 Capital Budget orders on this evening and a second reading beginning March 19, 2020. Mark Milne and Mr. Ells will do a brief summary of the FY 2021 Capital Improvement Program when items are taken up under New Business. Town Manager [FY 2021 rate hearing](#) is scheduled on March 10, 2020 at 10:00 AM at Town Hall in the James H. Crocker Jr. Hearing Room and posted on the Town website. Mr. Ells provided a summary of town wide water rates as requested at the last Town Council meeting. For information on our fiscal year budgets please view the Town's Open Budget website at <http://budget.townofbarnstable.us>.
4. The President of the Town Council has requested that the Town Manager prepare a draft ordinance for Town Council to consider a ban on municipal use of plastic bottles in the Town of Barnstable. Our senior staff has taken this under review and will bring forward a draft ordinance in the near future for your consideration.
5. At the request of the President of the Town Council we are planning for a Panel Discussion regarding 5G at the Knight Auditorium. The tentative date is March 30, 2020 pending confirmation by panelists. Mr. Ells provided the link to the [presentation to Town Council by Attorney Alan Mandl on municipal permitting limitations on March 7, 2019](#) for your review. We will keep you advised of our progress on this matter.
6. Mr. Ells thanked the Barnstable Youth Commission and supporting staff for the Job Fair conducted yesterday at the Hyannis Youth and Community Center. There were 266 students who attended from 22 schools on and off the Cape. This is the largest attendance to date. We want to thank the volunteers, 39 businesses that participated, and Warren Rutherford and his son Kevin from The Executive Suite joined by MassHire this year for the job coaching.
7. Elizabeth Jenkins, Director of Planning and Development, provided an update on the status of Accessory Dwelling Units. Ms. Jenkins was joined by Building Commissioner Brian Florence and Planning and Development's Housing Coordinator Arden Cadrin.

**OLD BUSINESS** Planning and Development Department Housing Coordinator Arden Cadrin joined by Developer Jake Dewey provided the rationale for [Agenda Item 2020-135](#) Authorization of a Housing Development Incentive Program Tax Increment Exemption Agreement between the Town of Barnstable and J.P. ## **School Committee Meeting – Wednesday, March 4, 2020**

The Highlight of the School Committee Meeting on March 4<sup>th</sup> was Hyannis West Elementary Students giving their “Dream” speeches inspired by Dr. Martin Luther King, Jr. Ms. Duran’s students spoke about being kind, strong, bright, sensitive, powerful, generous, artistic, caring, calm, loving, fearless and respectful while dreaming of a world with no racism, no fighting, no more hating, no war, equal rights for all people and loving each other with our red, beating hearts! Every year these students share not only their words, but also their hopes and dreams with the School Committee and the community. As School Committee member Stephanie Ellis shared at the meeting, the night these students share their speeches with the School Committee is her favorite school event of the year. Congratulations to Mrs. Duran and her class for sharing their “Dreams.” Barnstable Intermediate School shared the community engagement work that has been going on at the school with the help of the Mass Ideas Grant. There are more activities being offered to students including sports, Dungeons & Dragons Club, pep band, chorus, snack bar run by students, and peer leadership opportunities. Students are feeling more engaged and connected to the school. There are a great number of students attending social events and fewer absences from school. Dr. Mayo-Brown also gave a budget presentation, which focused on expanding social, emotional, behavioral, and academic supports by increasing direct services to students. She spoke about creating a Therapeutic Learning Intervention Center at Barnstable Community Innovation School, West Villages Elementary, Hyannis West Elementary, Barnstable-West Barnstable Elementary, Barnstable United Elementary, and



Barnstable Intermediate School. The model would include a licensed teacher, paraprofessional, and a half-time social worker. In total, there would be 21.4 new direct service positions for the 2020-2021 school year. ## News from Marine & Environmental Affairs: Oyster Season Began March 1st

As of March 1st, we are allowing weekly harvest to be one (1) level peck instead of ½ peck/week for the remainder of the season. The last day to harvest oysters is Sunday, March 29, 2020. Additionally, the recreational area at Scudder Lane shuts down April 1<sup>st</sup>, which means the last day to harvest any shellfish from the Scudder Lane recreational area will also be Sunday, March 29, 2020. The recreational area will re-open for the next oyster season sometime in November.

### **ABOUT THE EXHIBIT**

In October 2019 students from Barnstable High School's Fine Arts 4 Class participated in a field trip out to the Sandy Neck House at the "Halfway Point," so called because of its location half way down the inner rim of Sandy Neck. The building, more of a nature camp than a "house," is nestled in the maritime forest perched above the Barnstable Great Marsh. It overlooks a thick matted patch of marsh grass, Osprey nesting sites and a cluster of bird houses opening up to a view of Barnstable Harbor. Students Celita Cadet, Triona Ferrie, Victoria Hall, Alison Kearney, Shaya Morales, Stephen Pond, Alec Rogalski, Sam Van Gelder and Elisha Watson were tasked with combining what they had previously researched regarding the ecology, history, topography, and conservation aspects of Sandy Neck with their experiences journeying out to the House out at the Halfway Point. Accompanying them were Town of Barnstable Sandy Neck Natural Resource

Officer Sean Kortis and Barnstable High School art teachers Abby Fay Smith and Matt Kemp. During the day the students observed baby diamondback terrapins saved by the Town's conservation efforts, multiple tracks from a range of Sandy Neck fauna, explored the trails snaking through the maritime forest, gathered materials, and created a series of plein air sketches and wrote about their adventure. From this experience, the group created a range of artistic responses,



utilizing a variety of techniques including photo collage, mixed media painting, traditional acrylic painting, printmaking, and sculpture. They tell the story of the interaction of two of Barnstable's greatest resources: the natural beauty of Sandy Neck and the bright, talented, and inspiring students of Barnstable High School. *SNK Stitch*, Needlepoint embroidery sewn into unprimed canvas

I remember the sun being so incredibly bright the day we visited Sandy Neck I was blinded. I felt so warm even with the crisp October breeze tossing my hair around into knots. I sat in the back of the truck's bed and was pleasantly toured around the private, serene off-road trails. It was a day I'll always remember for its softness and profound beauty. I seldom spent time at Sandy Neck before this trip, brushing the beach off as merely another "tourist attraction". To say I was proven wrong would be an understatement. When given the chance to sit down and reflect on everything I saw, I was overwhelmed with words and ideas brewing in my mind, spilling everything onto the page. I wrote about how Sandy Neck reminded me of Eden, resembling sacred and untouched land. I felt like I had been exposed to a side of Cape Cod I had never known even existed. When we explored different media in class, I was subconsciously drawn to the embroidery. My grandmother worked at Heartbeat Quilts until it was closed and then moved to Tumbleweeds. She didn't just love needlepoint, quilting and sewing - she was fluent in the language of fabric and pattern. The familiarity of her life pulled me towards using it as the sole medium for this project. After reflecting at the Midway house, I made my way outside to bask in the sunlight upon the front steps. I sat there, rubbing the pad of my thumb against the butterfly ring on my pointer finger. In the silence, I thought about my grandmother for the first time in what had seemed to be months. The conservation reminded me of her, it brought a rosy smile to my cheeks the same way I

did around her. I watched in awe as a monarch fluttered down, settling gracefully onto the goldenrods beside me. Those brief two minutes I spent admiring the delicate insect is what inspired my *SNK Stitch*. I had collected flora and fauna while venturing the trails, I wanted to keep the entire experience and press it into my sketchbook for safe-keeping. I decided upon using unprimed canvas as my base for needlepoint. The soft, tan texture of the fabric brought me right back to the warm sand that engulfed every crevice inside my worn-out Adidas. Taking inspiration from my grandmother, I hand-sewed the goldenrod and other fauna onto the canvas on separate patches. I wanted to make a crazy stitch and I wanted to make it in honor of my grandmother and all her beauty, serenity and warmth. I stitched together a patch of a pink monarch that will be sewn into the center of the quilt. I chose to make the wings a variation of pink to resemble cancer awareness. It's been three years since she passed away and every September I miss her even deeper than the last. Her love will never fade from my heart, her essence and guidance will forever carry on within me. I miss her more than I can even begin to explain, but that's a story for another time. I hope I can rightfully honor both Mary Hamblin and Sandy Neck in this piece. I tribute all my hard work to her and hope to create something that speaks deeper than anything else I've made in previous years at BHS.

## ROAD WORK UPDATES

*As always please slow down and use extreme caution when traveling through the road construction areas and follow posted safety and detour signs.*



### **\*NEW\* National Grid New Customer Hookups**

Neuco Crews will install gas service as follows: Monday, March 9, 2020 through Friday, March 13, 2020 Main Street (Route 6A), Barnstable Village (near Railroad Avenue). Typical natural gas service installation includes marking out underground utilities within the project area, excavation of the street, laying gas main, relaying customer's individual gas service and connecting those services to the main and installing meters. This project should take about two days to complete. Visit [Ngrid.Com/ServiceLine](http://Ngrid.Com/ServiceLine) to view a YouTube video explaining the replacement of the service pipe to customer homes. Operations will start promptly at 7:00 AM and run until 3:00 PM. Reduce speed and use caution. All scheduled work is dependent on weather and / or may be impacted due to an emergency situation.

### **\*CONTINUES\* Main Street (Route 6A) and Mill Way in Barnstable Village**

Construction is scheduled to continue through May 2020. Normal work hours will be 6:30 AM to 4:30 PM, Monday through Friday. The project area is Main Street (Route 6A) from Rendezvous Lane to Mill Way, and Mill Way from Main Street to Barnstable Harbor Marina. The project objectives are to improve pedestrian access and overall traffic safety, rehabilitate aging infrastructure, and enhance the streetscape. The project scope includes new/improved sidewalks, landscaping, decorative street lighting in the village center, drainage, pavement, crosswalks, median islands, and traffic signals. In addition, Verizon is installing a number of new utility poles and the utility companies are responsible for transferring their lines to the new poles and then removing the obsolete poles. Traffic will be maintained on these roads throughout construction. During active construction in the roadway, there will be lane closures with police details to direct traffic. Traffic delays may occur during lane closures. When required, detours will be posted and communicated with local businesses and residents. As always, please slow down and use extreme caution when traveling through the road construction areas, and follow posted safety and detour signs.

### **\*CONTINUES\* Sea Street, South Street, and Ocean Avenue in Hyannis**

Construction is scheduled to continue into Spring 2020. Normal work hours will be 7:00 AM to 3:30 PM, Monday through Friday. The project area is Sea Street from Main Street to Ocean Avenue, Ocean Avenue from Sea Street to Keyes Memorial Beach, and the intersection of Sea Street & South Street. Comcast and Verizon are responsible for relocating overhead utility lines to the new poles and removing obsolete utility poles. Remaining work by the Town's contractor includes sidewalk work at the intersection of Sea Street & South Street; improvements at the beach parking driveway; sidewalk reconstruction and street lights installation on the east side of Sea Street between Main Street and South Street, and on the west side of Sea Street between South Street and Ocean Avenue; placing the top layer of asphalt on the roads and remaining driveway aprons; permanent pavement markings; and various punch list items. Traffic will be maintained on these roads throughout construction. During active construction in the roadway, there will be lane closures with police details to direct traffic. Traffic delays may occur during lane closures. When required, detours will be posted and communicated with

local businesses and residents. As always, please slow down and use extreme caution when traveling through the road construction areas, and follow posted safety and detour signs.

### **\*CONTINUES\* Route 149, Main Street, and River Road in Marstons Mills**

Construction is scheduled to continue into Spring 2020. Normal work hours will be from 7:00 AM to 3:30 PM, Monday through Friday. The project area is Route 149 from Mill Pond to Lovell's Lane, Main Street from Route 149 to the former elementary school, and River Road from Route 149 to the post office drive. Verizon is responsible for relocating overhead utility lines to the new poles and removing obsolete utility poles. Remaining work by the Town's contractor includes installing colorized stamped asphalt crosswalk surfaces; installing welcome signs; and various punch list items. Traffic will be maintained on these roads throughout construction. During active construction in the roadway, there will be lane closures with police details to direct traffic. Traffic delays may occur during lane closures. When required, detours will be posted and communicated with local businesses and residents. As always, please slow down and use extreme caution when traveling through the road construction areas, and follow posted safety and detour signs.

### **\*CONTINUES\* Pipe Installation, Hinckley Road from Falmouth Road to Route 132**

National Grid has started installation of a new gas main in Hinckley Road in Hyannis. The project includes installation of new 10" gas main from Falmouth Road to a regulator pit within Hinckley Road and a 12" gas main from the regulator pit to a tie-in in Route 132. Weather pending; construction will be on-going, Monday through Friday from 7:00 AM to 5:00 PM until completion of this phase of the project. Work within Hinckley Road is anticipated to be completed on Tuesday, March 3, 2020, with work resuming in early to mid-April. Work on Route 132 will be night work, with work starting Wednesday, March 4, 2020. Weather pending; work within Route 132 will be Sunday through Thursday nights, from 9:00 PM to 5:00 AM. Work is anticipated to take two (2) weeks.

### **\*CONTINUES\* National Grid Service Road**

National Grid Service Road Construction began on November 12, 2019; National Grid will be installing a new gas main on Service Road in Sandwich and Barnstable. Work in Barnstable will be starting the week of February 24th. Work will be performed during the day, Monday through Friday from 6:00 AM to 6:00 PM. Service Road will remain open with one-lane of traffic. The project is scheduled to be completed in November, 2020.

### **\*UPDATED\* MassDOT Schedules Intersection Improvements at Falmouth Road (Route 28) at Osterville West Barnstable Road**

Construction operations began on September 5, 2019, and will continue through to April 2021 MassDOT has commenced work on the intersection at Falmouth Road (Route 28) at Osterville West Barnstable Road. The road has been redesigned to include exclusive left turn lanes and improve bicycle and pedestrian accommodation as part of the proposed safety improvement work. The work to be done consists of furnishing and installing of new traffic signal equipment at the intersection including emergency vehicle pre-emption system, bicycle and vehicles loop detectors, construction of ADA compliant wheelchair ramps, sidewalks, and driveways, box widening, pavement milling and resurfacing, new pavement markings and signs, drainage improvements, water distribution modifications, existing utility pole relocations, installation of granite curbing, loam and seeding.

Night work will be starting Sunday, February 23rd and will continue for 3 weeks. Hours of Operation (Day/Night): Sunday through Thursday 9:00 PM-5:00 AM. Traffic control will include all required signage, channeling devices for lane shifts and alternating one-way traffic as required. Police details/flaggers will be used as needed.

## Notice from the Town Assessor

From now until October, representatives of Vision Government Solutions, who have been contracted to conduct the Fiscal Year 2021 Town Wide Reappraisal Project, may request access to your property. The first phase of the project is: 1) the inspection of all real property that have not been inspected within the last ten years (the Bureau of Local Assessment of the Department of Revenue requires all communities to perform periodic inspections of all real property every TEN years); and 2) a full field review of residential sales during calendar 2019 to be utilized in the FY2021 assessments (the Bureau of Local Assessment of the Department of Revenue requires all communities to perform a full reappraisal of all property every FIVE years). Channel 18 has shared a [brief video](#) with Town Director of Assessing Edward F. O'Neil, MAA, explaining why this project is so important.

The scope of this part of the project is to verify the property characteristics of sold properties in calendar year 2019. Accurate property data is a critical element in the development of uniform and equitable market values.

O'Neil, MAA, and are registered with the Barnstable Police Department. The Board of Assessors and Vision Government Solutions appreciate your cooperation in providing the representative with access to your property or any information necessary to undertake this assignment.
