## Town of Barnstable Presented with the Presidential Citation from the Republic of Korea

On October 19<sup>th</sup>, a ceremony was held at the Korean War Memorial, located at Veteran's Park Beach, to recognize the Town of Barnstable for its longstanding support of Cape Cod's Korean War Veterans. Commander Roy Thomas of the Cape Cod Chapter of the Korean War Veterans Association (KWVA) stated that the KWVA nominated the Town of Barnstable for the award "because of the critical support of Korean War Veterans on Cape Cod rendered by the Town in giving choice waterfront real estate for the location of the Korean War Memorial and for doubling the value of a fund in its custody for the perpetual upkeep of the monument." Presenting the Presidential Citation on behalf of the President of the Republic of Korea, Consul General Yonghyon Kim conveyed his warmest greetings to the people of Barnstable and noted that this year marks the 70<sup>th</sup> anniversary since the outbreak of the Korean War. He shared that "the Presidential Citation was being awarded to the Town of Barnstable to recognize its outstanding endeavors to honor Korean War Veterans by providing a space for the memorial, for their excellent association with the KWVA, and for the immaculate management of the memorial. By doing so the Town has greatly contributed to the public education of the Korean War, the importance of freedom and peace, and to remembering the war heroes." In accepting the Presidential Citation from Consul General Kim, Town Council President Paul Hebert shared that it was a tremendous honor for the Town to receive such a prestigious award and expressed his hope "that deep in our hearts someday there will be absolute peace between the two countries of Korea." ## Massachusetts Pauses All Indoor Ice Rink and Ice Skating Facilities Operations for Two Weeks through November 7<sup>th</sup>

Massachusetts to temporarily pause all indoor ice rink and ice skating facilities operations for two weeks Effective October 23 through November 7, 2020, this pause will allow for the development of enhanced COVID-19 protocols to further protect players, families, and coaches. There have been at least 30 clusters of COVID-19 associated with organized ice hockey activities involving residents from more than 60 municipalities in Massachusetts. Each of these includes two or more confirmed or probable COVID-19 cases, totaling 108 confirmed cases. This pause will allow for the development of stronger COVID-19 protocols to further protect players, families, coaches, arena staff and other participants, as well as communities surrounding hockey rinks. ## Hyannis Main Street Barriers to be Removed November 17<sup>th</sup>

### Last Day of Outdoor Business in the extended areas is November 15<sup>th</sup>

In response to the cooler temperatures and other off-season transitions, the Town of Barnstable is removing the concrete barriers installed on Hyannis Main Street. The barriers were placed to create additional space for pedestrians and outdoor business use and to promote public health and safety in response to the COVID-19 health crisis. The last day of outdoor business use will be Sunday, November 15<sup>th</sup>. Businesses will have all day on the 16<sup>th</sup> and until 5pm on the 17<sup>th</sup> to remove any items or installations that have been placed between the barriers and the sidewalk. Barriers will be removed starting on the night of Tuesday, November 17<sup>th</sup> and work will continue at night until all barriers are removed. Restaurants that had outdoor dining areas prior to the COVID-19 State of Emergency may revert to using the previously permitted footprints; social distancing requirements established by the Commonwealth of Massachusetts continue to apply. All temporary licenses issued in 2020 to businesses to use Town property will expire on Sunday, November 15<sup>th</sup>. The Town of Barnstable was proud to support business on Hyannis Main Street this summer and received overwhelmingly positive feedback from merchants and visitors in response to the modifications made to the street. The Town will evaluate the reinstallation of the barriers in the spring, and welcomes feedback from residents and merchants. The decision to remove the barriers in November was driven by feedback from businesses that the use of outdoor dining areas is limited by the cold temperatures and the desire to have ample, convenient parking for shoppers during the holiday season. The Town also needs the ability to promptly and safely respond should we get a snow event that requires plowing. We would like to recognize the tremendous efforts from so many Town of Barnstable employees who worked to make this project a success including Departments and Divisions of Public Works, Licensing, Health, Asset Management, Legal, Planning & Development, and the Barnstable Police Department and Hyannis Fire Department. We also thank the Hyannis Main Street Business Improvement District for their contribution to the effort. The Town of Barnstable encourages everyone to stay the course and keep physical distance, wear a mask/face covering whenever in public, wash hands and frequently touched surfaces, avoid crowds, and choose outdoor activities over indoor ones when possible.

## Town of Barnstable Community Development Block Grant Program (CDBG) Notice of Document Availability, Public Meeting and Comment Period

## Tips for a Safe and Healthy Halloween During COVID-19

Residents and communities should follow safe and healthy tips to participate in Halloween activities that may limit the risk of exposure to COVID-19. As a reminder, any Halloween activities are subject to the current state **gathering size limits** as well as applicable **sector-specific workplace safety standards**. Consistent with the **Halloween activity guidance released by the Centers for Disease Control and Prevention**, some things to keep in mind in celebrating Halloween this year include:

- Enjoy Halloween **outside** rather than attending indoor events.
- Place candy on a platter instead of a bowl
- Instead of traditional trick or treating, opt for one-way trick-or-treating, with treats placed outside of the home for trick-or-treaters as a "grab and go" while keeping distance from others.
- Consider leaving hand sanitizer by any treats left out for trick-or-treaters to use.
- Wear a face mask or face covering. For more information on face masks and face coverings, please see the state's Mask Up MA webpage.

- A costume mask is not a substitute for a face mask or face covering. To protect yourself and others, ensure you are wearing a protective face mask or covering instead of or in addition to a costume mask.
- Observe good hand hygiene, including hand washing and use of alcohol-based sanitizers with at least 60% alcohol. Carry hand sanitizer and use it often, especially after coming into contact with frequently touched surfaces and before eating candy.
- Refrain from touching your face.
- Decorate your yard for others to enjoy from their car or while on a socially-distanced walk.
- Hold virtual costume contests or pumpkin carving events.
- Celebrate with members of your household with a Halloween-themed meal, Halloween movie night, or by preparing a Halloween scavenger hunt.
- Maintain social distancing of at least 6 feet of physical distance from all other participants who are not members of the same household.
- Avoid:
  - Attending crowded costume parties held indoors, or any gatherings that exceed indoor or outdoor gathering limits;
  - Going to an indoor haunted house where people may be crowded together and screaming; and
  - Going on hayrides or tractor rides with people who are not in your household.
  - Indoor haunted houses; and
  - Hayrides or tractor rides with people who are not in your household.
  - Stay home and refrain from Halloween activities, including handing out Halloween treats, if:
    - you feel unwell;
    - you have tested positive for COVID-19;
    - you have been exposed to someone with COVID-19; or
    - you have traveled to or from a state that is not classified as lower risk within the last 14 days. For more information on lower risk states, please see the state's COVID-19 <u>Travel Order</u> webpage.



The Town of Barnstable, together with MassDevelopment and the Downtown Hyannis Community Development Corporation, is happy to announce the availability of a **second round of grants of up to \$8,000 each** for storefront businesses and cultural non-profits in Hyannis' East End. This grant round will provide a limited number of grants of up to \$8,000 each to assist storefront businesses and cultural non-profits located in Hyannis' East End TDI District and within 300 feet thereof, as shown in the map below. These grants will provide flexible funding in an effort to support small businesses and cultural institutions in the downtown that continue to be impacted by COVID-19 public health requirements and restrictions. 

## **Barnstable Remains at Level 2 Drought Status**





#### **DROUGHT STATUS**

Currently, the Massachusetts Executive Office of Energy and Environmental Affairs has declared a **Level 3 – Critical Drought** in the Southeast Region of the Commonwealth and in the Millers and Charles River watersheds. The other six regions across the state — the Western, Connecticut River Valley, Central, Northeast, Cape Cod, and Islands regions — remain at a **Level 2 – Significant Drought**.

#### **CURRENT CONDITIONS**

Due to over five months of below normal rainfall and above normal temperatures, streamflow has deteriorated in many locations with some record low flows, and groundwater is starting to see below normal conditions in many regions.

Extended drought conditions have rendered grasses, shrubs and forest fuels very dry across most of the state, leading to high risk of wildland and brush fires.

vaccine for Seniors. This year, we offer the quadrivalent flu vaccine. The quadrivalent influenza (flu) vaccine is designed to protect against four different flu viruses, including two influenza A viruses and two influenza B viruses. For many years, flu vaccines were designed to protect against three different flu viruses (trivalent vaccines). Trivalent vaccines protect against an influenza A(H1N1) virus, an influenza A(H3N2) virus and one influenza B virus, even though there are two different lineages of B viruses that both circulate during most seasons. Adding another B virus to the vaccine aims to give broader protection against circulating flu viruses. ## **ROAD WORK UPDATES**

## As always please slow down and use extreme caution when traveling through the road construction areas and follow posted safety and detour signs.

### \*NEW\* National Grid New Customer Hookups

Tuesday, October 27, 2020 through Friday, October 30, 2020 Neuco crews will install gas service on Cammett Way, Marstons Mills. Typical natural gas service installation includes marking out underground utilities within the project area, excavation of the street, laying gas main, relaying customer's individual gas service and connecting those services to the main and installing meters. This project should take about five days to complete. Visit ngrid.com/service line to view a YouTube video explaining the replacement of the service pipe to customer homes. Operations will start promptly at 7:00 AM and run until 3:00 PM. Reduce speed, and use caution. All scheduled work is dependent on weather and/or may be impacted due to an emergency situation.

\*CONTINUES\* Drainage & Pavement Improvements on Huckins Neck Road in

**Centerville/Barnstable Village** Pavement improvements on Huckins Neck Road in Centerville and Barnstable Village will continue through November 20, 2020. The work includes installation of new drainage systems, repairs to existing drainage systems, milling of the existing pavement, and adjustment of drainage structure castings, overlay with new pavement and restoration of any areas disturbed during construction. Normal work hours will be between 7:00 AM to 5:00 PM, Monday through Friday. Through traffic will be maintained throughout construction. Any lane closures will be supported with police details to direct traffic. Motorists are advised to seek alternate routes to avoid the construction work.

**\*CONTINUES\* National Grid Service Road** National Grid will be installing a new gas main on Service Road in Barnstable. Work will be performed during the day, Monday through Friday from 6:00 AM to 6:00 PM. Service Road will remain open with one-lane of traffic. Police details/ flaggers will be used as needed. Gas Line installation is anticipated to be complete in October, with testing being completed through November 2020. Final re-paving of Service Road is anticipated to be completed in spring 2021.

**\*CONTINUES\*** Bumps River Bridge Repairs on South Main Street in Centerville/Main Street in Osterville Construction is scheduled to start in October 2020 and to end in May 2021. Normal work hours are 7:00 AM to 3:30 PM, Monday through Friday, except work under the bridge may also occur during nights and weekends. Work will include repairing bridge piles and cross bracing, as well as repairing and re-surfacing the bridge deck. During active construction there may be lane closures with signs, cones/construction barrels, and police details or flaggers if necessary to direct traffic past the work zone.

**\*CONTINUES\*** Sewer Installation on Portions of Kidd's Hill Road, Merchants Way, and Business Lane in Barnstable Village Construction is expected to end in October 2020. Normal work hours are 7:00 AM to 3:30 PM, Monday through Friday. Remaining work includes applying centerline and edge lines on Kidd's Hill Road where recently resurfaced, from Wilkens Lane to a

point about 400 feet north of Merchants Way. During active construction there may be lane closures with signs, cones/construction barrels, and police details or flaggers if necessary to direct traffic past the work zones.

## \*CONTINUES\* Sidewalk, Traffic Signal, Water Distribution, and Associated Improvements on Independence Drive in Hyannis and Barnstable Village, and on Portions of Mary Dunn Road, Kidd's Hill Road, and Attucks Lane in Barnstable

**Village** Construction is scheduled to end in May 2021. Normal work hours are 7:00 AM to 3:30 PM, Monday through Friday. Work will include a new sidewalk and additional drainage systems the full length of Independence Drive, on Mary Dunn Road a short distance south of Independence Drive, on Kidd's Hill Road from Independence Drive to Merchants Way, and on Attucks Lane from Independence Drive to Wilkens Lane. The work will also include a new traffic signal system at the intersection of Attucks Lane & Wilkens Lane; a watermain extension on portions of Attucks Lane and Independence Drive; and additional street lights on portions of Independence Drive and Kidd's Hill Road. During active construction there will be lane closures with signs, cones/construction barrels, and police details or flaggers if necessary to direct traffic past the work zones.

\*CONTINUES\* Roadway Improvements on Portions of Main Street (Route 6A) and Mill Way in Barnstable Village Construction is scheduled to continue through the fall. Normal work hours are 7:00 AM to 3:30 PM, Monday through Friday. Remaining work includes utility line transfers and pole removals in a few locations (by utility companies); constructing a sidewalk from Main Street to the County Complex parking lot east end; installing street lights; refurbishing traffic signals; and other associated work. During active construction there will be lane closures or temporary detours with signs and police details or flaggers to direct traffic past or around the work zones.

**\*CONTINUES\* Survey and Map five of the Phase 1 Sewer Expansion Projects** As the first step in a multi-year planning and design effort, the Barnstable Department of Public Works has contracted with multiple land surveying firms to survey and map five of the Phase 1 Sewer Expansion Projects identified in the Town's Comprehensive Wastewater Management Plan. The projects include the mapping of dozens of roadways, including many residential areas for the following Phase 1 projects:

- Phinney's Lane Sewer Expansion Project which includes Phinney's Lane from Route 132 to Route 28 including residential roads to the east and west of Phinney's Lane
- Long Pond Area Sewer Expansion Project which includes all roadways between Old Stage Road /Park Avenue (western limits) and Strawberry Hill Road (eastern limits) and including the residential areas on the north and south side of Pine Street
- Route 28 East Sewer Expansion Project which includes Route 28 from the Water Pollution Control Facility property to Phinney's Lane
- Route 28 Centerville Sewer Expansion Project which includes Route 28 from Phinney's Lane to East Osterville Road and includes East Osterville Road and Old East Osterville Road
- Route 28 Marstons Mills Sewer Expansion Project which includes Route 28 from East Osterville Road to Old Post Road

Citizens can expect survey field crews to be working within the project areas at various times throughout the summer and fall. In the coming weeks, property owners within the project areas will be receiving notifications from the survey consultants which provide further detail on the survey project.
