Town Council Meeting – September 5, 2019

Last night's Town Council Meeting began with Barnstable Town Council President James Crocker leading the Pledge of Allegiance and Moment of Silence. Following Public Comment Elizabeth Jenkins, Planning and Development Director provided an [Overview and Recommendations from the Barnstable Economic Development Task Force](#) with Task Force Chair Alison Maloney, Matthew Eddy (Vice Chair) and Chuck Carey (member). Prior to delivering Town Manager Communications, Town Manager Mark Ells responded to Public Comment as it relates to Special Events. Mr. Ells provided updates on the following items for the period August 16-September 5, 2019 during [Town Manager Communications](#):

1. Provided a brief update on the potential impacts of Hurricane Dorian.
2. Derek Lawson, Marine & Environmental Affairs' Harbormaster Division Supervisor, provided an overview of the Hyannisport mooring field reconfiguration plan.
3. We are proceeding with the tasks in the budget action calendar for FY 2021 as scheduled. The Town Manger will issue FY 2021 Operating and Capital budget instructions next week. We anticipate a joint meeting/workshop with the school committee to review the financial

condition of the Town on November 7, 2019. For information on our fiscal year budgets please view the Town's Open Budget website at <http://budget.townofbarnstable.us>.

4. On September 1st of every year, the Town's Water Management Act water withdrawal permit requires the Town to significantly reduce water withdrawals from the Mary Dunn and Airport wells reducing the summertime maximum flow allowance to a lesser off season rate. The higher pumping rates from our filtered well fields are an essential factor to ensure compliance with the most recent PFAS advisory levels. Therefore, in coordination with the Massachusetts Department of Environmental Protection, we have requested and received authorization to continue pumping said wellfields for six months. We will continue to work with DEP to provide drinking water that meets all regulatory standards. We will keep you advised as we progress on this matter.
5. We received our signed access agreement from Fish & Wildlife for the installation of test wells on the 250 acre parcel owned by the Commonwealth that directly abuts the Hyannis public water supply. The Town plans to conduct tests in late September/early October 2019 on this and other parcels to determine if new public water supply wells are feasible on the various sites. The Town shall continue to work with Mass Fish & Wildlife, Barnstable County, and Water districts as we evaluate sites future potential public water supply well sites. We will keep you advised of our progress on this important effort.
6. The Town of Barnstable is hosting a training session for the Census 2020 Complete Count Committee for Cape Cod on Wednesday, September 11th from 11:00 AM to 12:30 PM. Barnstable County Administrator Jack Yunits and Mr. Ells are co-chairs of this Committee. The training will help oversee the efforts to ensure everyone on Cape Cod is counted in 2020. A complete count is essential to the region's long-term planning. Federal funding and regional competitiveness for health care, housing, transportation, infrastructure, and service programs rely on this data to help define and fund our community needs. The training will provide an overview of the Census process, methods for communicating and sharing information, and ways to promote participation. Town Clerk Ann Quirk and Community Services Director Lynne Poyant will be taking part in the training.
7. Mass Department of Transportation has intersection improvements scheduled to commence September 5, 2019 and will continue through April 2021. The work is scheduled to occur weekdays from 7:00 AM to 3:30 PM. It is our understanding that major in road construction activities will occur during the evening hours of 7:00 PM to 3:00 AM. The planned work includes redesign of exclusive left hand turn lanes, improved bicycle and pedestrian accommodations, installation of new traffic signals, improved drainage, mill and resurface roadway, install curbing, new pavement markings and signs, construction of sidewalks, and ADA compliant ramps.

Old Business began with President Crocker taking Agenda Item [2020-017](#) Appropriation Order in the amount of **\$203,117** for the Fiscal Year 2020 Barnstable Public Schools Operating Budget out of order. Superintendent Meg Mayo-Brown presented the item which was approved. Harbormaster Division Supervisor Derek Lawson presented Agenda Item [2020-012](#) Appropriation and Transfer Order in the amount of **\$30,000** for the Outboard Engine Replacement on the Harbormaster's South Side Patrol Boat which was approved. Community Preservation Committee Chair Lindsey Counsell was joined by Town Clerk Ann Quirk and Property and Risk Management Director David Anthony is presenting Agenda Item [2020-013](#) Appropriation Order in the amount of **\$136,055** Community Preservation Funds for historic preservation and restoration of Annual Town Report Volumes Years 1868 to 1994 which was approved. Mr. Counsell returned with Town Architect Mark Marinaccio to present Agenda Item [2020-015](#) Appropriation Order of **\$242,822.00** for the rehabilitation and restoration work to the Paine Black House, 2135 Meetinghouse Way, West Barnstable, MA which was approved. **NEW BUSINESS** began with Agenda Item [2020-018](#) Appropriation and Transfer Order in the amount of **\$330,400** for the Fiscal Year 2021 Real Property Revaluation being referred to a Public Hearing September 19, 2019. The

following three Agenda Items were referred to the Planning Board: [2020-019](#) Amending the Code of the Town of Barnstable, part I General Ordinances, Chapter 240 Zoning, Article II Section 9 to remove seasonal restrictions on the erection of tents as temporary accessory structures to existing permanent businesses; [2020-020](#) Amending the Code of the Town of Barnstable, Part I General Ordinances, Chapter 240 Zoning, Article VII Sign Regulations to eliminate the location hardship requirement for a-frame signs in Hyannis Village Business District; and [2020-021](#) Amending the Code of the Town of Barnstable, Part I General Ordinances, Chapter 240 Zoning, to update and standardize requirements for exterior lighting. Agenda Item [2020-022](#) Acceptance of sewer easement for 100 Merchants Way, Hyannis, MA was referred to a Second Reading on September 19, 2019. DPW Director Dan Santos presented Agenda Item [2020-023](#) Acceptance of a grant in the amount of **\$155,538** from the Coastal Pollutant Remediation Grant Program to design and construct Stormwater Best Management Practice's (BMPs) for the Three Bays Area which was approved. The following Agenda Items were referred to Public Hearings on September 19, 2019: [2020-024](#) Supplemental Appropriation Order in the amount of **\$15,000** for the Fiscal Year 2020 Planning and Development Department Operating Budget; [2020-025](#) Appropriation and Loan Order in the amount of **\$549,000.00** for the purpose of acquiring real property consisting of approximately .32 acres of land (32/100), more or less, in Barnstable shown on Assessors Map 208 as Parcel 048 to be associated with the construction of a new sewer infrastructure; and [2020-026](#) Appropriation and Loan Order in the amount of **\$283,900.00** for the purpose of acquiring real property consisting of approximately .65 acres of land (65/100), more or less, in Barnstable shown on Assessors Map 209 as Parcel 019 to be associated with the construction of new sewer infrastructure. Agenda Item [2020-027](#) Authorizing the Town Manager, in coordination with the Town Council President, draft for approval of the Town Council Special Legislation to authorize the Town of Barnstable to own, manage, or contract with any public or private entity, or both, for the management of water and/or wastewater facilities which was approved. The Town Council then went into Executive Session under M.G.L. c.30A, section 21(6) to discuss the purchase, exchange, lease, or value or the possible taking by eminent domain, of certain roadways in the Village of Hyannis, MA if the Chair declares that an open meeting may have a detrimental effect on the negotiating position of the Town and not to reconvene in open session. The next Town Council meeting will be held on Thursday, September 19, 2019 at 7:00 PM in the Town Hall Hearing Room, 367 Main Street, Hyannis.

Learn more about EEE in Massachusetts and how to protect yourself and your family

Eastern equine encephalitis (EEE or "Triple E") is a rare but serious disease caused by a virus that is spread through the bite of an infected mosquito. EEE has been found in mosquitos on Cape Cod and Southeastern Massachusetts this summer. **As of today, the Town of Barnstable remains in the "low risk" area for Triple E and West Nile Virus (WNV) as shown on the map; see link here:** <http://www.mosquitoresults.com/>. Be sure to take precautions and protect yourself against mosquito bites. Apply EPA-approved bug spray when you are outdoors, avoid peak mosquito hours (dusk to dawn), wear long-sleeves, socks and long pants to reduce skin exposure when you are outside around peak times, and mosquito proof your home by draining any standing water and repairing screens. Another option is cancelling outdoor activities in the hours from dusk to dawn when mosquitoes are most active. Governor Baker Declares September Emergency Preparedness Month

Residents Encouraged to Prepare During Emergency Preparedness Month

Governor Charlie Baker has proclaimed September 2019 as Emergency Preparedness Month to encourage individuals and families to prepare for emergencies and disasters. The Massachusetts Emergency Management Agency (MEMA), the Department of Public Health (DPH), and the American Red Cross in Massachusetts, together with their partners will promote emergency preparedness throughout the month through various outreach initiatives. These efforts are part of a month-long nationwide preparedness campaign to encourage residents to take simple steps to better prepare themselves, their homes, their businesses, and their communities. “As Massachusetts and the rest of the nation continue to confront natural disasters that cause major disruptions for our communities, we encourage residents to spend time this September preparing for a potential emergency or disaster,” **said Governor Charlie Baker**. “Increased preparedness will improve public health and safety, and can help minimize property damage and the economic impact of when disaster strikes.” “Through the Massachusetts Emergency Management Agency, the Department of Public Health and other state agencies, our administration remains committed to working with cities and towns across the Commonwealth and other government partners to strengthen our preparedness for the next disaster,” **said Lt. Governor Karyn Polito**. “We encourage the Commonwealth’s residents, communities and businesses to take steps to prepare before the next emergency.” “The best defense for an emergency is being properly prepared,” **said Health and Human Services Secretary Marylou Sudders**. “As we recognize Emergency Preparedness Month, we encourage individuals now and every day to take proactive steps to safeguard their future health should a disaster occur.” “When it comes to preparedness, there is no time like the present,” **said Public Health Commissioner Monica Bharel, MD, MPH**. “This September, take a few moments to think about the specific needs your family may have in the event of an emergency such as a blackout or severe weather, and how you can prepare now to ensure those needs are met.” “Preparedness Month is an important reminder that we should all take time now to be ready in case an emergency occurs,” **said Holly Grant, CEO of the American Red Cross in Massachusetts**. “Talking with our families and households about what to do in case something happens gives everyone peace of mind. Small steps taken now, like making a home escape plan, can make a huge difference when a disaster strikes.” “There are a variety of hazards and threats that can cause damage and impact residents in Massachusetts,” **said Public Safety and Security Secretary Thomas Turco**. “Residents can improve their personal safety and build community resilience by knowing their risks, preparing for them in advance, and knowing what to do in an emergency.” “Emergency Preparedness Month is an opportunity to prepare for the emergencies that may occur in communities across the Commonwealth,” **said MEMA Director Samantha Phillips**. “Recent tornadoes in July have shown the importance of receiving timely emergency alerts and taking protective actions during dangerous severe weather. September is a time to refocus our attention on ensuring we have a prepared and resilient Commonwealth.” During September, MEMA, DPH and the Red Cross will share information on their

respective social media accounts about emergency preparedness topics including financial preparedness, emergency planning, youth preparedness, planning for those with access and functional needs, ways to get involved in community preparedness, and more. These agencies and organizations will host a joint Facebook Live preparedness event on September 9th.

MEMA will also support various emergency preparedness events across the state and the Massachusetts Department of Transportation will feature signage along highways to raise awareness. ROAD WORK UPDATES

As always please slow down and use extreme caution when traveling through the road construction areas and follow posted safety and detour signs.

***NEW* National Grid will be installing new gas service along Iyannough Road Hyannis**

Sunday, September 8 through Thursday, September 12, National Grid will install gas service from 1 to 131 Iyannough Road, Hyannis. Typical natural gas service installation includes marking out underground utilities within the project area, excavation of the street, laying gas main, relaying customer's individual gas service and connecting those services to the main and installing meters. The project should take about three weeks to complete. Visit ngrid.com/service_line to view a YouTube video explaining the replacement of the service pipe to customer homes. **Operations will start promptly at 9:00 PM and run until 5:00 AM Sunday through Thursday. Reduce speed, and use caution. All scheduled work is dependent on weather and/or may be impacted due to an emergency situation.**

***CONTINUES* MassDOT Schedules Intersection Improvements at Falmouth Road (Route 28) at Osterville West Barnstable Road**

Construction operations will begin on September 5, 2019, and will continue through to April 2021

MassDOT has commenced work on the intersection at Falmouth Road (Route 28) at Osterville West Barnstable Road. The road has been redesigned to include exclusive left turn lanes and improve bicycle and pedestrian accommodation as part of the proposed safety improvement work. The work to be done consists of furnishing and installing of new traffic signal equipment at the intersection including emergency vehicle pre-emption system, bicycle and vehicles loop detectors, construction of ADA compliant wheelchair ramps, sidewalks, and driveways, box widening, pavement milling and resurfacing,



new pavement markings and signs, drainage improvements, water distribution modifications, existing utility pole relocations, installation of granite curbing, loam and seeding.

Hours of Operation (Day/Night): Monday through Friday 7:00 AM-3:30 PM. The initial work shall be done in four phases to allow access to local businesses for both vehicles and pedestrians. Traffic control will include all required signage, channeling devices for lane shifts and alternating one-way traffic as required. Police details/ flaggers will be used as needed.

***CONTINUES* Old Kings Road /Sampson's Mill Road**

The Towns of Mashpee and Barnstable are replacing a culvert at the Santuit River on Sampson's Mill Road (Mashpee)/Old Kings Road (Barnstable). Sampson's Mill Road/Old Kings Road will be closed to traffic in both directions for the duration of the project. **The road closure will be between Willowbend Drive in Mashpee and at Abbey Gate Road in Barnstable.** Eastbound traffic will be detoured in Mashpee onto Cape Drive to Route 28. Westbound traffic in Barnstable will be alerted via message boards to utilize Route 28 via Main Street. Work will continue through November 2019.

***CONTINUES* River Road, Marstons Mills, Cotuit Library, Putnam Avenue, Cotuit (Coastal Pollutant Remediation Grant Project)**

Work continues at sites for future green storm water control infrastructure placement. Field work can include but is not limited to site visits, survey, soil borings, pulling manhole covers and wetland delineation. This work will continue through 2019. ***PLEASE NOTE: Drivers who are traveling through the affected areas should expect delays, reduce speed, and use caution.***

***CONTINUES* Ropes Beach, Old Shore Road, Cotuit (Stormwater Project)**

The project is closing up for the summer with the contractor demobilized and site cleared. **The project will remobilize after Labor Day 2019. As always, please slow down and use extreme caution when traveling through the road construction areas, and follow posted safety and detour signs.**

***CONTINUES* Gleneagle Drive, Centerville**

Pavement and drainage improvements continue on Gleneagle Drive in Centerville. The work includes expansion of existing drainage systems, installation of a new drainage system, reclamation of the existing paved road surface and sidewalk, repaving the sidewalk and roadway with new hot mix asphalt and general restoration. The project is expected to be completed by September 27, 2019, weather permitting. ***As always please slow down and use extreme caution when traveling through the road construction areas and follow posted safety and detour signs.***

***UPDATED* Main Street (Route 6A) and Mill Way in Barnstable Village**

Construction started on September 3, 2019 and will continue through May 2020. Normal work hours will be 7:00 AM to 3:30 PM, Monday through Friday. The project area is Main Street (Route 6A) from Rendezvous Lane to Mill Way, and Mill Way from Main Street to Barnstable Harbor Marina. The project objectives are to improve pedestrian access and overall traffic safety, rehabilitate aging infrastructure, and enhance the streetscape. The project scope includes new/improved sidewalks, landscaping, and decorative street lighting in the village center, drainage, pavement, crosswalks, median islands, and traffic signals. ***Traffic will be maintained on these roads throughout construction. During active construction in the roadway, there will be lane closures with police details to direct traffic. Traffic***

delays may occur during lane closures. When required, detours will be posted and communicated with local businesses and residents. As always, please slow down and use extreme caution when traveling through the road construction areas, and follow posted safety and detour signs.

***UPDATED* Route 149, Main Street, and River Road in Marstons Mills**

Construction resumed on September 3, 2019 and is scheduled to continue through December 2019. Normal work hours will be from 7:00 AM to 3:30 PM, Monday through Friday. The project area is Route 149 from Mill Pond to Lovell's Lane, Main Street from Route 149 to the former elementary school, and River Road from Route 149 to the post office drive. Work this fall will include constructing additional stormwater management systems; replacing temporary sidewalks with permanent sidewalks; planting trees and installing other landscaping; constructing textured and raised crosswalks; placing the top layer of asphalt on roads and driveway aprons; and installing pavement markings and traffic signs. ***Traffic will be maintained on these roads throughout construction. During active construction in the roadway, there will be lane closures with police details to direct traffic. Traffic delays may occur during lane closures. When required, detours will be posted and communicated with local businesses and residents. As always, please slow down and use extreme caution when traveling through the road construction areas, and follow posted safety and detour signs.***

***UPDATED* Sea Street, South Street, and Ocean Avenue in Hyannis**

Construction resumed on September 3, 2019 and is scheduled to continue through December 2019. Normal work hours will be 7:00 AM to 3:30 PM, Monday through Saturday. The project area is Sea Street from Main Street to Ocean Avenue, Ocean Avenue from Sea Street to Keyes Memorial Beach, and the intersection of Sea Street & South Street. Work this fall will include sidewalk reconstruction and wheelchair ramps; installation of decorative street lights and planting street trees; new traffic signal equipment at Sea Street & South Street; placing the top layer of asphalt on the roads, sidewalks, and driveway aprons; and installing pavement markings and traffic signs, including crosswalks. ***Traffic will be maintained on these roads throughout construction. During active construction in the roadway, there will be lane closures with police details to direct traffic. Traffic delays may occur during lane closures. When required, detours will be posted and communicated with local businesses and residents. As always, please slow down and use extreme caution when traveling through the road construction areas, and follow posted safety and detour signs.***
