# Public Hearing

**TRANSFER INN HOLDER ALL ALCOHOL COMMON VICTUALLER INCLUDING TRANSFER OF DAILY LIVE AND DAILY NON LIVE ENTERTAINMENT LICENSES; ALSO CHANGE OF LICENSE TYPE AND ALTERATION OF PREMISES**

In accordance with MGL c.138 and c.140, an application has been filed by 473 Partners Restaurant LLC *dba Hyannis Inn*, 473 Main Street, Hyannis for the following transactions:

- (1) **Transfer** the Inn Holder All Alcohol Common Victualler license including transfer of the Daily Live and Daily Non-Live Entertainment licenses from Dilara Hospitality Inc dba Hyannis Inn to **473 Partners Restaurant LLC dba Hyannis Inn**; proposed manager is Alexander Tamargo. Proposed hours of alcohol service are Monday through Saturday 8AM to 12:45AM and Sundays, 10AM to 12AM. Outdoor seating will be limited to 11PM nightly.
- (2) **Change of license type** from §12 Hotel to §12 Restaurant
- (3) **Alteration of Licensed premise** per the following descriptions

***On-Season Premises (June 1<sup>st</sup> to September 30<sup>th</sup>):** Alcoholic beverages and food will be provided in the restaurant/dining room consisting of 715 sqft, 29 seats, 2 handicapped bathrooms, two entrances/exits and a 400sqft outdoor patio with 20 seats and a separate restaurant/dining room with a bar consisting of 567 sqft, 26 seats including 12 bar seats, storage room, 2 handicapped bathrooms, two entrances/exits with a 484sqft outdoor patio with 22 seats; for a total of 67 indoor and 42 outdoor seats.*

***Off-Season Premises (October 1<sup>st</sup> to May 31<sup>st</sup>):** Alcoholic beverages and food will be provided in a restaurant/dining room consisting of 715sqft, 49 seats, 2 handicapped bathrooms, two entrances/exits, and in a separate restaurant/dining room with a bar, 48 seats including 12 bar seats, storage room, 2 handicapped bathrooms, two entrances/exits*

Said hearing will be held on **Monday, March 20, 2023** at **9:30 a.m.** or as soon following as practical in the Barnstable Town Hall building, James H. Crocker Jr. Hearing Room, 2<sup>nd</sup> Floor, 367 Main Street, Hyannis.
